AND WHEREAS estimates of revenues and expenditure of Guyana for the financial year 1993 have been prepared and laid before the Assembly on 1993-03-12;

RESOLVED, That this National Assembly approves the estimates of expenditure for the financial year 1993, of a total sum of twenty one billion, three hundred and sixty four million, two hundred and sixty nine thousand dollars (21,364,269,000), excluding twelve billion four hundred and forty five million, two hundred and forty two thousand dollars (12,445,242,000) which is chargeable by law, as detailed therein and summarised in the undermentioned schedule, and agree that it is expedient to amend the law and to make further provision in respect to finance.



AND WHEREAS a Medical Termination of Pregnancy Bill 1993 was presented to the National Assembly on 3rd December, 1993;

AND WHEREAS there have continued to be calls for further consultation and specifically for multi-party consultation;

AND WHEREAS Standing Order No. 49(1) of the Standing Orders of the National Assembly requires that before any Bill be referred to a Committee, it has to be considered and read a second time;


AND WHEREAS in response to the calls for further consultation, it is proposed to have the Bill considered by a Special Select Committee of the National Assembly before its second reading;

RESOLVED,

- (i) that Standing Order No. 49(1) be suspended in order to facilitate the placing of the Medical Termination of Pregnancy Bill 1993 before a Special Select Committee without recourse to a substantive debate at this time;
- (ii) that in the exercise of its functions the Select Committee be empowered to invite and receive memoranda from members of the public or from organizations; and to co-opt into its service any persons who are deemed to have special skills relevant to the conduct of its business;
- (iii) that the Select Committee, having examined the Bill and considered the submissions received, propose such recommendations and/or amendments to the Bill as it sees fit;

AND FURTHER RESOLVED that after the submission of the report of the Special Select Committee, the National Assembly should proceed with the second reading and the remaining stages of the Bill in accordance with the Standing Orders.

WHEREAS the Conference of Heads of Government of the Caribbean Community, at a Special Meeting in October, 1992, in Port-of-Spain, Trinidad and Tobago, agreed to the development of a Caribbean Community Charter of Civil Society which would provide a nominative basis for the Community and would deal, inter alia, with matters such as a free press, a fair and open democratic process, the effective functioning of the parliamentary system, morality in public affairs, respect for fundamental civil, political, economic, social and cultural rights, the rights of women and children, respect for religious diversity, and greater accountability and transparency in government;

AND WHEREAS a draft of the Charter was considered at the Fourteenth Meeting of the Conference of Heads of Government in Nassau, The Bahamas, in July, 1993, and it was agreed to adopt the Charter as prepared as a basis for the holding of consultations on it at the national level, preparatory to the preparation of a final draft of the Charter;

AND WHEREAS Cabinet considered the draft Charter of Civil Society for the Caribbean Community and noted its contents on August 4, 1993;

RESOLVED, That this National Assembly wholeheartedly welcomes the development of the Charter of Civil Society for the Caribbean Community and gives its fullest support to the process of national consultations.

WHEREAS the Conference of Heads of Government of the Caribbean Community, at a Special Meeting in October, 1992, in Port-of-Spain, Trinidad and Tobago, considered the recommendations of the West Indian Commission on the establishment of a Caribbean Community Supreme Court with original jurisdiction in matters arising under the Treaty of Chaguaramas, including the issuing of orders to facilitate the implementation of Caribbean Community decisions, and with an appellate jurisdiction from the Courts of Member States desirous of abolishing the jurisdiction of the Judicial Committee of the Privy Council in respect of appeals from the superior Courts of those States;

AND WHEREAS the Conference decided that those Member States desirous of establishing the Court with an appellate jurisdiction should indicate as early as possible and that the matter of an original jurisdiction for the Court should be the subject of an indepth study in order to facilitate the taking of a decision by Member States;

AND WHEREAS the Government of Guyana, at the Fourth Inter-Sessional Meeting of the Conference of Heads of Government, in Roseau, Dominica, in March, 1993, supported the establishment of the Court as a Court of Appeal with an appellate jurisdiction only;

AND WHEREAS the Conference noted that the Caribbean Community Supreme Court as an Appellate Court could be established in Trinidad and Tobago by the Member States which are desirous of so doing, namely, Guyana, Barbados, Jamaica and Trinidad and Tobago;

RESOLVED, That this National Assembly looks forward to the urgent establishment of a Caribbean Court of Appeal in order to provide a final Appellate Court for the determination of appeals from the courts of Guyana.



WHEREAS the Constitution (Amendment) Act 1993 (Act No. 21 of 1993), for the purpose of facilitating the holding of local government elections in 1994, altered the Constitution temporarily -

- (i) by substituting a new article 161 providing for the composition of the Elections Commission;
- (ii) by inserting a new article 161A empowering the Elections Commission to appoint the Chief Election Officer and all other officers and staff as may be necessary for the conduct of the local government elections;
- (iii) by substituting for paragraph (5) of article 226 another paragraph fixing the quorum of the Elections Commission as consisting of the Chairman and not less than two-thirds of the number of the other appointed members;

AND WHEREAS, notwithstanding section 2 of the said Constitution (Amendment) Act 1993, paragraph (7) of the inserted article 161A stipulates that the said Act shall stand repealed on the 30th June, 1994, unless its life is extended by the National Assembly;

AND WHEREAS it has been recognised that it would be impracticable for local government elections to be held on or before 30th June, 1994 because of the inordinately long time taken to renovate the building housing the Elections Commission to meet the required standard to accommodate the Commission's electronic equipment, the extension of time granted by the Elections Commission for the hearing of claims and objections, and the additional time needed to train the new operators of the said equipment;

AND WHEREAS it is therefore necessary for the life of the said Constitution (Amendment) Act 1993 to be extended for a period of six months commencing from 1st July, 1994, thus ipso facto extending the life of the Elections Commission to enable it to complete the task of preparation for, and the holding of, local government elections for which it was specifically appointed;

NOW, THEREFORE, RESOLVED, That this National Assembly in accordance with paragraph (7) of article 161A of the Constitution approve the extension of the life of the Constitution (Amendment) Act 1993 for a period of six months commencing from 1st July, 1994 to give the Elections Commission the needed time to make all necessary preparations for, and to conduct, local government elections in 1994.

WHEREAS the Commonwealth Heads of Government at their meeting in Cyprus in October 1993 considered the matter "The emergence of a New Global Humanitarian Order" and agreed to establish a high-level intergovernmental group to examine specific ways in which the Commonwealth can contribute to the work of the international community; and

WHEREAS Guyana is a member of that Commonwealth high-level intergovernmental group; and

WHEREAS Guyana introduced an item on the matter at the inter-Sessional Meeting of the Conference of Heads of Government of the Caribbean Community at St. Vincent and the Grenadines in March 1994 which agreed to work together at the regional level and in concert with the Commonwealth high-level group to advance the concept globally; and

WHEREAS the Conference of Heads at the said meeting in St. Vincent and the Grenadines supported a proposal by Dr. Carlos Saul Menem, President of the Argentine Republic, to establish an International Volunteer Corps for the Fight against Hunger; and

WHEREAS the President of the Co-operative Republic of Guyana Dr. Cheddi Jagan, has written to a number of Heads of State advancing proposals for a development strategy for the eradication of poverty, which took account of certain recommendations of the Human Development Programme, and seeking the support of Heads of State for a global response to these global problems;

RESOLVED That this National Assembly support the call for a global strategy to combat poverty and hunger as a priority in the new Global Humanitarian Order.





WHEREAS Guyana is a Party to the decisions which emanated from the 15th Meeting of the Conference of Heads of Government of the Caribbean Community held in Barbados from 4 - 7 July, 1994;

AND WHEREAS the aforementioned Conference of Heads of Government of Caricom emphasised its recognition that the resolution of the political crisis in Haiti, a Caribbean country, is one to which all the countries of this geo-political region, in cooperation with the international community in general, must make a meaningful contribution, and reiterated its readiness to do so;

AND WHEREAS the aforementioned Conference recognised the necessity of now considering the early implementation of all appropriate measures towards the resolution of the Haitian crisis, the restoration of the democratic process and the return of President Jean Bertrand Aristide to his rightful place as elected President of Haiti;

AND WHEREAS the aforementioned Conference agreed to provide assistance in concert with other members of the international community, in the development of a civilian force as a professional organisation for maintaining the peace and respect for human rights in that strife-torn country;

AND WHEREAS the United Nations Security Council has adopted Resolution 940(1994) on 31 July 1994;

AND WHEREAS the aforementioned Resolution recorded that the Security Council was gravely concerned by the significant further deterioration of the humanitarian situation in Haiti, in particular the continuing escalation by the illegal de facto regime of systematic violations of civil liberties, the desperate plight of Haitian refugees and the recent expulsion of the staff of the International Civilian Mission (MICIVIH), which was condemned in its Presidential statement of 12 July 1994;

AND WHEREAS the Security Council in the aforementioned Resolution recognised the unique character of the present situation in Haiti, and that its deteriorating, complex and extraordinary nature, required an exceptional response;

AND WHEREAS the Security Council by the aforesaid Resolution 940, acting under Chapter VII of the Charter of the United Nations, authorized Member States to form a multinational force under unified command and control and, in this framework, to use all necessary means to facilitate the departure from Haiti of the military leadership, consistent with the Governors Island Agreement, the prompt return of the legitimately elected President and the restoration of the legitimate authorities of the Government of Haiti, and to establish and maintain a secure and stable environment that will permit implementation of the Governors Island Agreement;

AND WHEREAS the aforementioned Resolution invited all States, in particular those in the region, to provide appropriate support for the actions undertaken by the United Nations and by Member States pursuant to this and other relevant Security Council resolutions;

AND WHEREAS Guyana, being a Member of the United Nations, is obligated to abide by mandatory Resolutions of the Security Council;

AND WHEREAS Guyana participated in the Meeting of Caricom policy makers and Heads of Military and Police Personnel regarding the implementation of Resolution 940;

AND WHEREAS the aforesaid Meeting agreed that those CARICOM Forces which will be participating in the MNF, would concentrate on peacekeeping and reconstruction;

AND WHEREAS the aforesaid Meeting also agreed that such forces would only be deployed once a fair degree of stability had been established;

AND WHEREAS it is the collective intention of the Caricom countries to participate in the MNF at approximately stage 3 of the first phase of implementation of Resolution 940, that is following the departure from Haiti of the military Regime and the establishment of a fairly stable environment;

AND WHEREAS under section 7 of the Defence Act, Cap. 15:01 of the Laws of Guyana, the approval of the National Assembly is required for the employment of any part of the Guyana Defence Force out of or beyond Guyana;

RESOLVED, That the National Assembly hereby approves of the employment of troops of the Guyana Defence Force outside of Guyana to participate in the implementation of United Nations Security Council Resolution No. 940 in conformity with the decision of the Caricom Heads of Government.

AND WHEREAS it was also agreed, at the Fifth Inter-sessional meeting of Heads of Government to continue to seek parity of treatment for CBI excluded products since the negotiating process for negotiating the Community's relationship with NAFTA may take some time;

AND WHEREAS the President of the United States of America has assured the Chairman of the Caribbean Community that the Government of the United States in consultation with the Congress is examining a package of measures to address the concerns of the Community on the impact of NAFTA on their economies;

AND WHEREAS the Government of Guyana has been discussing with the private and public sector agencies the implications of the North American Free Trade Agreement;


AND WHEREAS the Government of the United States of America has submitted a draft Bilateral Investment Treaty and a draft Intellectual Property Rights Agreement to the Government of Guyana for its consideration;

AND WHEREAS the Government of Guyana is committed to ensuring the involvement of every interested citizen and organisation in the national consultations on the draft Treaty and Agreement and on the implications of the North American Free Trade Agreement;
