

Mrs. Holder: I repeat: the number of phantom pensioners has now increased to 17,640. The monthly haemorrhage from the fund, this is the pension fund, would, therefore, be over \$116 million or \$1.3 billion annually. This is evident of the high level of corruption under this Administration.

In closing, it is necessary to state that had the Auditor General, in his review of the Old Age Pension Programme, taken into consideration the census figures rather than solely rely on the Ministry of Labour, Human Services and Social Security, this situation would have been properly investigated and old age pensioners would have received thousands of dollars more than they are now receiving.

I am prepared to make my study available and public whenever necessary.
