(BILL NO. 15 OF 2008)

### **Publication of Bill**

1. The Money Transfer Agencies (Licensing) Bill 2008, Bill No. 15 of 2008, seeks to provide for the licensing of persons carrying on the business of money transfer agencies; to make provision for the registering of money transfer agents; and for connected purposes. The Bill was published on 23<sup>rd</sup> July, 2008.

# **Introduction and First and Second Readings**

2. The Bill was introduced in the National Assembly and read a first time on 24<sup>th</sup> July, 2008 and read a second time on 7<sup>th</sup> August, 2008.

# Committal to Select Committee

3. Following its first reading, the Bill was committed by the National Assembly for consideration by a Special Select Committee.
