EXECUTIVE SUMMARY

In accordance with Article 212D of the Constitution of Guyana the Ethnic Relations Commission (ERC) continued its work in the year 2008 in the following main areas:

- a. Public Education and Awareness
- b. Conflict Resolution/Transformation
- c. Investigative
- d. Administrative and Finance

Public Education and Awareness

The Commission held annual Constituency Meetings with representatives of the seven (7) Constituencies and other stakeholders to report on its 2007 programme of activities and to garner feedback aimed at further enhancing its work.

Two meetings of the Multi Stakeholder Forum (MSF) National Conversation Working Group were facilitated by the Commission during the reporting period; and the group apart from addressing the issue of "a type of governance that would ensure ethnic security," benefited from presentations by officials from the Ministries of Labour, Local Government and Culture, Youth and Sport.

The Commission visited the ten (10) Administrative Regions and held meetings with Regional Executive, religious leaders and other stakeholders. During those visits, the Commission also conducted for the first time Youth Workshops engaging young people in discussion of interest to them, held film festivals in schools and took complaints from residents.

Conflict Resolution/Transformation

In the aftermath of the massacres in Lusignan and Bartica early 2008, the ERC with support from other stakeholders held meetings in the two communities and nearby villages to offer moral support and assist the residents to deal with their concerns and fears.

By mid 2008 the Commission with funding from United Nation Development Programme held a number of Inter/Intra Community Dialogue meetings in Bartica and its neighbouring communities, as well as communities on the East Coast of Demerara. Approximately one thousand, four hundred and twenty-one (1,421) persons participated and benefited from the project.

In November, 2008 the ERC held a Religious Leaders' Conference aimed at engaging religious leaders in discussion to propagate their faith in a responsible manner under the theme "Propagating faith in a multi-cultural, multi-religious society".

The intention of the Conference was to forge among the religious leaders a closer understanding, tolerance and respect for the various religions/cultures. Three hundred and eighty-six (386) representatives of the Christian, Hindu, Muslim, Bahai and other religious faiths participated.

A Religious Broadcasters' Workshop under the theme "Encourage and create respect for religious, culture and other forms of diversity in a plural society" was held in December, 2008 to sensitise religious broadcasters of the need to exercise understanding, tolerance and respect for other religions in their programmes. The workshop was attended by seventy-six (76) religious broadcasters, television hosts and television owners from the Christian, Hindu, Muslim, Bahai and other religious faiths.

Investigative

During the period under review, the ERC received eighty (80) complaints. Fifty-nine (59) of those complaints were investigated and concluded.

In keeping with one of its functions, the Commission held a meeting with representatives of the various ethnic groups in Guyana to plan for a national Ethnic Based Conversation. Among the suggestions made by the representatives was that the ERC should first consult with each ethnic group before holding a national conversation. As a consequence, consultations were held with representatives of the Amerindian, Chinese and East Indian Communities. Reports of those consultations were presented to the National Assembly.

Administrative and Finance

Administrative

The ERC continues to be housed in the BIDCO building, 66 Peter Rose and Anira Streets, Queenstown, Georgetown. The Commission is staffed by a total of twenty persons who have been employed on a month to month basis since August 2007.

<u>Finance</u>

The ERC had budgeted to receive one hundred and four million, four hundred and seventy-three thousand (\$104,473,000) dollars under current expenditure, and five million, seven hundred and forty thousand (\$5,740,000) dollars for capital expenditure.

The Commission received from the Ministry of Finance a total of seventy-seven million, two hundred and fifty-nine thousand (\$77,259,000) dollars for current expenditure. Two

million, one hundred and forty thousand (\$2,140,000) dollars was approved for capital expenditure. However, the ERC expended only one million, eight hundred and eighty-seven thousand (\$1,887,000) dollars as it was decided that computers would not be purchased in 2008.

GENERAL

The Ethnic Relations Commission organized and executed its work programme for the year 2008 in accordance with its functions as set out in Article 212 D of the Constitution of Guyana.

DEATH OF COMMISSIONER SHAHABUDIN MC DOOM AND THE APPOINTMENT OF MR. SHAFFEEK KHAN AS COMMISSIONER

The Commission suffered the loss of Mr. Shahabudin Mc Doom, the Commissioner who represented the Muslim Community on the ERC. Mr. Mc Doom passed away in London on March 8, 2008 after a brief illness. As a consequence, the Commission elevated Mr. Shaffeek Khan, Alternate Commissioner to the position of Commissioner and a formal advisory was sent to the Muslim Community.

RESIGNATION: COMMISSIONERS

Mr. Andrew Garnett, the Commissioner representing the Labour Constituency on the ERC, tendered his resignation effective from June 30, 2008. Mr. Carvil Duncan, the Alternate Commissioner, was appointed to fill the vacant position with effect from July 1, 2008.

At the end of August, 2008 Reverend Roy Thakurdyal, the Alternate Commissioner representing the Christian Constituency, migrated to Canada.

Then on September 19, 2008 Commissioner Shaffeek Khan tendered his resignation as Commissioner representing the Muslim Community on the ERC, due to ill health.

These developments have led to a significant reduction in the size of the Commission with just four (4) Commissioners representing

- a. The Christian Constituency
- b. The Labour Constituency
- c. The Private Sector Constituency
- d. The Women's Constituency

There is no active representation on the ERC for the Hindu, Muslim and Youth Constituencies, nor are there Alternate Commissioners for those listed above.

MEETINGS OF THE COMMISSION

During the reporting period, the Commission held fifteen (15) Statutory Meetings and over thirty (30) special meetings to discuss its plans and agree on action to be taken regarding its work programme and other business.

PUBLIC EDUCATION AND AWARENESS

2008 CONSTITUENCY MEETINGS

The ERC hosted its Annual Constituency Meetings with the seven (7) Constituencies and other Stakeholders between March 26 and April 8, 2008. The purpose of the meetings

was to report on the Commission's work programme for 2007 and solicit feedback, comments and suggestions for the ERC's programme of activities for 2008.

MEETINGS OF THE MSF NATIONAL CONVERSATION WORKING GROUP

The Working Group established to ensure the implementation of recommendations for regional and national development suggested through the Multi-Stakeholder process, met on March 4, 2008. Discussion centered on:

- a. Local Government Reform
- b. The proposal for a Public Education Programme to inform citizens how to participate effectively in the Local Government Systems.
- c. Need for the functioning of the Constitutional Reform Committee (CRC) of Parliament
- d. Inter-Party discourse between the People's Progressive Party/Civic (PPP/C) and People's National Congress/Reform (PNC/R)
- e. A system of governance to ensure ethnic security in Guyana
- f. In light of the crime situation, Crime Law and Order
- g. Areas that should be lobbied for necessary changes.

The Group met again on October 9, 2008 and benefited from presentations by Officers of the Ministries of Labour, Local Government and Culture, Youth and Sport. After a general discussion, members of the Group suggested the following recommendations for action:

GAP/ROAR


- A broader approach is needed to tackle the issue of lack of job opportunities since adults are also suffering

- A structured policy with a common objective as it relates to youth strategy

PEOPLE'S PROGRESSIVE PARTY/CIVIC (PPP/C)

- Strengthen current structures in place for youth programmes
- Increase budgetary allocation to the Youth Ministry
- Make the youth programme more accessible to youths in various communities
- The profile of the youth programme needs to be intensely promoted for public awareness
- Source new partners for widening sponsorship
- Ministry needs to look at the delivery of the programme Trainers should be in touch with daily realities of life

TRADES UNION

• Would like the Working Group to come up with a solution for the subvention issue affecting the Critchlow Labour College (CLC)

CULTURAL BASED ORGANIZATION

- CDCs have to become more effective
- Crime and politics affecting development at the community and regional levels
- Youths should be involved in religious programmes, conflict ameliorated programmes and skills training.
- Youths are picked up daily by the police
- Corruption exists in the Police Force and judicial system

RELIGIOUS BODY (HINDU)

- Youths are unwilling to work even though there are job opportunities available to them
- Churches cannot help youths if they do not care about helping themselves
- Youths have to have some self-dignity

Career guidance will assist in training youths to develop their potential

REGIONAL CONCERNS:

The following concerns were noted from presentations made by representatives of the undermentioned Administrative Regions:-

REGION # 1

- The community is worse off with the trade in illicit drugs (marijuana and cocaine)
- Gold is used to attract girls into prostitution
- Rampant sale of arms and ammunition
- The ERC was asked to assist in pushing the cash-crop agriculture base set up at Port Kaituma to alleviate the drug trade

REGION # 2

- Too many youths are left out of youth organizations
- More industrial factories are needed for the creation of job opportunities
- Adults should encourage youths to focus on the positive aspects of life

REGION #3

- Farmers need to be certified to gain better access to market opportunity
- The regional authority needs to set up a data-base to register all unemployed youths, vacancies and employment opportunities
- Consideration should be given to have multi-grade schools in the riverain communities where one teacher teaches several classes - schools need one teacher per class
- Teachers in the riverain communities need to be paid better salaries and schools adequately staffed.

REGION #5

- Called for the recruitment office in the region to work full-time instead of part-time
- The religious groups should be more involved in youth activities
- More cottage industries to be set up in order to provide jobs opportunities
- The need for bank loans for farmers on a moratorium basis so that they can increase their production levels
- Proper supervision for the allocation of government contract; regional authority needs to be more involved in the proper execution of projects

Schools' curriculum to cater for career guidance

REGION # 6

- The Community Center in Region 6 is always locked residents have no access
- Concerned about the ERC's muscle at the governmental level

REGION #7

- Need for additional funding for youth programmes
- Access to more opportunities for youths within the hinterland communities
- More consideration for self-development should be given to youths from the hinterland communities
- Increased access to youth programmes that will create new opportunities and forge alliances with new partners
- Seeking employment with the private sector
- Youth Ministry needs to work along with youths to become aware of challenges they face
- More accountability needed for grants and loans received from NGOs
- Noted that the CDCs play a vital role in the communities, but that several of them have become defunct due to the lack of officials. CDCs have more access to funds available from funding agencies than the NDCs.

REGION #8

- The need to know what skills are most needed in the region in order to conduct skills training for youths in the community.
- Lack of reading skills is hampering the development of youths in the community

REGIONAL VISITS

As part of the Commission's annual programme of activities the Chairman, Commissioners and staff visited the ten (10) Administrative Regions over the period May 19 to December 18, 2008.

Set out below is the general programme for the visits:

- a. Meeting with the Regional Administration
- b. Meeting with representatives of religious bodies, the private sector, labour, youth and women
- c. Meeting with residents

- d. Youth Workshop
- e. Film Festival in schools
- f. Taking complaints from residents

Approximately eleven thousand (11,000) children from one hundred and twenty-one (121) schools throughout Guyana benefited from the Film Festival sessions conducted by officers of the Public Education and Awareness Unit.

YOUTH WORKSHOPS

The Youth Workshop is a new initiative through which the Commission engaged young people to sensitize them of the need for tolerance and respect for all races and to have them discuss how they can contribute meaningfully to racial harmony in Guyana.

The Workshops held in the ten (10) Administrative Regions throughout 2008 were also designed to mobilize youth from various areas in the Regions, to encourage among them free and frank discussion and provide them with the opportunity to share their views on the Guyana they desire.

The process utilized was the viewing of special video clips portraying conflict/conflict resolution. Participants also viewed a similar video titled "GUYANA" which was produced by the late Commissioner Shahabudin Mc Doom. After viewing the films, they were encouraged to identify the themes and messages and share any experiences that they could associate with the films.

In terms of the Guyana they desired, listed below are some of the common views shared by the young people:

- 1. Co-operative
- 2. Peaceful
- 3. God fearing
- 4. Harmonious
- 5. Loving
- 6. Violence-free
- 7. Wealthy

With respect to obstacles facing them, the youths listed below some of their views:

- 1. The government, politicians and religious leaders were blamed for not living up to their offices and for not fulfilling promises
- 2. They called for the creation of job opportunities for youth
- 3. They called on leaders to preach peace instead of segregation
- 4. Identified poor working conditions
- 5. Racism/ethnic conflict
- 6. Teenage Pregnancy
- 7. Domestic violence
- 8. Brain and skills drain due to migration
- 9. Lack of co-operation and understanding among Guyanese
- 10. Criminal activities
- 11. Lack of family values
- 12. Need for equal opportunities
- 13. Abuse of alcohol
- 14. Lack of youth activities
- 15. Corruption in the Police Force
- 16. Lack of education among citizens
- 17. Police lacks the right approach to situations

Listed below are some of their recommendations for a better Guyana

- 1. There must be respect for all ethnic groups
- Need to improve literacy
- 3. Need for equal opportunity and justice for all
- 4. Stop fighting and unite for a better Guyana
- 5. Reintroduction of religious education in schools
- 6. Children must not only be aware of their rights but also their responsibilities
- 7. Foreign investors should do more for the country
- 8. Need to eradicate crime in order to have a Guyana we desire
- 9. Educate the nation through dialogue, workshops, media etc.

- 10. Proudly display our diverse culture always and not only at specific times
- 11. Guyanese must work together
- 12. Stop racism in schools
- 13. Promotion of games and events involving a wide cross section of people to encourage peace
- 14. Open multi-disciplinary training centres across the country

The Youth Workshop attracted approximately four hundred and sixty-six (466) young people from the Administrative Regions visited. A breakdown of participants by Region is shown below –

CONFLICT RESOLUTION/TRANSFORMATION

SUPPORT TO RESIDENTS IN THE AFTERMATH OF THE MASSACRES IN LUSIGNAN AND BARTICA.

The massacres in Lusignan, East Coast Demerara on 26th January, and Bartica on 17th February, 2008 led the ERC to intervene prematurely in those communities with the Inter/Intra Community Dialogue that was aimed at having communities interface with each other in an environment that was free from fear, intimidation and animosity.

Between January and February, 2008 the Commission conducted meetings in nine (9) communities on the East Coast of Demerara namely, La Bonne Intention, Chateau Margot, Annandale, Beterverwagting, Enterprise, Lusignan, Buxton, Friendship and Mon repos. Meetings were also held with students in a number of schools that are in close proximity to Lusignan, including the Life Spring Ministries Primary School, Institution of Business Education and Urmilla Primary School. The purpose of those meetings was to help the students to address their fears and concerns and to offer them moral support in the aftermath of the tragedy in Lusignan.

The ERC had two interventions in Bartica, Region 7 immediately following the massacre in that community.

With a delegation which included Commissioner L. John P. Willems, Hindu Priest Shri Prakash Gossai and members of the Inter-Religious Organisation, Rev. Ronald Mc Garrell and Mr. Roshan Khan, the Chairman of the ERC visited Bartica to give moral support to grieving families and offer words of comfort to the grief stricken community.

A live call-in television programme and community meeting were also held giving residents the opportunity to air their views on the incident that had taken place and to consider future security of the community.

While the Commission continued its work on the East Coast of Demerara, a team comprising Commissioner Willems, the Chief Executive Officer, two Investigative Officer and Programme Officer paid a follow-up visit to Bartica and its neighbouring communities to conduct peace discussions with students and residents. Meetings were held at:

- Bartica Secondary School
- Bartica Annex
- St. Anthony Secondary School
- St. John the Baptist Primary School

A live call in television programme was also hosted by the team and the entire interaction provided opportunities for residents to express their views and concerns particularly as they relate to ethnic security.

INTER/INTRA COMMUNITY DIALOGUE

The Inter/Intra Community Dialogue was launched on June 16, 2008 with funding provided by the United Nations Development Programme (UNDP).

The main objectives of the Dialogue were:

- To encourage the understanding, acceptance and tolerance of the diversities among the ethnic groups through dialogue in a harmonious and safe environment.
- ❖ To forge solidarity among the ethnic groups particularly between the African and East Indians in affected areas
- To create a sense of ethnic security among the ethnic groups by examining stereotypical perceptions
- To harness recommendations and suggestions for policy and behavioral changes for the fostering of harmonious relationships among the ethnic groups.

Common Recommendations Identified from the Inter/Intra Community Dialogue/Meetings

- There must be equal access/opportunities to resources
- Guyanese must educate themselves on each other's culture and religious beliefs/practices
- The fear/mistrust/stereotypical perceptions must be eradicated in homes, places of worship and schools; the media to lend support in this area
- The need for integration in communities
- We have to co-operate as Guyanese to promote a Guyana that we all desire

- Politicians must keep "their word/promises"
- Remove the "Indo" and "Afro" when identifying the two major ethnic groups
- Politicians should set examples regarding racial issues; they contribute to the division among the people
- ❖ The people must put all prejudices aside and start living peacefully together
- ❖ People must learn to let go
- The use of racist language must cease
- Build trust, love and respect for each other

Two hundred and eighty-eight (288) residents from Bartica and its neighbouring communities participated in the Inter/Intra Dialogue, while one thousand, one hundred and thirty-three (1,133) persons from twenty-six (26) villages along the East Coast Demerara benefited from discussions in the Inter/Intra Community Dialogue.

A full report of the Inter/Intra Community Dialogue was submitted to the National Assembly on 29th January, 2009.

RELIGIOUS LEADERS' CONFERENCE

Article 212D (f) of the Constitution states that the ERC is mandated to establish and create respect for religious, cultural and other forms of diversity in a plural society.

The Conference of Religious Leaders was proposed in accordance with this mandate and formed part of ERC's proactive work to promote harmony and good relations within the society. The Conference was therefore used to engage religious leaders in a discussion to propagate their faith in a responsible manner. Further, it served to engage stakeholders from all religious persuasions to discuss and examine the theme: "Propagating Faith in a multi-cultural, multi-religious society."

The Conference of Religious Leaders targeted all religious groups, Inter-Religious Organisations, umbrella organisations, religious denominations and faith-based groups.

It was envisaged that this Conference would forge among Religious Leaders a closer understanding, while developing tolerance and respect for the various religions/cultures that constitute the Guyanese society.

Three hundred and eighty-six (386) persons from the Christian, Hindu, Muslim, Bahai and other faiths participated in the Conference. The opening Ceremony was attended by His Excellency the President Mr. Bharrat Jagdeo, Ministers of the Government, Members of Parliament, representatives of the Diplomatic Corps, His Worship the Mayor, Deputy Mayor of Georgetown and the Regional Chairman of Region 4.

Following the official opening ceremony, participants engaged in discussions under four key sub-themes

- a. What is working for us in our society
- b. Some examples of obstacles, areas of conflict and sensitivities
- c. Ingredients for a continued and healthy interfaith dialogue
- d. What participants left the conference with

Participants also examined a case study which was aimed at allowing them to utilize skills of negotiating to resolve a potential conflict.

Though it was not a direct objective, many of the views put forward by participants were in the form of recommendations and these are outlined in the final report which will be issued under separate cover and placed on the ERC's Website www.ethnicrelations.org.gy.

RELIGIOUS BROADCASTERS' WORKSHOP

The Religious Broadcasters' Workshop was the final major activity for the Ethnic Relations Commission in 2008. This workshop was held under the theme "Encourage and create respect for religious, cultural and other forms of diversity in a plural society" on December 2, 2008 at the Umana Yana, Kingston, Georgetown. It was attended by seventy six (76) Religious Broadcasters, television hosts and television owners from the Christian, Hindu, Muslim, Bahai' and other religious communities.

The purpose of the Religious Broadcasters' Workshop was to sensitise Religious Broadcasters of the need to exercise understanding, tolerance and respect for other religion in their programming.

To achieve the desired outcomes and objectives agreed upon, two (2) team meetings were held on November 27 and December 1, 2008 respectively. The team comprised of ERC Chairman Bishop Juan A. Edghill, Commissioner L. John P. Willems, Ms. Christine King, Chief Executive Officer, other staff members of the ERC, and Facilitators Ms. Rajkumarie Singh, Rev. Ronald Mc Garrell, Pandit Chrishna Persaud, Ms. Beverly Chan, Ms. Daune Pratt, Mr. Abbas Mancey, Mr. Imran Mohamed, and Mr. Kwame Gilbert. The pre-workshop activities helped to provide a brief overview of the workshop purpose and objectives; brainstorm stakeholder group(s) attending the workshop; and gather input around specific topics/themes for inquiry during the workshop itself.

These information gathering and planning efforts made possible the design of a workshop agenda, facilitation plan and participants' handout.

After a brief opening ceremony at which the Chairman of the Advisory Committee,

Mr. Pat Dial delivered a presentation on the regulations relative to television license and programming, participants were placed in four (4) groups that were each managed by two (2) trained facilitators. The first session focused on the following questions

- a. What do you value as a Broadcaster?
- b. What are your expectation(s) for the day?

Participants were further led through a session that asked two (2) specific questions

- a. What is working for us?
- b. What can be done differently/what do you hope for?

The afternoon's activities sought to further deepen the discussion in keeping with the workshop's theme. To achieve this, participants were given a typical case study to examine, discuss and resolve. At the end of the exercise participants were asked to present five (5) principles or standards that they agreed on for future broadcasting.

The report of the Religious Broadcasters' Workshop will also be submitted to the National Assembly.

INVESTIGATIVE

COMPLAINTS

Between January 1 and December 31, 2008 the Investigative Unit received eighty (80) complaints during the Commission's Regional Visits, Inter/Intra Community Dialogue as well as from persons visiting the offices of the ERC. Of those complaints, fifty-nine (59) matters were investigated and completed.

The Unit is continuing follow-up work on the remaining twenty-one (21) cases for 2008 and fourteen (14) for 2007 which require further evidence. A matrix of complaints received is at **Appendix 2**.

Complaints to the Commission which attracted public attention were:

- a. Mr. Rudolph Adams against the Guyana Forestry Commission
- b. Ms. Charmaine DeMendonca against Dr. Kishore Persaud of the GPHC
- c. The Indian Arrival Committee (IAC) against Stabroek News.

The complaints at a. and b. are still under investigation and the IAC complaint was dealt with and closed. The decision of the ERC in this case is at Appendix 3.

MEETINGS/CONSULTATIONS WITH ETHNIC-BASED GROUPS

One of the functions of the Ethnic Relations Commission as outlined in Article 212 D of the Constitution of Guyana is to "Foster a sense of security among all ethnic groups by encouraging and promoting the understanding, acceptance and tolerance of diversity in all aspects of material life, and promoting full participation by all ethnic groups in the social, economic, cultural and political life of the people"

Based on complaints received by the Commission and in keeping with the above mandate, the Commission invited the Ethnic-Based groups to plan for a national Ethnic-Based Conversation. Initially, the ERC had intended to target the two main ethnic groups – Indo-Guyanese and African Guyanese. It was however felt that the other ethnic groups should be included with a view to lessening racial animosity and bolstering faith in the institutions tasked with governing the nation.

The Commission organized the first meeting in January 2008 which was attended by representatives of the Guyanese Organisation of Indigenous Peoples, Indian Arrival Committee, The Amerindian Action Movement of Guyana, Kingdom of Manumitted African, Amerindian Peoples Association and the Guyana Rastafarian Council. At that meeting representatives were given a concept paper for examination and discussion. There were varying views on the organisation of the ethnic-based conversation, and since time was of essence, the Commission agreed with the suggestion to consult separately with each ethnic group before hosting a national conversation.

As the Commission had already met with the African Guyanese Community in November 2007, advertisements were published in the media for consultations with representatives of the Indo Guyanese, Amerindians, Chinese, Portuguese and mixed race groups. Responses were received from:

- The Amerindian Community
- The Chinese Community
- The East Indian Community

The Commission met with representatives of the Amerindian Community on July 8, 2008 who highlighted the following concerns:

- a. Illegal Mining in Amerindian Communities
- b. High incidence of robbery in Amerindian Communities
- c. Prostitution
- d. Selling of alcohol in mining camps
- e. Use of illicit drugs
- f. Danger to aquatic life

- g. Grant of Mining Concessions by Guyana Geology and Mines Commission without consultation with Village Captains
- h. Amerindian Right to Land titles
- i. Mercury pollution creating a health hazard for Amerindians
- j. Guns in the Wai Wai area
- k. The low quality of education offered in Amerindian communities when compared with that offered to coastlanders
- I. Potable water for Amerindian communities
- m. Exploitation of Amerindian women and girls

Representatives of the East Indian Community met with the Commission on July 10, 2008 to share their concerns. However, there was a request that there should be no written or audio recording of the meeting, thus no report was reproduced on that Consultation.

Members of the Chinese Community met with the ERC on July 17, 2008. With them was a representative from the Chinese Embassy. The Chinese raised the following issues:

- a. Problems of the language barrier between locals and Chinese immigrants
- b. That Chinese immigrants are targeted because of the language barrier
- c. Security especially for Chinese immigrants
- d. Robberies committed on Chinese businesses
- e. Problems encountered by Chinese immigrants with the Immigration Department

There was no response from the Portuguese and Mixed race groups.

Reports of Consultations with representatives of the Amerindian and Chinese Communities were compiled and presented to the National Assembly on November 26, 2008.

The report of the African Community Consultation which was held in November, 2007 was submitted to the National Assembly on March 27, 2008.

TRANSPORT

The Commission has in its possession one **Toyota Carina AT212 motor car** and **one Toyota Hilux 4 Runner** purchased in 2004 and 2005 respectively. These refurbished vehicles have provided (with regular maintenance) a fairly satisfactory service to the work of the Commission. The Commission also has a serviceable a **125cc motor scooter** which was purchased in 2005 to be used by the Office Assistant for official duties.

FINANCE

The Ethnic Relations Commission's budgetary estimate for 2008 was one hundred and ten million, seven hundred and forty-six thousand (\$110,746,000) dollars, of which five million, seven hundred and forty thousand (\$5,740,000) dollars were for capital expenditure and one hundred and four million, four hundred and seventy-three thousand (\$104,473,000) dollars for current expenditure. The National Assembly in its annual budget approved seventy-two million, one hundred and forty thousand (\$72,140,000) dollars with two million, one hundred and forty thousand (\$2,140,000) dollars for capital expenditure and seventy million (\$70,000,000) dollars for current expenditure. Below is a breakdown of the current expenditure:

The 2008 expenditure shows an increase of 12% over that of 2007. In terms of employment costs, there were resignations from staff, and although some of the positions were filled, this did not impact on the 5% increase in salary; payments to those persons eligible were based on the December, 2007 salary.

Other Charges increased with the level of activity of the Commission throughout the year, as well as the steep increase in fuel costs resulting in increases in electricity and other charges.

In October, 2008 the Commission requested a supplementary provision of six million and fifty-two thousand, nine hundred and thirty-two (\$6,052,932,000) dollars to facilitate the Religious Leaders' Conference and Religious Broadcasters' Workshop; six million dollars (\$6,000,000) was approved. The ERC also received one million, two hundred and fifty-nine thousand and eighteen (\$1,259,018) dollars to cover the five (5%) percent payout on salaries retroactive to the period January 2008 – May, 2008.

CAPITAL EXPENDITURE 2008

Two million, one hundred and forty thousand (\$2,140,000) dollars was approved for capital expenditure but the ERC capital budget was revised downward to one million, eight hundred and eighty-seven thousand (\$1,887,000) dollars.

DONOR FUNDING

The United Nations Development Programme (UNDP) funded the Inter/Intra Community Dialogue to the tune of two million, four hundred and one thousand (\$2,401,000) dollars. Six hundred and seventy-one thousand and twenty-six (\$671,026) dollars was provided by the Commission to cover the full cost of the project.

RECOMMENDATIONS

- a. That the Motion for the reconstitution of the Ethnic Relations Commission be reviewed with a view to the appointment of members of the Commission.
- b. The naming of representatives and establishment of the other Rights Commissions under Act 5 of 2001.
- c. The constitution and activation of the Ethnic Relations Commission Tribunal.
- d. That the Ethnic Relations Commission be empowered to subpoena witnesses and documents.
- e. That members of the National Assembly having received annual and other special reports will table motions for debate and specific action.

CONCLUSION

The year under review begun as a challenge to the Ethnic Relations Commission with the massacres in Lusignan and Bartica. As a consequence of those incidents, the Commission launched a successful programme aimed at facilitating residents in both communities to share among themselves and with other residents their views and concerns on the issue of ethnic relations particularly between African and Indian Guyanese.

Apart from the Inter/Intra Community Dialogue, the Commission introduced for the first time, Youth Workshops as part of its programme for Regional visits, to encourage the participation of young people in discussing matters of national concern. Attendance and participation were encouraging and thus it is the intention of the Commission to continue this exercise.

The activities held for the Religious Community provided Religious Leaders and Broadcasters with the kind of information that would allow for greater understanding, tolerance and respect for the various religions in Guyana. It is envisaged that the experiences and lessons learnt by the religious representatives will be shared with their respective groups thereby contributing to the resolution of some of the problems encountered in our society.

Christian Constituency

Interested in finding solutions to bridge the ethnic divide that exists in Guyana...

Representatives from Christian denominations listed on the Parliamentary list of entities which are to be consulted to elect members to serve on the ERC and other Christian bodies the Commission had developed partnerships with over the last five years, met at the ERC's Secretariat on March 26, 2008 as part of its Annual Constituency Meetings. The aim of the meeting was for the Christian Constituency to review the work the Commission executed over the past year and to offer suggestions on how the ERC can enhance its role to promote good relations among the citizenry.

Reporting briefly on the work the Commission conducted in 2007, Chairman of the ERC Bishop Juan A. Edghill informed the representatives of the following activities:

- 1. The presentation of the five research reports on equitable distribution of resources to the Speaker of the National Assembly.
- 2. The 2007 Regional Visits
- 3. The African Guyanese Consultation and the presentation of the report to the Speaker of the National Assembly
- 4. The Commission's Public Education and Awareness activities.

Outlining the Commission's priorities for the year 2008, the Chairman informed the Christian representatives about the Commission's plan to conduct a Religious Broadcasters' Consultation, an Inter/Intra Community Dialogue and an Ethnic Based Conversation.

The Chairman told the representatives that ERC will be hosting the Religious Broadcasters' Consultation to encourage respect for Guyana's religious plurality among the producers of religious television programmes on the state and private media. Regarding the conceptualization of the Religious Broadcasters' Consultation, the ERC Chairman stated that a survey of the electronic media would determine that there is a proliferation of religious programmes, and sometimes the content is not always conducive to maintaining religious tolerance in the society.

He added that in some cases, religious broadcasters go beyond propagating their faith to demonizing other religious beliefs. The Chairman noted that the ERC would therefore be taking a proactive step to forge a commitment among religious broadcasters to propagate their faith without offending others, in the interest of harmony and good relations in the society.

Bishop Edghill told the Christian Constituency that the Inter/Intra Community Meetings is aimed at providing the opportunity for racially exclusive communities and those which are mixed to interface with each other.

He also informed them of the Commission's plan to monitor the imminent Local Government Election to ensure that race is not factored into Political Parties campaigns, the continuation of its Regional Visits and Public Education and Awareness programmes. The representatives were then given the opportunity to comment on the work of the Commission and its priorities for 2008.

Chairman of the Guyana Council of Churches, Rev. Alphonso Porter observed that the work the ERC has done over the past four years should be celebrated. The Commission, he said, has been carrying out its mandate with regard to the investigation of complaints, conflict resolution, education and awareness and research, in a commendable manner.

Nevertheless, the Chairman of the Guyana Council of Churches inquired whether the Commission encountered any challenges in the execution of its mandate, specifically the difficulties it may have encountered as it traversed the country. In addition, he inquired about the other areas the Commission needed to cover apart from those the Chairman highlighted in highlight in his presentation.

Responding to the latter, ERC Chairman stated that from the time the ERC started its work, the initial focus was investigation of complaints, conflict resolution, education and awareness and research. He noted that very soon, the Commission will begin to focus on review of legislation that has implications for ethnic relations. One of those has to do with the treating of public holidays, he noted, adding that it is felt that other religious holidays are not given the same respect as Good Friday and other Christian holidays, so it was one area the ERC needs to explore.

Regarding the question on challenges the ERC may have encountered, its Chairman stated that the Commission's capacity to deal with complaints of racial discrimination has been limited because it does not have the power to subpoena. He noted that for the past four years, the Commission has recommended in its Annual Report that that omission from Article 212 (D) of the Constitution be included so that the Commission can perform this aspect of its mandate more effectively.

The Christian constituency indicated to the Commission that is was interested in finding solutions to bridge the ethnic divide that exists in Guyana, knowing that they have tremendous influence over a large percentage of Guyanese.

This consultation with the Christian community was the first in a series of Annual Constituency Meetings from March 26 to April 7, 2008.

Muslim Constituency

 Affirmative action should be taken to foster religious understanding and remove suspicion about the various forms of religious practices that exist in Guyana - Muslim

The Ethnic Relations Commission (ERC) conducted the second in series of meetings with its constituencies and civil society partners on March 27, 2008. The Commission met at its Peter Rose and Anira Streets location with the Muslim Constituency, including organisations on the Parliamentary list and other Muslim groups the ERC has collaborated with over the past five years.

At the meeting, the representatives were presented with a document detailing the work the Commission executed from 2007 to present and its projections for the remainder of this year. The Chairman highlighted the ERC's intention to host a Religious Broadcaster's Consultation to bring about a sense of religious tolerance on the air waves.

This proposal was commended by the Muslim representatives who felt that affirmative action should be taken to foster religious understanding and remove suspicions about the various forms of religious practices that exist in Guyana, which in many instances, stem from the lack of knowledge.

Speaking at the meeting, Private Sector Constituency representative on the Commission, Mr. John L. P. Willems, called for the cross fertilization of cultures, which he said is necessary to dispel suspicion and bring about a sense of ethnic harmony in a multicultural society such as ours. Emphasizing the need to explore the richness of our multicultural diversity, Commissioner Willems said that the depth of the various cultural traditions which exist in Guyana has been obscured by the preoccupation with one's own culture. The Private Sector Commissioner noted that there is some inevitable 'mixing' in business transactions and other spheres, but generally Guyanese seldom get an opportunity to really understand the intricate details of each other's culture. He urged the Muslim leaders to use the television medium for this sort of cross fertilization.

The meeting heard the Muslim representatives expressing dissatisfaction with the insensitivity of some employers who are reluctant to grant Muslim employees time off to pray on Fridays. Chairman of the ERC, Bishop Juan Edghill, noted that this concern was raised during the 2007 Constituency meeting, and the Commission mediate in a few complaints of this nature that were brought to its attention, adding that they were dealt with amicably. The Chairman stated however, that there is need for the exercising of greater religious sensitivity towards Muslims and other religious practices.

The issue of plurality of marriages, as part of the Muslim culture, was brought to the fore by representatives who felt that there is a need for the practice to be institutionalized. The ERC head advised the Muslims leaders present at the meeting to petition their elected representatives in the

National Assembly, as a collective body for there to be further debate and discussion on this issue.

In addition, concerns were expressed about stringent measures taken by law enforcement and social services official against *Nikka* marriages performed for female Muslims just under the age of consent. The representatives noted that the Muslim culture permits a girl's parent to give consent for her marriage in preservation of dignity and religious sanctity. However, if a marriage performed in such circumstance is drawn to the attention of the law enforcement officials, the parents can be charged. The representatives felt that this law should be reviewed.

Further, the Muslim representatives requested that ERC lobbies the Guyana Prison Service to make provision for their followers to wear three-quarter pants as against the knee length stipulation of the prison uniform for inmates whose terms of imprisonment have been confirmed. At the end of the meeting, the Chairman thanked the representatives for their continued support to work of the Commission and noted that the ERC remained committed to its work to promote harmony and good relations in Guyana.

Labour Constituency

 Representatives of the Labour Constituency encouraged the ERC to continue its Public Education and Awareness programmes in schools and work places

Claims of discrimination should be examined thoroughly to determine their validity so that those claims are not based on mere perceptions, which can stimulate ethnic insecurity in the society. This was the advice of the Ethnic Relations Commission's (ERC) Chairman, Bishop Juan Edghill, to member of its Labour Constituency, on Friday March 31, 2008.

During the period March 26 to April 8, 2008, the ERC met with its seven constituencies: Labour, Private Sector, Youth, Women and the three main religions, to apprise them of its work over the past year, and to harness their suggestions for the enhancing of ERC's role in improving harmony and good relations in Guyana.

In his address to the Labour Constituency, the ERC head stated that the Commission receives complaints of ethnic discrimination in the workplace and deals with them expeditiously. He added that those complaints are not widespread but are limited to a few State and Private Sector agencies.

Referring to complaints of ethnic discrimination, the Chairman told the Labour Union representatives that persons should not conclude that they were denied an opportunity because they are of a particular ethnic group. Conversely he said, a person should not perceived that he or she should automatically be granted an opportunity or service because of his or her racial background. That opportunity must be based on "objective criteria" and specific policy guidelines, the ERC head stated.

Bishop Edghill told the representatives that the researches the ERC commissioned in 2007 conducted on employment practices and economic opportunities did not find any instance of institutionalized racism or ethnic discrimination. However, he said that it was evident from the research that in some cases, officials used their 'discretionary powers' to favour one group as opposed to another and the ERC will take the necessary steps to ensure that those individuals receive "stiff sanctions." The Labour Constituency was encouraged by the Chairman to use the research reports as a basis for discussion on equal opportunities in the workplace.

The Constituency encouraged the Commission to continue its Public Education and Awareness programmes in schools and work places, which is essential to creating ethnic harmony in those spheres.

Inter-Religious Organisation

• Guyanese should think for themselves rather than having people doing the thinking for them - IRO

Arising out of the meeting with the IRO the following discussion/suggestions were tabled:-

- ✓ The Commission should intensify its work routine in the various communities
- ✓ People should move away from race politics.
- ✓ It was said that there is a perception by "Indo Guyanese" that if an "Afro Guyanese" gets into government, the "Indo Guyanese" would feel left out and vise versa, but this can be addressed either politically or electorally.
- ✓ Peoples' problems are based on their wants rather than their needs.
- ✓ It was suggested that the ERC should be consistent in its operations, at the same time try to avoid biasness.
- ✓ The view was expressed that people should respect and acknowledge each other's identity.
- ✓ Resolve our differences whether culturally or politically through dialogue.
- ✓ Respect our individual differences, this might not be easy, but we have to try as Guyanese.
- ✓ Provide a system of governance that promote ethnic security, whether it is shared governance or inclusive governance.
- ✓ Citizens must participate in all the religious functions in Guyana. For example, all Guyanese should celebrate with the Hindus, Muslims, and Christians as they observe their religious holidays.
- ✓ Re-introduce religious education in the school curriculum.
- ✓ To have unity and cohesion, we have to start with the individual.

- ✓ It was suggested that the ERC should promote debates in Secondary Schools relative to race relations.
- ✓ There are a lot of differences in the workplaces; the ERC was encouraged to facilitate programmes that can deal with these issues within the working environment.
- ✓ To bridge the gap in society we need to educate the people; we should not allow the political parties to manipulate us.
- ✓ Guyanese should think for themselves rather than having people doing the thinking for them.
- ✓ Guyanese must stop blaming each other and learn to work together as one people.

Private Sector Constituency

Voiced their support for the ERC to continue its Research Programme

Opening Remarks:

The Private Sector Constituency meeting was chaired by Commissioner L. John P. Willems who briefly reviewed the 2007 ERC's Report.

The meeting was informed of the absence of Bishop Juan Edghill, the ERC's Chairman who was out of the jurisdiction. Commissioner Willems in his opening remarks pointed out that although the ERC was being subjected to criticisms, it should stay free from political disputes and focus on its mandate until such time that Parliament determines otherwise. He charged the Private Sector with discharging its responsibilities in a responsible and unbiased manner. In concluding his brief remarks he invited participants to make their submissions / recommendations.

Discussion / Recommendations:

The following suggestions were submitted for consideration:-

- a. It was suggested that Civil Society and other Government bodies move away from past incidents and focus more on getting the work done, with a view of moving the Country forward.
- b. Participants lauded the way the ERC was pursuing its investigation into complaints of discrimination and advocated that the evidence must be brought to the forefront to expose individuals / Agencies practicing discrimination. The notion of getting Agencies to implement the recommendations was to be considered.
- c. Commissioner Duncan suggested that the dialogue process on cultural and other issues was critical at the community level. He made reference to the Trinidad model and suggested that Public Education Programmes on those issues be considered.
- d. Representatives of the Private Sector voiced their support for the ERC to continue with its Research Programmes.
- e. Discussions were centered on resuscitating some of the old cultural practices, the role of the ERC in fostering cohesion and a sense of identity. It was suggested that educational programmes be fashioned to reach people at the lower strata of society through symposiums and home meetings. The UN, the Government and Civil Society should be approached for assistance on these programmes.
- f. The concerns expressed by the African Guyanese of marginalization and discrimination were briefly discussed. Participants were informed by the Chair that research was done in five (5) areas which were very objective and balanced and not what was perceived. It was recommended that summaries of such reports be made available to the libraries of schools for future reference.

g. A comment was raised with respect to the Lusignan massacre of January 2009, where the Private Sector body expressed satisfaction that that incident did not escalate into racial tensions. It felt that the work done by Institutions and Civil Society should be recognised. The ERC was asked to continue with its Public Awareness Programmes in an effort to educate the public.

Questions:

Questions to be considered were asked by the participants;

- (i) How do Agencies respond to complaints of discrimination?
- (ii) Do you see ERC being given more scope?
- (iii) How effective is the ERC if the 2006 recommendations were implemented?
- (iv) Do we need to see if ethnic problems arise outside of election time?
- (v) Does the ERC have plans to educate young voters for the next election?

Closing Remarks:

The Acting Chairman thanked all for their participation and contribution towards the successful conduct of the Constituency meeting He made the point that the power to subpoena witnesses was being pursued by the substantive Chairman Bishop Juan Edghill, after which the meeting came to a close at 18:00 hours.

Hindu Constituency

 Group asked ERC to examine the disparity in employment practices with a view to having mechanisms put in place to deal with such discriminatory issues

OPENING REMARKS

The meeting commenced at 13:00 hours with a one minute silence of reflection being observed, after which the Chairperson, Commissioner Roy Thakurdyal welcomed all. Participants were informed of the absence of the substantive Chairman of the ERC and of the seven constituencies that constitute the Commission. The present state of the Commission was highlighted as it relates to the composition of Commissioners. Mr. Thakurdyal also made reference to the five (5) reports that were recently submitted to Parliament by the ERC.

It was recognised that there were no representatives from the Hindu Constituency on the Commission. The meeting was informed that the Hindu representative Pandit Ramkissoon Maharaj, was hospitalized in the UK, while Mr. Radha K. Sharma, Substitute Commissioner had resigned. With questions raised on immediate replacements, Commissioner Duncan indicated that procedural approaches do not allow the Commission to appoint Commissioners. A recommendation was made for mechanisms to be put in place to address the immediate replacement of Commissioners from the Hindu Religion.

Commissioner Thakurdyal briefly reviewed the ERC's 2007 Report, after which participants were asked to make their submissions/recommendations as they see fit.

Discussion/Recommendation

The following recommendation/suggestions were submitted for consideration:-

- a. With respect to employment practices in Guyana, the group advocated that Hindus were twice discriminated, once as a Hindu, the other as an East Indian. With a perception that Hindus were not getting justice in Guyana, they are asking the ERC to examine this disparity in employment practices with a view to have mechanisms put in place to deal with such discriminatory issues.
- b. The body feels that Hindu Religious Symbols, "Jhandi Flags erected at river edges and "Murtis" placed in Mandirs were being destroyed and were not respected. In a multi-ethnic, multi-cultural society such as Guyana, they are recommending that the public be sensitized through Religious educational programmes with a view to have them preserved.
- c. A suggestion was made with respect to the transferring of Police ranks of East Indian origin, where transfers contribute to the disintegration of the family and infidelity. The

Commissioners opined that transfers were imminent in the interest of National Security. The CEO suggested that issues of this nature should be referred to the respect Agencies.

- d. The group examined a perception by the Afro Guyanese Community that they are marginalized by the Government the Hindu community leaders are of the opinion that Hindus are worst off. It was suggested that they speak as a body with one voice on how they are marginalized.
- e. Comments were made that the Guyana Police Force was plagued with racism. It was recommended that mechanisms be put in place to address this issue.
- f. In the Hindu culture it was said that the Hindu woman loved to be adorned with jewellery. In today's' environment, Hindu women are afraid to uphold that part of their culture.
- g. Concerns were raised with respect to Inter Faith services in State Institutions where services were dominated by mainly Christian Priests. Particular reference was made to the Joint Services. The Constituency is of the view that the reciting of Hindu and Muslim prayers at these functions is a mere cosmetic approach which needs to be examined by the ERC.
- h. With the streets becoming very dangerous, some of the old Hindu cultures have changed. A recommendation was made for an educational programme sensitising people on these changes to be considered. It was felt that institutions like the ERC can bridge these gaps.
- i. A recommendation was made for all Guyanese to work together. In doing so, the "blaming process approach" as practiced by individuals and Institutions has to be changed.
- j. Hindus identified themselves through the wearing of "Rakshas" and "Chandans," a coloured string tied around the wrist of the hand. The body is concerned that this practice has been opposed in schools especially QC and Saints, where Hindu students were asked to remove these symbols during classes. Some teachers have associated these symbols with the devil. It was recommended that educational programmes be initiated in schools to change this perception.
- k. The home series Test matches between the West Indies and Sri Lanka in the Caribbean commenced with the opening match being played at the Providence Stadium on 23rd March, 2008, which was identified as "Phagwah Day," a Hindu holiday. Members of the constituency were of the opinion that this violated the rights of the Hindu religion, in that Test matches were never scheduled to play on other religious holidays. The Commissioners' view was that the issue should have been challenged long before the start of the Test match and that the body should have spoken with one voice.
- 1. References were made to the Army's Chaplain who was paid a salary. The view expressed was that Christians have complete monopoly of time and opportunity to administer religious activities in Institutions such as the GDF and the GPF. A

recommendation was made for the ERC to give guidance on its mandate to allow other religious bodies to have equal time and opportunity to participate.

- m. A recommendation was made for the ERC to pursue community dialogue with a view to fostering cohesion and respect among the different ethnic groups, cultures and religions.
- n. It was recommended that the ERC should make available the movie "Just a Little Red Dot," to be shown in schools, since it portrays a very important message of respect and understanding.
- o. On the issue of racism, it was suggested that religious groups should pursue an initiative of meeting, pronouncing and submitting recommendations to Parliament through their respective constituencies, in an effort to minimize its escalation.
- p. A proposal was made to broaden the representative field for the appointment of Commissioners to the ERC and to allow for replacements in the absence of those appointed.

Closing remarks

In his closing remarks, Commissioner Thakurdyal expressed thanks to all for their meaningful participation and suggested that the ERC in 2008 should strive to bring all religious denominations together for a better Guyana.

Women's Constituency

Commissioner Sampson briefs representatives of the Women's Constituency on ERC Work Programme for 2007

Opening remarks

In his opening remarks Commissioner L. John P. Willems, Chairman (Ag) welcomed those present and invited representatives to join in observing a silent reflection. Commissioner Willems told the gathering that the ERC was happy to meet with the Women's Constituency and informed them of the absence of the substantive Chairman who was out of the jurisdiction. Commissioner Cheryl Sampson was then asked to chair the meeting.

Commissioner Cheryl Sampson after introducing herself, Commissioners and staff asked the invitees to state their names and the organizations/groups they represented.. She then went on to explain the aim of the meeting which was for them to have an understanding of the work of the Commission from 2007 to the present time and to give their individual feedback which can enhance the Commission's work for 2008. Commissioner Sampson also spoke about the seven constituencies and highlighted the Commission's functions which are set out in Article 212D of the Constitution of Guyana.

She said that despite the fact that the Commission was not reconstituted, it continues to do its work in accordance with its mandate. She touched briefly on the following as was outlined in the report which was distributed to the attendees:

1. Toshaos' meeting

The infiltration of strange persons in the Amerindian Communities and other concerns.

2. Education & Public Awareness

- (a) Conducting Film Festivals in schools with the young people.
- (b) Debating & Essay Competitions working along with Ministry of Education.
- (c) Female Windball Cricket Competition

3. Legal & Investigative Unit

Status of Complaints

- 4. Strategic Planning for ERC 2008
- 5. Plans for Local Government Elections

6. Lusignan Massacre

Inter/Intra meetings were held in several villages with children, parents, teachers and the Community.

7. Bartica Massacre

Live Television programme, meetings in Bartica and neighbouring communities

- 8. Dialogue with the African Guyanese group
- 9. Religious broadcasters' consultations
- 10. Meetings with Christian, Hindu and Muslim organizations
- 11. Regional visits meetings with the Regional Administration and other stakeholders as well as residents in the communities.

Commissioner Sampson also reported on the research done on employment practices, economic opportunities, academic scholarships, tendering and procurement and land distribution and advised that they were submitted to the National Assembly.

Contribution of Participants:

During the discussion, a participant responding to the report of the Toshao's meeting, observed that Amerindians were inter marrying for years and that it was nothing new for strangers to visit their villages.

Another participant said that she would like the ERC to prevent the teaching of various religions in the public schools. She felt that it was offensive to indoctrinate children through a religion other than their own.

Commissioner Garnett in response to the request, stated that persons should be able to propagate their own faith. He added that it is not the role of the ERC to convert anyone to any religion.

It was mentioned, that there was an increase in the mixed race group in Guyana and it was suggested that the ERC considers this development in its programmes. It was also mentioned that there should be programmes that are inclusive of African and Indian Guyanese.

A representative speaking on the on research reports, enquired if any discrimination was proven, and what were the responses from Parliament.

Commissioner Sampson informed the audience that the ERC could not demand responses from Parliament but would have to wait for the reports to be tabled for discussion.

Youth Constituency

ERC engages the Youth Constituency to report on its Work Programme for 2007

The Meeting was called to order by Rev. Roy Thakurdyal who explained the absence of Bishop Juan Edghill, Chairman of the ERC and appointment of Mr. John Willems to act as Chairman ERC.

Rev. Roy Thakurdyal asked each person to introduce themselves and then went on to give a brief historical background of ERC and the annual constituency meetings. He explained that because of the interim position of the ERC a replacement could not be made for Dr. Frank Anthony, Minister of Culture Youth and Sport.

He then read the booklet "An Update on the Work of the 2007 to Present" and asked participants to follow in their copies. On completion of this activity Rev. Thakurdyal encouraged the group to make their recommendations/views/suggestions which can enhance the work of the Commission for 2008.

A participant enquired about a research document after its gets to Parliament. He made mention of the Multi-Stake holder project.

The CEO, ERC, informed the group that a copy of each research was placed on ERC website so that persons could peruse and do their lobbying. She mentioned also, that a working group which was established after the National Conversation meets quarterly to address the recommendations of the MSF.

A participant enquired about the findings of Employment Practices Research, as she noted that there was nothing in the news stating the ERC is taking action against anyone or organization. "What enforcement ERC has and what does it do", she asked.

Commissioner Sampson explained that the Employment Practices Research was done in Region # 4 and no discrimination was actually found.

The CEO, ERC also explained that it was a preliminary research that can be further developed.

Another participant sought clarity on whether the ERC is controlled by the Government. He opined "if the final decision lies in the Government's hands, then what are we really doing".

Rev. Roy Thakurdyal explained that the ERC does not have the power to subpoena witnesses or demand from any organization their documents.

Commissioner Garnett also made it clear that the ERC does not prosecute, but after investigations and findings, matters are referred to the relevant authorities for necessary action.

It was suggested that ERC uses its influence to recommend a standardised employment form to be used nationally which would cater for information on ethnicity, age, gender, etc.

Commissioner Garnett said it is a worthy contribution, but that the ERC will have to obtain legal advice on the suggestion.

A participant said that there was a major problem of racial insecurity among youths. He mentioned that this stems from the wrong perception, propaganda, school of thought, mindset, expectation and perceived hostility. He asked how we perception, fact or fiction could be dealt with.

Commissioner Garnett in response stated that ERC has to separate fact from fiction, treat with the mindset and deal with hardcore cases of discrimination.

It was reported by a representative that there is a deficiency as it relates to Community High Schools. He said that there is a decline in performance and suggested that an improved system should be put in place by the Ministry of Education.

He suggested that the ERC should assist in ensuring that the undermentioned areas are addressed:

- Plumbing, carpentry and other skills in schools; that they become part of the curriculum
- Lack of equipment in schools
- Lack of teachers in schools

Commissioner Sampson agreed with the suggestion. She made mention of:

- The Policy of Education implemented in 1970 to assist low achievers.
- Multilateral schools equipment no longer exist.
- Looking into the matter of re-implementing the Education Policy.
- The National Service and its benefits.

Another participant requested a meeting with the representative of the MSF Working Group (who was present) to report to members of the Youth Constituency.

Discussion also centered on:

- What is ERC doing to re-affirm its creditability and weight?
- Would like to see ERC doing more.
- Lobbying for a Regional/Caribbean programmes
- More creativity in dealing with Ethnic Relations.
- ERC needs to work closely with NGOs
- Tangible benefits for Youths
- Motivation
- Making use of Local Leaders

Stabroek News Editorial Cartoon, published June 15, 2008

Decision of the Ethnic Relations Commission in the matter of the complaint raised by the IAC with respect to an editorial cartoon and published by the *Stabroek News*, on June 15, 2008, p.6.

The Ethnic Relations Commission acting under Article 212 D of the Constitution of Guyana, considering all the information at its disposal, regarding the said complaint by the IAC, having deliberated on the matter on June 2, 2008, hereby adopts the following conclusions on the matter.

1.0 BACKGROUND:

By correspondence to the ERC dated June 16, 2008, the IAC registered a complaint with the Commission condemning an editorial cartoon in the *Stabroek News* dated June 15, 2008.

1.1 The cartoon visually depicts what appears to be an elderly woman of East Indian extraction, sitting hunch-backed on a stool and wearing an undecorated rumal, traditional accessories and an 'I Love Guyana' badge. She is peeling what seems to be an agricultural product taken from a large wicker basket. A bespectacled man representing the media asks the following:

"How do you feel about a Black man being President..."

After a supposed pause, he continues:

"..er..ahh..of the United States of America..of course!"

The elderly woman responds:

'Oh! The United States!...well...'

2.0 IAC ISSUES:

The IAC raises the following five issues with respect to the cartoon:

- 2.1 The old East Indian woman is portrayed as belonging to a past era historically. The IAC interprets this portrayal to mean that Indo-Guyanese are a backward ethnic group.
- 2.2 Since historically Hindu women have worn the rumal, its depiction in the cartoon is interpreted by the IAC to mean that Hindus are a backward group.

- 2.3 The old East Indian woman is drawn wearing an 'I Love Guyana' sticker badge. The IAC interprets this portrayal to mean that Indo-Guyanese are not inherently patriotic.
- 2.4 The old East Indian woman is drawn in the act of peeling something with her hands. The IAC interprets this portrayal to mean that Indo-Guyanese are technologically backward.
- 2.5 The interviewer is shown in an anxious manner to extract a negative answer to his question: 'How do you feel about a BLACK MAN being PRESIDENT?' The IAC interprets this portrayal to mean that Indo-Guyanese are alarmed at the notion of having an Afro-Guyanese as President of Guyana.
- Generally, it is the IAC's opinion that the cartoon may be considered <u>racially offensive</u> but denigrating to persons of Indo-Guyanese origin as it can stir up feelings of social hostility against Indo-Guyanese by promoting and perpetrating negative stereotypes of Indo-Guyanese.

3.0 **MEDIATION EFFORTS**:

The ERC wrote Guyana Publications Ltd (Stabroek News) seeking a response to the IAC complaint, and received a response from the said media house, outlining their position in a letter dated June 20, 2008.

The ERC has held round table discussions with officials of the IAC and the *Stabroek News*, including separate caucuses with each body, in an attempt to mediate on the complaint that is before the Commission. This has been without success.

4.0 **ERC FINDINGS**:

The Commission has since deliberated on the issues raised by the complainant taking into consideration the art form of cartoons, particularly editorial cartoons, their use in liberal democratic societies and the right to freedom of expression guaranteed under the Constitution of Guyana. The Commission wishes to advise the following:

4.1 That the IAC is correct in that the elderly woman represents an East Indian woman of a past era historically. While there may perhaps be some legitimacy in the argument that is raised here of stereotyping/negative profiling it is important however to note that, generally editorial cartoons are a type of gag cartoon, employing humor, very often with a satirical/ironical content. This genre often employs the use of caricature which is sometimes typified by a grotesque comic representation, exaggerating or distorting perhaps what may seem to be characteristic traits. To infer from the cartoon that the elderly woman is of a backward group, merely because she is portrayed in a historical and traditional mode of attire is assuming a definite intention on the part of the cartoonist which is not substantiated. Therefore, we find the IAC argument on this point cannot be sustained.

- 4.3 That it cannot be reasonably inferred that the wearing of an 'l love Guyana' badge means that that East Indians are unpatriotic, in fact prima facie it seems to expressly state the contrary. However, when one looks at the cartoon in its entirety, it seems that the artist may be employing the use of irony to beg the question as to whether East Indians generally, or East Indians of senior age are patriotic or not in relation to the particular issue he is seeking to raise. If this is indeed the intention of the cartoonist, by itself, and giving due consideration to the usual artistic leverage in a liberal democracy and the genre of cartoon, it does not give rise to the suggestions that there is an intention on the part of the artist or Stabroek News to castigate, to demean or necessarily to be racist or to promote or propagate racism. Editorial cartoons are often used to raise for discussion political and moral issues of a society, and whether such issues are legitimate or not, or uncomfortable, by itself, does not promote racism.
- 4.4 The performance of an act of manual labour as opposed to the use of technology is not necessarily an inference that Indo-Guyanese are 'technologically backward.' The act of peeling is one that is common across all cultures and social groups and the Commission is of the opinion that this is a *non sequitor*.
- The IAC may be correct in its interpretation of the message of the cartoon in that 4.5 it seems that the artist is suggesting that Indo-Guyanese would be alarmed at the notion of having an Afro-Guyanese as president. This may be a legitimate concern in that the cartoon may have unfairly typify/brand one ethnic group exclusively as a racist group which perhaps may inherently be an unfair proposition or false premise that needs to be qualified. However, even if this is the issue of the cartoon, however uncomfortable it is to sit with, by itself, is not sufficient to deem it the intention of the cartoonist/Stabroek News to label East Indians as racists or to promote racism within the society. Again, an editorial cartoon very often illustrates a point of view on current social and/or political topics, whether taboo or not. The intent is almost always invariably to bring about improvement, whether in the way we think, or act, or speak, as the case may be. Indeed this may be one of the partial truths in this society that is perceived to be driven by ethnic politics, polarities and insecurities (which may not be solely limited to East Indians in Guyana). If the message is a positive one albeit and admittedly in a negative context, in that there is a need to address issues of ethnic insecurities in a broad context, then the editorial cartoon may have scored its due points. It is this latter position that the Commission believes is relevant and may have been the intended message by the cartoonist and by Stabroek News.

5.0 **CONCLUSION:**

Conclusively, the cartoon has interestingly brought to the fore a debate that may have a positive impact in the context of race related conversations, debate and dialogue on issues that are topical in a multi-cultural and multi-ethnic society. This debate must take place in a responsible environment having due regard to the ethno-cultural and the ethno-religious sensitivities that exist in Guyana. It also points us to and cautions us on the possible dangers of negative stereotyping and profiling which may be considered prevalent in past and present local theatre, television sitcoms and advertisements.

- 5.1 The ERC has sought to mediate the issue between Stabroek News and the IAC, with a view towards achieving common ground, and a way forward. The Commission wishes to express its disappointment in the cavalier and high handed approach taken by Stabroek News in its conduct at the said meetings. It is rather unfortunate that a statement by Stabroek News clarifying their intention under the subject cartoon was not seen as helpful possibly bridging the divide.
- 5.2 The ERC further expresses its disappointment with the IAC with its *modus operandi* in dealing with the complaint. The IAC should have firstly registered their concerns with the ERC, as opposed to bringing the matter into the public domain, and give the Commission free and full opportunity to resolve the matter.

6.0 RECOMMENDATION:

6.1 Freedom of expression is guaranteed by Article 146, (1) of the Guyana Constitution and is one of the celebrated principles of law. This is not an absolute right however and must be must be practiced in a responsible manner. It is to be noted for instance, that Article 146 (3) of the Constitution for instance, provides that: 'freedom of expression in this Article does not relate to hate speeches or other expression, in whatever form, capable of exciting ill-will against any person or class of persons.' It is therefore an important duty of a publisher/media house to exercise good editorial oversight, sensitivity, prudence and judgment when taking publications to press. At the same time the media operative must ensure that there is not undue censorship.
