Intituled

AN ACT to amend the Drainage and Irrigation Act.

Enacted by the Parliament of Guyana:-

Short title 1. This Act, which amends the Drainage and Irrigation and commencement Act, may be cited as the Drainage and Irrigation (Amendment) This Act, which amends the Drainage and Irrigation Act 1976, and shall be deemed to have come into operation on 1st January 1972.

2. Section 5 of the Principal Act is hereby amended by the substitution of the words "at such remuneration and on such terms and conditions (including the payment of pensions, gratuities or other like benefits by reference to the service of the secretary or servants) as the Board may think fit" for the words "as the Board may deem necessary".

- Section 74 of the Principal Act is hereby amended in the following respects -
 - (a) by the deletion of the word "and" appearing at the end of paragraph (a) of subsection (1);
 - by the relettering of paragraph (b) as paragraph (c) in subsection (1);
 - (c) by the insertion in subsection (1) of the following as paragraph (b) -
 - "(b) at the beginning of each financial year, such sum of money as the Minister may approve for the purpose of providing the Board with funds to meet the payments of any persions, gratuities or other like benefits to be made by the Board under Section 5; and";
 - (d) by the substitution in subsection (3) of the words "in which the advance was made except where the Minister has approved otherwise" for the words "nort following that in which the advance was "next following that in which the advance was made"; and

- (e) by the insertion of the following as subsection (4) —
 - "(4) Any sum of money advanced on loan under sub-section (1) (c) shall be repaid to the Accountant General by the Board during the year next following that in which the advance was made".
- Section 77 of the Principal Act is hereby amended in Amendment the following respects -

 - by the deletion of the word "and" appearing in para-Act. (a)
 - by the renumbering of paragraph (j) and paragraph (b)
 - by the insertion immediately after paragraph (i) of (c) the following as paragraph (j)
 - prescribing the category of servants employed by the Board to be paid pensions, gratuities or other like benefits and the terms and conditions under which such payments are to be made; and".

EXPLANATORY MEMORANDUM

This Bill seeks to amend the Drainage and Irrigation Act to empower the Board to make payments of pensions, gratuities and other like benefits to employees appointed by the Board and to allow the Accountant General to advance on loan to the Board sums of money as may be approved by the Minister for the said purpose.
