## **PROCLAMATION**



By His Excellency SIR DAVID JAMES GARDINER ROSE, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Commander in the Royal Victorian Order, Member of the Most Excellent Order of the British Empire, Governor-General and Commander-in-Chief of Guyana.

WHEREAS it is provided by section 4(2) of the Roads Ordinance, Chapter 277, that the Governor-General may, by Proclamation published in the Gazette, order that any road or any part of any such road mentioned in the schedule to the said Ordinance shall cease to be maintained out of moneys provided by the National Assembly and thereupon the provisions of the said Ordinance shall no longer apply to that road or any part thereof as the case may be;

AND WHEREAS it is expedient that the parts of the roads specified in the schedule hereto shall not be maintained out of moneys provided by the National Assembly;

NOW, THEREFORE, by virtue of the power in me vested by section 4(2) of the Roads Ordinance, Chapter 277, and of all other powers thereunto enabling me, I do hereby order that the parts of the roads specified in the schedule hereto shall cease to be maintained out of moneys provided by the National Assembly.

## SCHEDULE

## BERBICE

West Coast

Parts of Main Road

1. The part of the main road, situate at Plantation Golden Grove, West Coast Berbice, commencing at a point near Station 2918 + 48, on the eastern boundary

of the deviation of the main road and extending for a distance of 0.1426 of a mile to a point near Station 2924 + 52 on the north western boundary of the said deviation and shaded yellow on Plan No. A.R.S. 295/53.

2. The part of the main road, situate between Plantation Brahan (also known as Brahn) and Plantation Kingelly, West Coast, Berbice, commencing at a point near Station 2725 + 66, on the south western boundary of the deviation of the main road and extending for a distance of 0.1174 of a mile to a point near Station 2731 + 75 and shaded yellow on Plan No. A.R.S. 295/47.

## **ESSEQUIBO**

Aroabisci Coast.
Part of Main Road.

The part of the main road, situate at Queenstown, West Coast, Essequibo, commencing at a point near Station 919 + 100, on the western boundary of the deviation of the main road and extending for a distance of 0.37 mile to a point near Station 932 + 69.15 BK = 959 + 81.15 AH, on the western boundary of the said deviation and shaded yellow on Plan No. 294 / 10 and on Plan No. 294 / 11.
