AN ACT to provide for the issue from the Consolidated Fund of the sums necessary to meet the expenditure (not otherwise lawfully charged on the Comsolidated Fund) of Guyana for the fiscal year ending 31<sup>st</sup> December, 2007, estimates whereof have been approved by the National Assembly, and for the appropriation of those sums for the specified purposes, in conformity with the Constitution.

Issue from the Consolidated Fund authorised. No. 20 of 2003.	2. The issue from the Consolidated Fund of such sums, not exceeding in the aggregate the gross of eight billion, six hundred and seventy-nine million, four hundred and twelve thousand, two hundred and fifty-six dollars (\$8,679,412,256), necessary to meet the expenditure of Guyana for the fiscal year ending on 31 <sup>st</sup> December, 2007, is hereby authorized in accordance with Article 219 of the Constitution and Sections 24 and 41 of the Fiscal Management and Accountability Act 2003.
