The issue from the Consolidated Fund of such sums, not exceeding in the aggregate the gross of four billion, eight hundred and forty million, six hundred and thirteen thousand, five hundred and seventy six dollars (\$4,840,613,576), necessary to meet the expenditure of Guyana for the fiscal year ending on 31<sup>st</sup> December, 2008, is hereby authorised in accordance with article 219 of the Constitution and sections 24 and 41 of the Fiscal Management and Accountability Act 2003.
