Enacted by the Parliament of Guyana:-

Short title. Cap. 91:04 1. This Act, which amends the Shops (Consolidation) Act, may be cited as the Shops (Consolidation) (Amendment) Act 2006.

Amendment of section 2 of Principal Act. 2. Section 2 of the Principal Act is amended -

(a) by substituting, in paragraph (a) of the definition of "shop", for the word "premises", the words "licensed premises (as defined by section 2 of the Licensed Premises Act)"; and

(b) by inserting, at the end of the definition of "shop assistant", the words "but does not include any worker (as defined by section 2 of the Labour (Conditions of Employment of Certain Workers) Act 1978)".

EXPLANATORY MEMORANDUM

This Bill seeks to amend the Shops (Consolidation) Act (Cap.91:04).

Clause 1 sets out the short title.

Clause 2 -

- (a) excludes licensed premises (as defined in the Licensed Premises Act) from the definition of "shop" in the Principal Act; and
- (b) excludes workers (as defined in the Labour (Conditions of Employment of Certain Workers) Act 1978) from the definition of "shop assistant" in the Principal Act.

The Licensed Premises Act already regulates licensed premises, while the Labour (Conditions of Employment of Certain Workers) Act 1978 regulates working conditions of "workers" as defined in the latter Act.
