- 1. This Act may be cited as the Assemblies of God (Incorporation) (Amendment) Act 1973, and amends the Assemblies of God (Incorporation) Ordinance, 1958, hereinafter referred to as the Principal Ordinance.

5. Sections 6, 7, 8 and 9 of the Principal Ordinance are hereby repealed and the following section inserted as section 6:-

"Proceedings by or against the Guyana Mission service of process upon the Superintendent or General Secretary upon the Superintendent or General Secretary

of the Council or, if there is no Superintendent or General Secretary, by affixing the process on a conspicuous part of any of the buildings or churches of the Guyana Mission situate in the City of Georgetown, shall be good and sufficient service."

- (a) by the substitution of the word "Council" for the words "General Council" wherever they appear;
- (b) by renumbering sections 10 and 11 as sections 7 and 8, respectively.

EXPLANATORY MEMORANDUM

Under the provisions of the Assemblies of God (Incorporation) Ordinance, 1958, the General Council of the Assemblies of God in Springfield, Missouri, is the body through which and by whose officers the Assemblies of God in Guyana are a body corporate. It has been decided that the controlling authority for the body should be in Guyana, that the officers constituting the body corporate should be members of the Assemblies of God in Guyana and that the body in Springfield, Missouri, should no longer control the Mission in Guyana. This Bill seeks to provide for these changes.
