| Citation, | 1. These By-laws may be cited as the Rose Hall Town Council (Reward and Poundage Money) By-laws 1989. |
| Establishment of pound at Rose Hall Town, | 2. A pound is hereby established at Lot 38, 1st Street, Swamp Sect., Rose Hall Town. |
| Stray animals
Schedule | 3. Where any animal specified in the first column of the Schedule strays on private property situated within the council area of the Rose Hall Town Council, any owner or occupier of such property or any person authorised in writing by such owner or occupier, who detains and take such animal to the Rose Hall Town Council Pound, shall receive from the pound-keeper thereof by way of reward, the sum set out in the second column of the Schedule in relation to the animal specified in the first column. |
| Impounded animal, | 4. The pound-keeper shall, before delivering an animal impounded in the Rose Hall Town Council Pound, demand and receive from the person claiming the animal — |
| Schedule | (a) the poundage set out in the third column of the Schedule in relation to the animal specified in the first column. |
| Schedule | (b) the sum for feeding the animal set out in the fourth column of the Schedule in relation to the animal specified in the first column. |

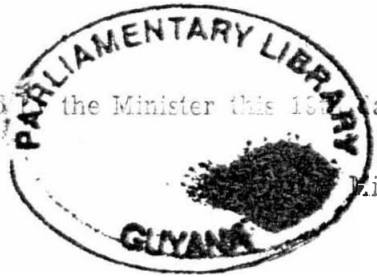
