THE CONSUMPTION TAX ACT

(Chapter 80:02)

IN EXERCISE OF THE POWER CONFERRED UPON THE MINISTER UNDER SECTION 4 OF THE CONSUMPTION TAX ACT, I HEREBY ORDER AS FOLLOWS:-

1. This Order, which amends the Consumption Tax Order*, may be cited as the Consumption Tax (Amendment) Order 1978. Citation.
2. The Schedule to the Principal Order is hereby amended by the substitution for the particulars appearing in the column headed "Rate of Tax" against the respective Statistical Classification Numbers mentioned in the Schedule to this Order, of the particulars appearing in the column of like heading in that Schedule.
