THE CONSUMPTION TAX ACT, 1969

(No. 13 of 1969)

UNDER SECTION 4 OF THE CONSUMPTION TAX ACT, 1969, I HEREBY MAKE THE FOLLOWING ORDER:—

- 1. This Order which amends the Consumption Tax (Amendment) Order 1973* may be cited as the Consumption Tax (Amendment) (No. 3) Order, 1973.
