THE CONSUMPTION TAX ACT

(Chapter 80:02)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 4 OF THE CONSUMPTION TAX ACT, I HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order may be cited as the Consumption Tax Order 1974.
2. During the continuance in force of this Order tax shall be payable on the goods specified in the First Schedule at the respective rate so specified, other than on goods exempt from duties of customs or excise under any law.
3. The references in the First Schedule to Tariff Heading Numbers and Statistical Classification Numbers are to those numbers as are prescribed in Part 1 of the First Schedule to the Customs Act. The prefix "Ex" to those numbers indicates that the goods therein described comprise only part of the items covered by those classification numbers in that Part of the Customs Act.
4. The Orders specified in the Second Schedule are revoked.
