THE SUGAR LEVY ACT 1974
(No. 22)

UNDER SECTION 7 OF THE SUGAR LEVY ACT 1974, THE FOLLOWING
REGULATIONS HAVE BEEN MADE BY THE MINISTER:—

1. These Regulations may be cited as the Sugar Levy Regulations 1974.
2. A provisional return and a final return to be submitted by an exporter of sugar under section 5 of the Act shall be in Forms A and B, respectively, in the Schedule.
3. In determining the amount of the levy to be shown on a final return as payable in respect of any exportation of sugar no less quantity of sugar and degree of polarisation thereof, as stated in the provisional return relating to the exportation, shall be used for the purposes of such determination.
4. Regulations 4 to 8 (inclusive) of the Customs Regulations* shall, for the purpose of the submission of forms in respect of the sugar levy, apply *mutatis mutandis* to an exporter of sugar as they apply for the purpose of the submission of forms in respect of duties of customs.
