AND IN EXERCISE OF ALL OTHER POWERS ENABLING HIM IN THAT BEHAIF, IT

HEREBY ORDERED BY THE GOVERNOR-GENERAL AS FOLLOWS:-

- 1.(1) This Order may be cited as the Rates of Postage Order, 1967.
 - (2) This Order shall come into operation on the 1st March, 1967.
- 2. The rates of postage to be paid in respect of the communications and postal packets specified in the first column of the first schedule hereto for transmission by surface mail to places within Guyana shall be those set out in the second column of that schedule, the rates of postage when such communications and postal packets are addressed to places within the Commonwealth excluding Guyana, territories under British Trusteeship and British Post Offices in the Persian Gulf shall be those specified in the third column of the said schedule and the rates of postage when such communications and postal packets are addressed to places elsewhere shall be those specified in the fourth column of that schedule.
- 3. The fees to be paid for the services specified in the first column of the second schedule shall be those set out in the second column of that schedule.
- 4. Order in Council No. 47 of 1950 made on the 29th day of December, 1950, and Order in Council No. 10 of 1960 as amended by the Rates of Postage Order, 1965, are hereby revoked.
