

ORDER
 Made Under
THE CONSUMPTION TAX ACT, 1969.
 (No. 13 of 1969)

UNDER SECTION 4 OF THE CONSUMPTION TAX ACT, 1969, AND BY VIRTUE AND IN EXERCISE OF ALL OTHER POWERS ENABLING HIM IN THAT BEHALF, IT IS HEREBY ORDERED BY THE MINISTER RESPONSIBLE FOR FINANCE AS FOLLOWS:—

1. This Order may be cited as the Consumption Tax (Petroleum) (Amendment) (No. 2) Order, 1969 and shall be deemed to have had effect on the coming into operation of the Consumption Tax (Petroleum) Order, 1969*, hereinafter referred to as the Principal Order, and all amendments thereto.

2. Paragraph 2 of the Principal Order is hereby amended by the insertion of the brackets and words "(other than goods entitled under any law to be exempt from customs duty)" immediately after the words "chargeable goods".

3. The rate of tax specified in the third column of the schedule to the Principal Order, in relation to the imported chargeable goods of the respective item number mentioned in the second and first columns, respectively, of the schedule to this Order, shall, for the period 1st May, 1969 to 3rd July, 1969, (inclusive) be construed as if there were substituted for such rate of tax, the rate of tax respectively set out against such goods and item number in the third column of the last mentioned schedule.
