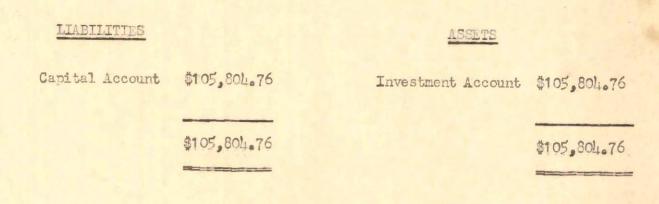

The Administrators of the Trotman Trust Fund have the honour to submit the following report on the working of the Fund for the year 1957.

At the beginning of the year there were eight male pensioners on the Trotman Fund and two male pensioners on the Frankland Fund while there were eleven female pensioners on the Trotman Fund, making a total of twenty-one pensioners. In May, 1957, Mr. C.A.Ouckama died and in March, 1957, Mr. G.M.Taylor died. There are now two vacencies on the Fund. For nearly 22 years Mary Grantham has been a pensioner of the Fund while for about 18 years Mr. G. S. Elphage has been on the Fund.

The income received in 1955 and 1956 exceeded the pension paid out in the vicinity of \$1200 per annum so that with effect from the 1st January, 1957, it was decided to increase the pension to each pensioner by \$2.50 per month. The increased pension received by male pensioners on The Trotman Fund being \$17.50, female pensioners being \$10.00 each and male pensioners on the Frankland Fund being \$10.00 each.

The total revenue for the year amounted to \$3,924.65. Six per cent of this amount - \$235.47was reserved for administration expenses leaving the sum of \$3,689.18 to be paid out as pension. The amount actually paid out to pensioners during the year was \$2960.00.

The Administrators of the Trotman Trust Fund have the honour to submit the following report on the working of the Fund for the year 1958.

The total revenue for the year amounted to \$5,613.08. Six per cent of this amount - \$336.78 - was reserved for administration expenses leaving the sum of \$5276.30 to be paid out as pension. The amount actually paid out to pensioners during the year was \$2862.50.

At the beginning of the year there were:

- (a) Six (6) male pensioners on the Trotman Fund and two vacancies; one of the vacancies was filled with effect from 1st October, 1958 by the admission of Mr. GEORGE HARES into the Fund;
- (b) Two (2) male pensioners on the Frankland Fund;
- (c) Eleven (11) female pensioners on the Trotman Fund. On the 21st November, 1958 a pensioner, Mrs. Ellen McLean died; there is therefore one vacancy.
