BRITISH GUIANA

ORDER

MADE UNDER
THE CUSTOMS ORDINANCE,
(Chapter 309).

UNDER SECTION 8 OF THE CUSTOMS ORDINANCE AND BY VIRTUE AND IN EXERCISE OF ALL OTHER POWERS ENABLING HIM IN THAT BEHALF, IT IS HEREBY ORDERED BY THE GOVERNOR AS FOLLOWS :—

- 1. This Order may be cited as the Customs (Amendment) Order, 1965.
- 2. Part 111 of the First Schedule to the Customs Ordinance is hereby amended in the following respects —

- (a) by renumbering sub-item (4) of item 12 as sub-item (5);
- (b) by the insertion after the words "other than" in the third line of the renumbered sub-item (5), of the words and comma "the Federal Republic of Germany,";
- (c) by the insertion of the following sub-item as sub-item (4)—
 "(4) Goods imported on first arrival or at any time during his official residence by a consular officer or consular employee of the Consulate of the Federal Republic of Germany, for his personal use or the personal use of members of his family forming part of his household:
 Provided that —
 (i) he is a citizen of the Federal Republic of Germany;
 (ii) he is a permanent employee of the Government of the Federal Republic of Germany and is not engaged in any private occupation for gain within British Guiana, and
 (iii) his appointment as a consular officer or consular employee of the Consulate of the Federal Republic of Germany has been duly notified to the Government of British Guiana.";
- (d) by the addition immediately after item 48 of the following item—

"Representatives of Commonwealth Countries (other than Trade Commissions).

48A. (1) Goods imported for the official use of any representative in British Guiana (other than a representative to whom item 48 of this Part applies) of any country in the Commonwealth or of the Republic of Ireland.

(2) Goods imported on first arrival or at any time during his official residence by any such representative, or by such member of his official staff as may be approved by the Governor, for his personal use or the personal use of his family forming part of his household:

ORDER

Provided that —

- (i) he is a citizen of any such country in the Commonwealth or of the Republic of Ireland;
- (ii) he is a permanent employee of the Government of any such country in the Commonwealth or of the Republic of Ireland and is not engaged in any private occupation for gain within British Guiana; and
- (iii) his appointment as such representative or as a member of the official staff of such representative has been duly notified to the Government of British Guiana."

(1) In a resolution of the Council of the Government of British Guiana passed on the 18th day of February 1965, the following provisions were made:

(2) Goods imported on first arrival or at any time during his official residence by any such representative, or by such member of his official staff as may be approved by the Governor, for his personal use or the personal use of his family forming part of his household:

(3) Provided that —

(i) he is a citizen of any such country in the Commonwealth or of the Republic of Ireland;

(ii) he is a permanent employee of the Government of any such country in the Commonwealth or of the Republic of Ireland and is not engaged in any private occupation for gain within British Guiana; and

(iii) his appointment as such representative or as a member of the official staff of such representative has been duly notified to the Government of British Guiana."

(4) The Governor is hereby ordered to give effect to the above provisions.
