- UNDER PARAGRAPH (c) OF SECTION 23 OF THE ELECTORAL PRO-VISIONS (REGISTRATION) ORDINANCE, 1961, IN ACCORDANCE WITH ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA, AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF, THE FOLLOWING REGULATIONS HAVE, BEEN MADE BY THE GOVERNOR:—
- 1. These Regulations may be cited as the Electoral Provisions (Registration) / Regulations, 1962.
- 2. Rule 11 of the Rules is hereby amended by the substitution for the word "tenth" appearing therein of the word "seventeenth".
- 3. Rule 12 of the Rules is hereby amended by the substitution for the word "eleventh" appearing therein of the word "twenty-fifth".
- 4. The form in these Regulations is hereby substituted for Form No. 7 in the second schedule to the Electoral Provisions (Registration) Ordinance, 1961.
