REPORT OF THE SPECIAL SELECT COMMITTEE OF THE NATIONAL ASSEMBLY ON THE AUDIT BILL 2004.

Publication of Bill

The Audit Bill 2004, which was published on Thursday, 11th March 2004, sets out the responsibilities and authority of the Auditor General, strengthens Parliamentary oversight over the work of the Auditor General, provides for the establishment and administration of an independent Audit Office and regulates such other matters connected with or incidental to the independent auditing of the finances of Guyana.

Introduction and First Reading in the National Assembly

2. The Bill was introduced in the National Assembly and read the first time on Monday, 15th March, 2004.

Debate and Second Reading in the National Assembly

3. The Bill was debated in the National Assembly and was read the second time on 19th March, 2004.

Committal to Select Committee

4. Following its second reading the Bill was committed by the National Assembly for consideration by a Special Select Committee.

8. Clauses 1 to 16 were agreed to as printed.

9. **Clause 17**

The following amendment was made to subsection (2) of the clause:-

For the words "emoluments at" substitute the words "emoluments on the date immediately preceding".

10. Clauses 18 to 38 were agreed to as printed.

11. Clause 39

The following amendment was made to the clause -

For the words "four hundred thousand" substitute the words "one million".

Report of the Select Committee

12. At its meeting on 13th April, 2004 the Special Select Committee on the Audit Bill agreed that this Report on the Bill should be presented to the National Assembly.

13. The Report is accordingly hereby submitted to the National Assembly for adoption.
