## REPORT OF THE SPECIAL SELECT COMMITTEE OF THE NATIONAL ASSEMBLY ON THE SMALL BUSINESS BILL 2003.

### **Publication of Bill**

The Small Business Bill 2003, which provides for an incentive regime and support programme for small businesses; the establishment of the Small Business Council, the Small Business Bureau, the Small Business Development Fund and for matters connected therewith and incidental thereto, was published on Wednesday, 30<sup>th</sup> July, 2003.

#### Introduction and First Reading in the National Assembly

 The Bill was introduced in the National Assembly and read the first time on 4<sup>th</sup> August, 2003.

## Debate and Second Reading in the National Assembly

 The Bill was debated in the National Assembly and was read the second time on 18th August, 2003.

## **Committal to Select Committee**

4. Following its second reading the Bill was committed by the Assembly for consideration by a Special Select Committee.

#### 12. Clause 12

The following amendment was made:-

Substitution of the following for the clause

<ol><li>A small business shall be</li></ol>
eligible for every applicable fiscal incentive under the law.".

13. Clause 12 was agreed to as amended.

14. Clause 13 was agreed to as printed.

#### **Report of the Select Committee**

15. At its meeting on 3rd March, 2004 the Special Select Committee on the Bill agreed that this Report on the Bill should be presented to the National Assembly.

16. The Report is accordingly hereby submitted to the National Assembly for adoption.
