Report of the Clerk of the National Assembly on the Selection of Nominees for Membership of the Ethnic Relations Commission

1. INVITATION TO ENTITIES TO NOMINATE MEMBERS TO THE ETHNIC RELATIONS COMMISSION

Article 212A of the Constitution has established an Ethnic Relations Commission with article 212 B(1) providing for its composition.

On 11th December, 2000, the National Assembly of the First Session (1998 - 2000) of the Seventh Parliament of Guyana passed Resolution No. 62 which -

- (i) determined the entities to nominate members of the Ethnic Relations Commission in accordance with article 212 B (1) (a) of the Constitution,
- (ii) set out the number of nominees for each group of entities,
- (iii) determined the consensual mechanism for the nomination of members by each group and,
- (iv) assigned the Clerk of the National Assembly the task of inviting entities in each group to select a nominee (and substitute) for the Membership of the Ethnic Relations Commission.

Acting in accordance with paragraph 1 of the Second Schedule of Resolution 62 (see Appendix 1) my predecessor in office on 8th March, 2002 addressed letters to -

- (i) the following umbrella organisations:
 - (a) The Chairman of the Guyana Council of Churches as the recognised "umbrella organisation" for the Christian Bodies; a copy of that letter was forwarded to each of the constituent entities,

- (b) The Secretary General of the Guyana Trades Union Congress as the recognised "umbrella organisation" for the Trade Unions in Guyana; a copy of that letter was forwarded to each of the constituent entities,
- (c) The Chairman, Private Sector Commission as the recognised "umbrella organisation" for the Private Sector Bodies; a copy of that letter was forwarded to each of the constituent entities.
- (ii) the following organisations as coordinators -
 - (a) the Chairperson of the National Commission on Women requesting her Commission to act as a coordinator of the Women's Bodles for the selection purpose; a copy of the letter was forwarded to each of the Women's bodies, and
 - (b) the Chairman of the National Youth Commission requesting his Commission to act as a coordinator of **Youth Bodies** for the purpose of the selection; a copy of letter was forwarded to each of the youth bodies.
- (iii) each of the constituents of the undermentioned groups of entities -
 - (a) Islamic -

The Central Islamic Organisation of Guyana, Guyana Islamic Trust, Guyana United Sadr Islamic Anjuman, Anjuman Hifazutal Islamic Organisation, and Hijatul Ulamaa

2. **RESPONSE TO INVITATION**

Friday, 12th April, 2002, was the deadline set by which time formal notification of particulars of the nominees, the process/procedure used for the selection of the nominees and other particulars as set out in the Second Schedule to Resolution No. 62 should be submitted.

The Guyana Council of Churches, the recognised umbrella organisation of the Christian Churches, formally submitted its notification of the selection of the nominee and substitute of the Christian Bodies on 8th April, 2002.

The Chairman of the National Youth Commission reported on 8th April, 2002 as follows:

"... Correspondence from you dated on the 11th March 2002 indicated that all youth groups listed in the Second Schedule was written to by you. In that correspondence these groups was asked to contact me so that arrangements can be put in place for a meeting, and subsequent nomination of the youth representative and his/her alternate. Unfortunately to date only three organisations have contacted me, and efforts made by my office to contact the others have not been productive.

In light of this your advice is sought on whether to proceed with a meeting of those who have indicated an interest. I will also like to know whether parliament would provide any assistance in order to convene this meeting

In my reply dated 21st April, 2002 to the Chairman of the National Youth Commission I said in part:

"... With reference to your enquiry about assistance to convene a meeting, I regret to inform you that Parliament Office does not have the resources to place at the disposal of the Commission on Youth to enable it to proceed with the required nominations.

However, may I suggest that you bring this matter to the attention of the Permanent Secretary, Ministry of Culture, Youth and Sport and solicit from him the requisite assistance that will enable your Commission to convene a meeting to determine a nominee and one substitute for membership of the Ethnic Relations Commission.

It may be prudent for invitations to be extended to all youth bodies named in the First Schedule to Resolution No. 62 to attend the meeting convened for the nomination process. In this circumstance, no one will be in a position of accusing the National Youth Commission in being selective in its approach to the process. ..."

Apart from the above two organisations no nomination or report was received from the other groups of entities by the deadline. However, some members within the various bodies of the group of entities erroneously embarked on nominations of their own which were submitted to me.

It is pertinent to bring to the attention of the National Assembly the following letter dated 14th March, 2002 from the National Spiritual Assembly of the Bahai's of Guyana:

"Dear Sir,

)

We wish to acknowledge with thanks your letters of 11 March regarding nomination of a member to the Ethnic Relations Commission. We appreciate the inclusion of the Baha'i Faith in arrangements for the establishment of this Commission.

We wish to point out, with respect, that the Baha'i Faith is an independent religion and does not fall within the grouping of the various Christian bodies. The National Spiritual Assembly of the Baha'is of Guyana was incorporated by act of Parliament passed on 9 December 1976. The Faith is unified and has no factions: it has its own divinely revealed Book of Laws - The Kitab-i-Aqdas. It is our view that in the circumstances the Faith should be allowed the same privilege as each other religious grouping.

Sincerely, Sgd. Hazel Griffith Secretary".

The reply to this letter dated 19th March, 2002 was as follows:

"Dear Ms Griffith

Thank you for your letter dated 14th March, 2002 informing me that the Baha'i Faith is an independent religion and does not fall within the grouping of the various Christian bodies.

The intent of the National Assembly was to take into consideration only the three major groups of religious bodies - Christians, Hindus and Muslims. Its placing the Baha'i Faith within the Christian grouping was certainly an error. I can assure you that this action was not meant to embarrass or insult your Faith. The inclusion of the Baha'i Faith in the Resolution is evident of the high esteem accorded it by the National Assembly.

By a copy of this letter, I am bringing your letter to the attention of the Honourable Minister of Parliamentary Affairs and the Chairman of the Guyana Council of Churches.

Yours sincerely, Sgd. Maurice B. Henry for Clerk of the National Assembly". Many oral reminders were made and, eventually, written reminders dated 31 July 2002 were sent to the groups of entities with outstanding nominations to hasten the process. This was partly successful with responses received from:

- (i) The Central Islamic Organisation of Guyana on behalf of the Muslim Religious Bodies - dated August 3, 2002;
- (ii) The Private Sector Commission of Guyana Limited for the Private Sector Bodies dated 15th August, 2002;
- (iii) Guyana Hindu Dharmic Sabha for Hindu Religious Bodies dated October 18, 2002;
- (iv) National Youth Commission for Youth Organisations dated 20th November, 2002
- (v) National Commission on Women for Women Bodies undated.

At the time of preparing this Report the Guyana Trades Union Congress has failed to respond.

SEVENTH PARLIAMENT OF GUYANA

FIRST SESSION (1998-2000)

NATIONAL ASSEMBLY

RESOLUTION NO. 62

WHEREAS article 212A of the Constitution has established an Ethnic Relations Commission;

AND WHEREAS in accordance with article 212B(1) of the Constitution, the Ethnic Relations Commission shall consist of -

- (a) not less than five nor more than fifteen members nominated by entities, by a consensual mechanism determined by the National Assembly, including entities, representative of religious bodies, the labour movement, the private business sector, youth and women, after the entities are determined by the votes of not less than two-thirds of all elected members of the National Assembly;
- (b) a member who shall be a nominee, without the right to vote, chosen by and from each of the following commissions to be established under this Constitution, Indigenous People's Commission, Women and Gender Equality Commission, Commission for the Rights of the Child and Human Rights Commission;

NOW, THEREFORE, BE IT RESOLVED:

That this National Assembly determines the entities to nominate members of the Ethnic Relations commission, in accordance with article 212B(1)(a) of the Constitution, to be as set out in the First Schedule attached;

AND BE IT FURTHER RESOLVED:

That the number of nominees for each group of entities be as follows:-

SECOND SCHEDULE

Consensual Mechanism for the Nomination by Entities of Members of the Ethnic Relations commission.

All the Entities in each Group, immediately on the passage of this motion, should be written to by the Clerk of the national Assembly inviting them to meet, on a day/date, time and place to be agreed by them, to determine their Nominee (and one substitute who would replace the Nominee on the Ethnic Relations Commission in the event that the Nominee is no longer able to function) for Membership of the Ethnic relations Commission. Where there is a recognised "umbrella organisation" for the Group, the Clerk should write to that organisation and copy his letter to each of the "constituent entities" within the Group.

The Nominee and Substitute chosen by the group must be persons who are competent to contribute positively to the work of the commission and who are committed to ensuring that it discharges all of its functions. They should have earned public respect and be of unquestioned and unblemished honesty and integrity.

The "process/procedure" used must be demonstrated to be unbiased and transparent. It is important that the Nominee and Substitute obtain the unquestioned support and acceptance of the Entity nominating them as well as the Entities within the Group.

A deadline should be set by the Clerk of the National Assembly by which time he would be formally notified of: the names and other requested particulars of the Nominee; the number of Entities within the Group which were "properly" represented when the Nominee was selected; and a "statement" to the effect that the Nominee is supported and accepted by the majority of Entities within the Group.

Dear Sir,

Prior to March 19, 2002 invitations were issued by telephone to representatives of the six Christian groups as listed on your schedule to attend a meeting hosted by Bishop Dr. Juan A. Edghill, Chairman of the Guyana Council of Churches at the Guyana Council of Churches temporary office, 26 Durban Street Lodge, Georgetown Guyana. The purpose of that meeting was to decide on the process / procedure for the nomination of the Christian Nominee and Substitute to the Ethnic Relations Commission.

The attendees at that meeting were the following: Guyana Evangelical Fellowship, Guyana Conference of Seventh Day Adventists, The Guyana United Apostolic Mystical Council and Guyana Council of Churches. There were two absentees namely: the National Assembly of the Bahai's of Guyana and The Jewish Orthodox Church (Apostolic Faith).

The Guyana Conference of Seventh Day Adventists indicated at this meeting that they will not be submitting a nominee but will support a nominee submitted.

At this forum there was a consensus on the process/ procedure for the nomination. Outlined is the process:

- The returning officer was selected, namely Pastor Hubert Jack of the Guyana Conference of Seventh Day Adventists.
- The date of March 27, 2002 was set for the various groups to submit the names of their nominees and substitutes.
- The names of the nominees and substitutes were to be submitted to the temporary office of the Guyana Council of Churches by 11:00 hours on March 27, 2002 to the returning officer.
- Wednesday April 3, 2002 was set for voting on the nominees and the substitute.
- The time was set for 17:00 hours at the office of the Guyana Council of Churches 274 West Ruinveldt Front Road.
- Representatives of all twenty -five denominations as listed on the schedule from Parliament office is to attend and has only one vote.
- > Voting will be done by secret ballot.

However at 11:00 hours on March 27, 2002 only three respondents had submitted nominees namely: Guyana Conference of Seventh Day Adventists, The Guyana United Apostolic Mystical Council and the Guyana Council of Churches. The time was extended to 12:00 hours by the returning officer. Attempts were made by telephone during the extended period to contact the groups who had not yet submitted their nominees. A copy of a letter was received from the Spiritual Assembly of the Bahai's indicating their position (same letter was sent to the Clerk of the National Assembly). At the close of the nominations the submissions remained the same.

The nominees were Bishop Dr. Juan Anthony Edghill and retired Chief Justice Randolph Harper with the substitute being Pastor Roy Thakurdyal.

These nominees were communicated to the five Christian groups who were expected to have representatives present on April 3, 2002 meeting to vote for the representative and substitute.

On Wednesday April 3, 2002 only thirteen denominations were present namely: Ethiopian Orthodox, Roman Catholic, Christian Brethren Mission, African Methodist Episcopalian (Zion), Moravians, District Centre Church of the Nazarene, Full Gospel Fellowship, Assemblies of God in Guyana, Wesleyian Church, African Methodist Episcopalian, Guyana Conference of Seventh day Adventists, Outreach Ministries International and the Guyana United Apostolic Mystical Council although all twenty five were contacted via telephone on Tuesday April 2, and Wednesday April 3, 2002. Messages were left for persons who were not spoken to directly.

Two denominations namely The Methodist Church in Guyana and The Lutheran Church of Guyana indicated by letter their inability to attend the meeting but indicated their votes in favour of Bishop Dr. Juan Anthony Edghill representative and Pastor Roy Thakurdyal as the substitute.

All thirteen denominations present were eligible to vote the result after the casting of the ballots were:

- Bishop Dr. Juan A. Edghill nine (9) votes by secret ballot
- Mr. Rudolph Harper (1) vote by secret ballot.
- Three (3) votes were recorded as spoilt. (nothing was submitted on the ballot paper).
- Pastor Roy Thakurdyal was the only nominee for the substitute representative.

The ballots were counted in the presence of all present with Rev. Gordon Hamlet and Mr. Patrick Benjamin witnessing the count.

The results of the process showed that eleven votes were cast in favor of Bishop Dr. Juan A. Edghill and one in favor of Mr. Rudolph Harper. This showed that Bishop Dr. Juan A. Edghill is the Christian Representative to the Ethnic Relations Commission with Pastor Roy Thakurdyal being the person elected as the substitute representative.

As the Returning Officer for the process I submit to you the Clerk of the National Assembly the procedure and the results of the process. Bishop Dr. Juan A. Edghill has been elected the Christian Representative and Pastor Roy Thakurdyal the Substitute Representative of the Ethnic Relations Commission.



RESOLUTION

100th Anniversary of the Formation of the Pan American Health Organisation Presented by Hon. Dr. Leslie Ramsammy, M.P., Minister of Health

Pan American Health Organisation is celebrating its 100th Anniversary December 2nd, 2002. The Minister of Health is requesting the National Assembly to approve the following as part of Guyana's acknowledgement of the role of the Pan American Health Organisation (PAHO) in Public Health in the Americas and in Guyana.

Resolution

Recognizing that the Pan American Health Organisation (PAHO) is the oldest international health organisation in the world, serving the interests and needs of the people of the Americas and that it has served as a precursor to the formation of the World Health Organisation (WHO) in 1949 and serve as its Americas Bureau.

Acknowledging the leadership that the Pan American Health Organisation has demonstrated throughout the region of the Americas and in general to the world, and in particular, in Guyana, its role in reducing the transmission of vector borne illnesses in the nineteen fifties and sixties, eradication of small pox, wild polio virus transmission and the practical elimination of measles from Guyana and the English – speaking Caribbean and its assistance in controlling rubella in Guyana.

Acknowledging further role of Pan American Health Organisation (PAHO) in promoting a successful immunization and vaccination program, leading to elimination and control of several infectious diseases.

Bearing in mind the significant role the Pan American Health Organisation has played in promoting south – south technical cooperation in health through such modalities as the Caribbean Cooperation in Health Initiative of which Guyana has been a significant beneficiary and its important role in the elimination of filariasis by 2010 in Guyana.

Considering that its specialized technical centers have built regional capacities and supported the governments' and people desire to achieve better health and recognizing especially the role of CAREC in elevating the status of regional disease surveillance efforts, especially in the HIV/AIDS, and laboratory strengthening, particularly in the area of blood banking, CFNI through their strategies in reducing the incidence of nutritional disorder and promoting healthy lifestyles and more recently the role of Panaftoza in supporting Guyana's successful efforts in attaining foot and mouth free status;

In the light of health sector reform being a formidable role – played by PAHO in advocating for and elevating the status of essential public health functions and promoting cross – sectoral collaboration for a Shared Agenda for Health in the Americas.

And in tribute to the committed and high quality work and leadership of Sir George Alleyen, Director of Pan American Health Organisation and Dr. Ciro de Quadros of the Immunization Program, both of them retired this year.

Resolves to:

- 1. Congratulate the secretariat on the attainment of the centenary of the formation the Sanitary Bureau;
- 2. Congratulate the bureau on the achievements which it along with the countries have achieved in the past one hundred years and the leadership in sanitary affairs demonstrated to the rest of the world;
- 3. Encourage the further strengthening of the key principles of the Organisation of equity and Pan Americanism;
- 4. Support the aims and aspirations of the smaller states of the Caribbean including Guyana in health matters, through enhanced technical cooperation and the strengthening of the regional centers CAREC and CFNI.
