

**REPORT OF THE DIRECTORS
OF THE
DEPENDANTS' PENSION FUND
FOR THE YEAR 1989**

1. In accordance with Section 16 of the Dependants' Pension Fund Act, Chapter 27:08 the Directors of the Dependants' Pension Fund have the honour to report on the management and operations of the Fund for the year 1989.

BOARD OF DIRECTORS

2. By virtue of Section 11(1) of the Act, the Accountant General is ex-officio a Director and Chairman of the Board of Directors of the Fund. The other members were appointed from the following:-
 - (a) two persons, who, in the minister's opinion, are qualified for appointment by reason of their experience of and shown capacity in matters relating to the functions of the Board of Directors;
 - (b) three persons, who, in the Minister's opinion, respectively represent the following trade unions:-
 - (i) the Guyana Public Service Union
 - (ii) the Guyana Teachers' Union; and
 - (iii) the Guyana Trades Union Congress; and
 - (c) one person, who, in the Minister's opinion, represents the Police Association.

The persons who functioned during the year were:-

CURRENT CONTRIBUTORS

3. The number of contributors at the end of 1988 was thirty one thousand five hundred and seventy-two. During the year, four hundred and ninety-eight new contributors were admitted, eighty-nine died, and one hundred and twenty-one ceased to contribute for various reasons and retained no interest and twenty-one ceased to contribute and retained an interest in the Fund. The number of contributors at the end of 1989 was thirty-one thousand eight hundred and thirty-nine.

FORMER CONTRIBUTORS WITH INTEREST

4. Sixteen of the former contributors who have ceased to contribute and retained an interest in the Fund died and twenty-one were added making a total of six thousand and twenty-four at the end of the year as compared with six thousand and nineteen at the end of 1988.

REJECTED OFFICERS

5. There were no new Rejected Officers during the year. The number of accounts on the Register of Rejected Officers was thirty-two at the end of the year, all of whom ceased contributing, but retained an interest.

PENSIONERS

6. Fifty-four pensioners were added to the Register of Pensioners while there were eleven deaths during the year thereby realising a total of one thousand two hundred and twenty-four pensioners on the Register of the Fund at the end of 1989 as compared with one thousand one hundred and eighty-one for 1988.

INCOME AND EXPENDITURE

8. The total income reflected in the accounts of the Fund during the year amounted to \$27,249,060.00 or \$10,647,554.00 more than in the preceding year. After meeting expenses and other charges amounting to \$4,760,558.00 the surplus of income over expenditure was \$22,488,502.00 as compared with \$13,255,143.00 in 1988, an increase of \$9,233,359.00.
9. Interest earned on investments during the year was \$1,212,278.00. There was no need for a Government's contribution under Section 3(2) of the Act to ensure a return of six per cent per annum on the cost price of investments as the rate of return on Investments exceeded six percent. A sum of \$11,939,774.00 was receivable from Government in respect of interest on the monthly balances held on deposit by the Accountant General on behalf of the Fund. The interest rate thereon was 35% throughout the year. Interest on Mortgages was \$7,407,493.00.
10. Contributions increased by \$627,115.00 against the 1988 figure to \$6,202,916.00 for the year. Government's 1% contributions in respect of the disciplined services as required by Section 20(c) of the Act was \$486,599.00 as compared to \$375,426.00 in 1988.

11. Refund of contributions amounted to \$283,101.00 mainly in respect of bachelor contributors who resigned their appointments, died, were transferred from the Public Service and those not liable to contribute. The amounts refunded in 1988 were \$310,835.
12. Pensions paid and payable was \$2,124,614.00 at the end of 1989 as compared with \$1,765,939.00 at the end of 1988. The other charges against Revenue are shown on the table hereunder.

14. The aggregate administration and general expenses along with other operating expenses showed an increase over the figures of 1988.
15. The Investments held on behalf of the Fund amounted to \$17,283,039.00 at the end of the year. The Mean Market value was \$16,734,936.00 a sum of \$548,103.00 below ledger value. The value of the Securities of the Guyana Government and Other Investments including Mortgages totalled \$79,794,770.00 representing 62.88% of the total assets of the Fund. In addition the Accountant General held a net sum of \$35,216,476.00 at the end of 1989 on behalf of the Fund.

MORTGAGES

16. One hundred and twenty-four Mortgage Loans were approved during the year totalling \$5,692,392.00. The following is a table of applications received and Mortgages executed for the four previous years.

The amount outstanding (including interest) as at 31.12.89 was \$62,511,731.00.

The rate of interest for the period January to June remained at 8%. In July the interest rate increased to 14% for amounts borrowed up to \$50,000.00 and 21% for amounts borrowed in excess of \$50,000.00.

The lending limit increased to \$100,000.00 per applicant.

Some of the mortgages executed in 1989 were in respect of applications received prior to 1988.

18. **(a) DEBTORS**

The balances reflected under this account were due mainly to officers leaving their employment for various reasons and the relevant information was not received by the Fund on time so that the necessary adjustments can be affected.

(b) CREDITORS

The balances under this account were due to inadequate and in most cases no information being received from various Ministries / Departments / Regions in respect of new contributors as set out in circulars sent by Secretary to the Treasury and Accountant General respectively.

As a result, deductions were made from persons not liable to contribute and in cases where persons were liable, the necessary information for the purpose of registering officers as contributors were not submitted on a timely basis to facilitate allocation of contributions.

COST OF LIVING ALLOWANCE

19. The amount paid during 1989 in respect of Cost of Living Allowances to pensioners of the Fund was \$13,557.31.

**REPORT OF THE AUDITOR GENERAL
TO THE MEMBERS OF THE BOARD
OF THE DEPENDANTS' PENSION FUND
ON THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 DECEMBER 1989**

I have audited the financial statements of the Dependants' Pension Fund for the year ended 31 December, 1989 as set out on the following pages. These statements have been prepared under the historical cost convention as modified by the revaluation of certain fixed assets and in accordance with the accounting policies as set out on page 13.

Respective Responsibilities of Management and Auditors

The Fund's Management is responsible for the preparation of the financial statements. It is my responsibility to form an independent opinion, based on my audit, on those statements and to report my opinion to you.

Basis of Opinion

I conducted my audit in accordance with generally accepted auditing standards. Those standards require that I plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures on the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by Management, as well as evaluating the overall financial statement presentation. I believe that my audit provides a reasonable basis for my opinion.

The completeness and accuracy of the amounts of \$6,689,515 shown as Contributions in the Income Statement and \$9,565,925 and \$5,088,641 shown as Debtors and Prepayments, and Unregistered Contributors respectively in the Balance Sheet could not be substantiated since details relating to the classification of contributions of registered and unregistered contributors were not presented for audit examination.

The completeness and accuracy of the amount of \$35,216,476 shown as Due from Accountant General could not be determined. Confirmation of the balances was not obtained from the Accountant General's Department. No evidence was provided of reconciliations between the balances of the Fund and those of the Accountant General's Department. Further, this amount includes an amount of \$18,432,985 representing interest receivable from the Accountant General's Department and computed on the basis described at note 1(B) (III) to the financial statements. There was no evidence to substantiate the basis used to compute this Interest.

Qualified Opinion Resulting from Insufficient Information

Except for any adjustments which might have been shown to be necessary as a result of the matters referred to in the preceding paragraphs, in my opinion the financial statements present fairly, in all material respects, the financial position of the Dependants' Pension Fund as at 31 December 1989, and its net surplus and cash flows for the year then ended in conformity with generally accepted accounting principles.

NOTES TO THE ACCOUNTS

1. PRINCIPAL ACCOUNTING POLICIES

(A) Accounting Convention

These accounts have been prepared using the historical cost convention.

(B) The main sources of income are Contributions and Interest on Investments including Mortgages as shown below:

(I) Only actual contributions received from members are accounted for due to the fact that contributors accounts are not updated. 1% Government contributions are recognised on the accrual basis of accounting.

(II) Interest on Mortgages accrue from the date of advance.

(III) Government's interest is calculated at the prevailing overdraft bank rate and interest on investment is calculated on the number of days it is held.

(C) Fixed Assets and Depreciation.

Fixed Assets are depreciated on the reducing balance method on balances at December of each year.

10. UNREGISTERED CONTRIBUTORS - \$5,088,641

This figure represents contributions received from officers not registered with the Fund. Upon registration the relevant amounts would be transferred to revenue.

11. DUE TO EXPATRIATE OFFICERS - \$904,494

The amount relates to a prior year adjustment pertaining to an agreement between the Government of Guyana and the British Government that the liability for the payment of benefits to expatriate officers should be taken over by the British Government. The liability in respect of the widows of those expatriates who contributed to the Fund has been established at \$904,494 by the Actuaries Bacon Woodrow and De Souza of Trinidad and Tobago. Settlement is on a Government to Government basis.
