

THE OVERSIGHT COMMITTEE on CONSTITUTIONAL REFORM

- 1. This is the third monthly report to the National Assembly on the status of work of the Oversight Committee on Constitutional Reform, pursuant to the instructions and requirements of Resolution No.33, passed by the Assembly on December 6, 1999.
- 2. The Oversight Committee held one Plenary meeting during the month of February, on Friday February 18, 2000. Appendix A to this report comprises the Minutes of that meeting and related documentation. At that meeting OSC members were apprised of the fact that by Resolution No.36 on 10 February, 2000 the National Assembly had formally approved the Oversight Committee's Time-Bound Plan for the drafting of Constitutional Revisions.
- 3. During February, overseer members of the Oversight Committee conducted Task Force Meetings in pursuit of the preparation of drafting briefs with the frequencies detailed below:

- 4. Initially, Task Force meetings proceeded without the benefit of the presence of members from the Legal Advisory Group; but this was corrected towards the end of the month, in accord with the decision of the OSC in plenary that a specific member of the Legal Advisory Group should be assigned to each Task Force, and should participate in the deliberations of the Task Force to which they have been assigned, while still collaborating among themselves as circumstances required.
- 5. The appointments, with effect from 1 February 2000, and the assignment of individual members of the Legal Advisory Group to Task Forces, with effect from 24 February 2000, were effectuated by the Hon. Minister of Agriculture and Parliamentary Affairs, and the assignments are as follows:

- 6. The OSC in plenary has decided (see appended minutes) that as draft briefs of individual recommendations are completed by Task Forces, they will be examined by the OSC in plenary before being tendered to the draftspersons of Task Force E for conversion into drafts of revised clauses of the Constitution.
- 7. Sections 5.3 through 5.7 of the appended minutes in Appendix A comprise reports of the status, as at 18 February, 2000, of the work of the Task Forces. The next report on the status of this work will be considered at the OSC Plenary scheduled for Friday 3 March, 2000. There is so far no reason to apprehend that any Task Force will not complete its assignment in accord with the time-bound plan; although Task Force B is not yet in a position to benefit from the advice of the Expert on Electoral Systems whose engagement has not yet been concluded. Paragraph 10 of this report gives the status of this matter as at 29 February, 2000.
- 8. That time-bound plan has scheduled the task of drafting of the revisions to the clauses of the Constitution to start on 1 March, 2000, and has highlighted the task as "critical", in the sense of its importance to meeting the final target date of 28 July, 2000. As at 29 February, the status of engagement of the five required draftspersons was as follows:
 - (a) Only four of the planned five draftspersons have been identified and have confirmed their willingness to serve. The search for the fifth is being pursued as an urgent matter. The four persons mentioned above are: Mr Keith Massiah OR; S.C.; Justice Oswald Legall; Mr Cecil Dhurjon, S.C.; and Mr Zehar Singh Negi.
 - (b) Formal contracting of the four persons so far identified, is being pursued with the UNDP under its commitment to fund this expenditure. It is anticipated that all arrangements should be completed no later than the second week of March.
- 9. At its plenary meeting of Friday 18 February 2000, the OSC considered and approved the budget for the project. Section 5.9 of the appended minutes in Appendix A contains the relevant summary of the budget, and the details are in the budget document in Appendix A. It should be noted that non-finalisation, as at 29 February, of the sums to be actually paid to the Expert on Electoral Systems; the Draftspersons; and the Coordinator, Planning and Monitoring, poses no problem of financing since the UNDP has undertaken to meet the expenses, will be the entity contracting the individuals to perform those tasks, and will determine what remuneration those posts attract in accord with its own established rules and procedures for tasks with those job descriptions.

- 10. As at 29 February 2000, no Expert on Electoral Systems had been engaged. The copy of the fax from the NDI in Appendix B contains the latest information, as of 29 February, on the CVs and timing of availability of the candidates so far identified. The only candidate that appears to be available with the urgency demanded by the time-bound plan is Mr Andrew Reynolds. The overseers of Task Force B concur with the view that Mr Reynolds is adequately qualified, and arrangements are in train to secure his services as quickly as possible.
- 11. This report of the OSC's work during February, 2000, together with its Appendices A and B, has been adopted and approved for transmittal to the National Assembly by the fifth plenary meeting of the OSC, which took place on Friday March 3, 2000.

ITEM 1 CALL TO ORDER

1.1 The Chairman called the meeting to order at 4.55 p.m.

ITEM 2 AGENDA

2.1 Members adopted the Agenda.

ITEM 3 ANNOUNCEMENTS

- 3.1 Presentation of Second Report and Time-Bound Plan to the National Assembly.
- 3.2 The Chairman reported for the purpose of the records that the Clerk of the National Assembly in a letter dated 11th February, 2000 informed the Executive Secretary that the Oversight Committee's Second Report and the requisite Time-bound Plan were presented by the Hon. Minister of Agriculture and Parliamentary Affairs to the National Assembly at its sitting held on Thursday, 10th February, 2000.
- 3.3 Further at that sitting the Assembly passed the following Resolution on a motion by the Minister of Agriculture and Parliamentary Affairs -
- 3.3.1

SEVENTH PARLIAMENT OF GUYANA FIRST SESSION (1998-2000) NATIONAL ASSEMBLY

RESOLUTION NO. 36

RESOLVED, That this National Assembly approve of the Time-Bound Plan for the drafting of Constitutional Revisions which has been prepared by the Oversight Committee.

- 3.3.2 The Clerk advised the Secretariat that copies of the Report and Time-bound Plan were made available to representatives of the Media who were present at the sitting.
- 3.3.3 The Chairman also reported that he had been advised by the Secretariat that Members of the Oversight Committee were given a copy of the Second Report and the Timebound Plan, as presented to the National Assembly, and a copy of the Clerk's letter.

3.4 Experts in Electoral System

- 3.4.1 The Chairman drew Members' attention to copies of the following two letters on experts in the area of electoral systems sent to them by the Secretariat -
 - (a) a letter dated February 9, 2000 from Mr. John W. Heffernan, Director, NDI/Guyana, and addressed to the Coordinator, Planning and Monitoring;
 - (b) the Coordinator's reply dated February 9, 2000 to Mr. Heffernan's letter.
- 3.4.2 The Coordinator, Planning and Monitoring at the invitation of the Chairman, reported that the information that he had to date was only the Curriculum Vitae of the following three experts:
 - 1. Dr. Theodor Hanf, Director of the Arnold-Bergstrasser Institute of Social Research, Freiburg, Germany;
 - 2. Professor Aanund Hylland, University of Oslo, Norway; and
 - 3. Mr. Andrew Stephen Reynolds, Assistant Professor, Department of Government and International Studies, University of Notre Dame.
- 3.4.3 In his reply to Mr. Heffernan's letter, the Coordinator he had requested that the Committee be advised on the availability of the experts. He had made available to Mr. Heffernan a copy of the current draft of the Terms of Reference of an expert in the area of electoral systems and had indicated the need for the expert identified to begin to work as early as possible. Up to the previous day he had not received a reply to his letter.
- 3.4.4 The Coordinator said that according to the Time-bound Plan the expert should have been with the Oversight Committee from mid-February to work for one month. Although his presence was not a critical one, in that it would not adversely affect the Time-bound Plan, however, his early presence was important since the work of Task Force "B" was dependent on expert's advice on the electoral system.

3.4.5 The Coordinator also reported that assurance was given by Mr. Richard Olver, Resident Representative, UNDP to both the Head of the Presidential Secretariat and himself that the payment in respect of expenditure for the engagement of experts would be met by a donor agency.

3.5 Excuses

3.5.1 The Chairman informed Members that Mr. Alexander had asked to be excused from that meeting.

ITEM 4 CONFIRMATION OF MINUTES

- 4.1 The Minutes of the Third Meeting of the Oversight Committee held on Monday, 31st January, 2000 were confirmed on a motion moved by Dr. Ramsammy and seconded by Dr. Luncheon.
- 4.1.1 There were no matters arising out of the Minutes.

ITEM 5 BUSINESS

5.1 **Discussion on Format on Reporting of Briefing Drafts**

- 5.1.1 The Chairman referred to the Memorandum submitted by the Coordinator, Planning and Monitoring dated February 14, 2000 on the **Proposed Format for each Task Force's Drafting Brief** and in which the Coordinator acknowledged his indebtedness to the ingenuity of Dr. Ramsammy for the format appended to the memorandum.
- 5.1.2 Dr. Ramsammy on the invitation of the Chairman explained that his format was derived from the Terms of Reference and Guidelines for Task Forces. He found that it had made discussions easier and had worked well for Task Force "D". While it was not his original intention to create an "across-the-board" format, he felt that if the format was used by other Task Forces the draftspersons would be working with a standard format.
- 5.1.3 Members discussed the format and agreed that it would be useful to adopt it subject to modification as members thought fit.
- 5.1.4 Arising from the discussion on the format on drafting briefs was the relationship between the Task Forces and the Legal Advisory Group. From that discussion it was clearly established that the Legal Advisory Group was a part of the Task Forces and a member of the Group would be attached to a specific Task Force to assist in



preparing drafting briefs for Task Force "E". It was also clearly established that members of the Group would meet from time to time to consult among themselves on issues pertaining to their work and that of the Task Forces.

5.1.2 Members then agreed to proceed with Item 3 of Business instead of Item 2.

5.2 Status of Legal Advisory Group

- 5.2.1 The Chairman reported that the Hon. Minister of Agriculture and Parliamentary Affairs had informed him that he had approached the following persons who had agreed to be members of the Legal Advisory Group:
 - (a) Mr. Cecil Dhurjon, S.C., Chief Parliamentary Counsel, Attorney General's Chambers;
 - (b) Ms Roxane George, Assistant Director of Public Prosecutions, Chambers of the Director of Public Prosecutions;
 - Mr. Zehar Singh Negi, Legal Draftsman, Attorney General's Chambers;
 - (d) Ms Cavelle Lynch, Attorney-at-Law in private practice.
- 5.2.2 The Chairman asked members of the Media not to publish the names as those persons had not been officially appointed. He advised them that the Secretariat would issue a Press Release upon their appointments.
- 5.2.3 The Chairman also reported that the Hon. Minister of Agriculture and Parliamentary Affairs would contact Overseers of the Task Forces A1, A2 and D, to discuss who from the Legal Advisory Group would be assigned to his Task Force. It was decided that Mr. Dhurjon would be assigned to Task Force "B" but would be available to Task Force C as required.
- 5.2.4 He explained that members of the Legal Advisory Group could not have been available earlier because their appointments were dependent on the successful conclusion of the budgetary proposals for the Oversight Committee.

5.3 Report on Work Programmes of Task Forces

5.3.1 Task Force "A1"

- 5.3.1.1 Mr. Nadir reported that Task Force "A1" which had a relatively slow start due to a number of reasons, had agreed to a Work Programme that would take it up to 17th March, 2000. To date that Task Force had dealt with ten (10) of the fifty-four (54) recommendations assigned to it. Mr. Nadir assured Members that a copy of his Task Force's Work Programme would be made available to them.
- 5.3.1.2 Mr. Nadir said that Members of his Task Force felt that since Guyana had subscribed to and had ratified the "Charter of Civil Society for the Caribbean Community", it was prudent for the relevant Articles of that Charter to be adopted for the Constitution.
- 5.3.1.3 It was pointed out by the Coordinator that that Charter was considered by the Constitution Reform Commission in their deliberations, however, any part extracted from it should be indicated in the Objective or Intention of Change Column of the drafting brief to alert the draftspersons. He reminded Members that amendments to recommendations were not permissible.

5.4 Task Force "A2"

- 5.4.1 Dr. Roopnaraine reported that Task Force "A2" had made a reasonable start since the language of most of the recommendations were already drafted by the Special Select Committee. He said that they urgently needed the assistance of the Legal Advisory Group.
- 5.4.2 There were, however, two main areas for Task Force "A2" to draft:
 - (a) a new draft of the Preamble; and
 - (b) the Public Tender Commission under Recommendation 9.17.3(7) Finance. The Task Force was awaiting a copy of the draft Procurement Act to continue consideration of Recommendation 9.17.3(7).
- 5.4.3 In response to what should be done by the Task Forces with respect to recommendations which the Constitution Reform Commission specifically referred to Parliament for a decision and on which neither Parliament nor the Special Select Committee made a decision, Dr. Roopnaraine was advised to either:
 - (a) propose that the recommendations be referred at a future date to the Parliamentary Standing Committees for Constitution Reform; or

(b) refer the recommendations to the Minister of Agriculture and Parliamentary Affairs for consideration by the National Assembly.

5.5 Task Force "B"

- 5.5.1 Dr. Luncheon reported that Task Force "B" had held three separate meetings and that the frequency of meetings was affected by his absence from the country for a week.
- 5.5.2 He said that his Task Force dealt with the six recommendations under 9.10 -Elections Commission. It also dealt with two consequential recommendations with respect to Leader of the Opposition that affected the Electoral System. The drafting briefs would be submitted shortly.
- 5.5.3 He also reported that the meeting that dealt with Recommendation 9.11 Electoral System led to the adoption of the draft Terms of Reference for an expert on electoral systems which had been circulated. It would enable the donor agency to recruit the expert on Electoral Systems to deal with the recommendations of the Special Select Committee.
- 5.5.4 He said that the next meeting of Task Force "B" was scheduled for Tuesday, 22nd February, 2000 at which Recommendations 9.8 Local Government would be examined.
- 5.5.5 The Chairman advised Dr. Luncheon to indicate to the Oversight Committee when he would wish to report definitively on the fast-tracking of the Recommendations on the Elections Commission.

5.6 Task Force "C"

- 5.6.1 The Chairman reported that out of the twenty (20) recommendations considered by Task Force "C", seventeen (17) were concluded and three (3) deferred. He said that by the end of February the Task Force would be ready to work along with the Legal Advisory Group.
- 5.6.2 The Chairman also reported that Task Force "C" encountered similar problems as those of Task Force "A2".

5.7 Task Force "D"

5.7.1 Dr. Ramsammy reported that Task Force "D" met on seven (7) occasions and would continue to work up to the 28th March, 2000. They had considered Recommendation 9.9 - The Judicature which consisted of thirteen (13) Recommendations and had submitted a Report on this category of Recommendations.

- 5.7.2 He noted that of the thirteen (13) Recommendations the Task Force had suggested drafts for four (4) of them, forwarded six (6) to be drafted by the Legal Advisory Group and needed advice on three (3) of them two of which could be drafted by the Legal Advisory Group and one which might necessitate the discussion of the Oversight Committee. A letter was sent to the Chairman on this matter.
- 5.7.3 Dr. Ramsammy also reported that the Task Force had commenced discussions on Commissions and suggested that since all other Task Forces had a Commission or more to deal with, then there would be need for collaboration on the respective Commission or Commissions.
- 5.7.4 The Chairman asked Members to submit completed recommendations as they become available. This would facilitate the compilation for transmission to Task Force "E".

5.8 Status of Engagement of Task Force Draftspersons

- 5.8.1 The Chairman informed Members that the following names were under consideration by the Hon. Minister of Agriculture and Parliamentary Affairs:
 - (a) Professor Keith Massiah, S.C., O.R.
 - (b) Mr. Cecil Dhurjon, S.C., Chief Parliamentary Counsel
 - (c) Ms Jamela Ali, Principal Legal Adviser
 - (d) Mr. Dean Sharma, Legal Consultant to the Minister of Legal Affairs
- 5.9.2 Once again, the Media was asked not to publish the names of the above persons.

5.9 Status of the Oversight Committee's Budget

5.9.1 The Coordinator presented the Draft (No. 3) Budget of the Oversight Committee amounting to G\$27,860,806 or US\$154,782 as summarised below:

- 5.9.2 The Coordinator explained that the budget was derived from the Time-bound Plan and other policy decisions with regard to the organisation structure and its activities. The figures were not final as they excluded the remunerations of the Coordinator, Planning and Monitoring and other expenses in respect of the engagement of an electoral system expert.
- 5.9.3 Members were informed that Dr. Roger Luncheon, Head of the Presidential Secretariat, Mr. Rudy Collins of the Ministry of Foreign Affairs and the Coordinator met the Resident Representative, UNDP, and discussed with him the five options as presented on page 6 of the budgetary proposals, for financing the project.

- 5.9.4 After considering the size of the budget, its contents and the financing options, the Resident Representative informed them that the rules governing the funding of projects would permit him to provide assistance for the total funding of the Oversight Committee's project.
 - 5.10.5 The Committee adopted the budget as presented.
 - 5.10.6 The Chairman thanked Dr. Luncheon, Mr. Parris and Mr. Collins for obtaining the funding for the project.

The meeting was adjourned at 6.50 p.m. sine die.
