MOTOR VEHICLES AND ROAD TRAFFIC ACT

(Cap. 51:02)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 98 OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT, I HEREBY MAKE THE FOLLOWING REGULATIONS:—

Citation. 1. These Regulations may be cited as the Motor Vehicles and Road Traffic (Amendment of Fees) Regulations 1981.
