PERSONAL EXPLANATIONS

Mr. M.F. Singh – Misleading Statement in the Assembly

<u>Mr. M.F. Singh</u>: Mr. Speaker, under this Head I crave your indulgence to make personal explanation.

At the meeting of this honourable House on Friday, 28th March, 1980 during my contribution in the debate on the Criminal Law Bill 1980, I told this honourable House that the Guyana Bar Association had held an emergency meeting that very morning, that I had not attended that meeting, but that I had been informed by an

executive member of the Guyana Bar Association that three resolutions had been unanimously passed to the effect –

- That the Guyana Bar Association had rejected out of hand the Amendments to the Bill proposed by the honourable Attorney General;
- (2) That the lawyers had agreed to withhold their services to the courts until 7th April, 1980; and
- (3) That the lawyers had resolved that they had no confidence in the hon. Attorney General.

Mr. Speaker, I regret to say that I have since discovered that my information in respect of the third resolution was incorrect and that in fact no less a person than the President of the Guyana Bar Association, Mr. B.O. Adams, had voted against the motion of No Confidence in the hon. Attorney General.

Mr. Speaker, to mislead the House as I did in a matter such as this is indeed very serious. It is no excuse for me to plead that I was misinformed. I have to take full blame, and I consider that I am in duty bound to set the records straight and to humbly apologies to this honourable House and in particular to the hon. Attorney General.

I have been a member of this honourable House since 1996 and I have always tried to live up to the high ethical and moral standards expected of Members of Parliament. It grieves me deeply to know that I was, albeit unwittingly, the bearer of false information to this honourable House.

May I add, Mr. Speaker, that even though I still remain opposed to the retroactivity in the Criminal Law Act, as it now is, were I at that meeting of the Guyana Bar Association on Friday, 28th March, I also, like Mr. B.O. Adams, would have voted against the resolution of No Confidence in the hon. Attorney General. <u>[Comrades</u> (Government): "Hear! Hear!"] Why? Because as a former Cabinet Minister, and having seen the amendments proposed, I was in a position to appreciate to what lengths the hon. Attorney General had gone to meet the objections of the Guyana Bar Association.

Mr. Speaker, let me assure this honourable House that I continue to have the highest regard for the integrity and scholarship of the hon. Attorney General – in the Criminal Law Act 1980 – and that is all I disagree with: the retroactivity [Applause] – while retaining the right to disagree in respect of the retroactivity in section 2. That is as far as my objection goes.

Mr. Speaker, I humbly ask that my apology be accepted by this honourable House and in particular by the hon. Attorney General. Thank you.
