### VACATION OF SEAT BY DR. G. KUMAR

**The Speaker:** Hon. Members, Dr. Ganraj Kumar, who was declared to be an elected Member of the National Assembly, has been absent from seven (7) sittings of the Assembly held as follows:

- (i) Thursday,  $26^{\text{th}}$  July, 1975;
- (ii) Monday,  $30^{\text{th}}$  July, 1973;
- (iii) Thursday, 2<sup>nd</sup> August, 1973;
- (iv) Friday, 3<sup>rd</sup> August, 1973;
- (v) Tuesday, 7<sup>th</sup> August, 1973
- (vi) Friday, 10<sup>th</sup> August, 1973; and
- (vii) Tuesday, 14<sup>th</sup> August, 1973

These have been consecutive sittings and have been held during the present session of parliament and within the period of not longer than two calendar months.

Dr. Kumar did not apply for and was not granted leave of absence by me. He has, therefore, vacated his seat in the National Assembly in accordance with article 61(2) (b) of the Constitution and Standing Order No. 77. Dr. Kumar has been formally informed of this.

In accordance with article 70 of the Constitution, the appropriate Member of the Assembly was called upon to extract from the list in which Dr. Kumar's name was included, the name of a person to fill the vacancy.

The name of Mrs. Elinor DaSilva was extracted from the list and Mrs. DaSilva has been declared to be a Member of the National Assembly.

As Mrs. DaSilva is present the Oath of Office will be administered to her.

### **OATH OF OFFICE**

The Oath of Office was made and subscribed by Mrs. Elinor DaSilva.

**The Speaker:** Hon. Member Mrs. DaSilva, on behalf of the Members of the National Assembly may I congratulate you and welcome you back to Parliament.

**Mrs. DaSilva:** Mr. Speaker and fellow Members of Parliament, I wish to thank you for your congratulations and your kind welcome back to the House.

I am indeed happy to be here because Parliament is the place where you make your voice heard no matter how small it is, and where you say what is needed to be said.

My presence here, as that of my leader, does not mean that we condone what took place at the General Election. This has to be repeated so that it can be clearly understood. We do not condone what took place before, during and after the General Election but, nevertheless, we feel that Parliament is the forum where your presence must be if you want to be of service to your country, and this is the object of my Leader and myself, the United Force faction of the Liberator Party.

**Mr. M.F. Singh:** Mr. Speaker, I would like to express my hearty congratulations to Mrs. DaSilva on having become a Member of this honourable House.

Mrs. DaSilva is no stranger to this Chamber. Indeed, I do not think she is a stranger to any of us in this House. She was a Member of the last Parliament. I am sure we, who were Members then, remember her starling and, indeed, her lively contributions to the debates. I welcome her as my colleague to this House and I am grateful that I will now have her valued assistance on this side of the House to ease the burden which, up to now, I have carried as the Opposition

I do regret the circumstances under which Mrs. DaSilva entered the House but as the saying goes, out of evil cometh good. As everyone knows the United Force joined with the Guyana Anti- Discrimination Movement under the name "Liberator Party" with the United Force

symbol, "The Sun" to fight the last General Election. After the Elections, as List Representative, I appointed Dr. Kumar and myself to Parliament but Dr. Kumar refused to take his seat. His group's decision was to follow whatever the P.P.P. did. They claimed that if the seats were taken it would give the stamp of legality to an illegal P.N.C. Government. By not taking the seats, they added, the outside world would recognise that the P.N.C. had no right to be in power. This was reasoning.

I would like all Guyanese to appreciate how idiotic this reasoning is. The Prime Minister was recently at the Commonwealth Heads of Government Conference. This Conference was held in Canada. What impact did the P.P.P.-G.A.D.N.'s boycott have on that conference? And now, to top it all, Dr. Fidel Castro, Dr. Jagan's greatest friend, is coming to Guyana, warmly recognised by the Prime Minister and warmly recognising the P.N.C. Government, and hosting Guyana's Prime Minister on his Cuban Airline plane to Algiers.

Mr. Speaker, Dr. Jagan should have been in Parliament today as the official Leader of the Opposition. He should have been here representing the people who voted for his party. Instead, he and his P.P.P. are going around the country preaching violence, the effect of which would only be to bring sufferings to his misguided followers.

In yesterday's *Mirror*, Mr. Speaker, they cried: "Fidel, sir! Burnham, no!" That was written in the front page. "Long live Fidel! Down with Guyana's Batista Regime!"

Mr. Speaker, why Castro... Si, Castro does not rig elections. He does not even bother to have elections. Does this make Castro more virtuous? Or does it make rigging more heinous?

Let me not misunderstood. I do not agree with many of Dr. Castro's policies and actions anymore than I condone election irregularities, but we must recognize the realities of the situation, the realities of politics. Dr. Castro leads a large Caribbean nation with whom we must have productive dialogue, just as we must bring our local political differences into public hearing within this Chamber. In any case the visit of Dr. Castro is testimony to the fact that Guyana is recognized by the third World countries as being among the foremost of the progressive nations

in the Third World who are striving for economic reconstruction and for a better way of life for its people.

But of course, this does not at all mean that the United Force section of the Liberator Party agrees with the policies, the methods used by the P.N.C. Government to attain its objectives.

However, to get back to Mrs. DaSilva's appointment...

**The Speaker**: I was just about asking you if you are going to congratulate Mrs. DaSilva or make a political speech.

**Mr. M.F. Singh**: Let us look again at the circumstances because this is very relevant. Dr. Kumar and his group, political infants that they are, have blindly followed a sightless Jagan and his last P.P.P. tribe into the wilderness.
