Speaker, I wrote you today intimating that I propose at the convenient time to move the suspension of the Standing Orders in order to discuss a matter of urgent public importance that is the escalating threat to the . . . in the region arising from the continuing acts of hostility by the United States Administration against the

Government and people of Nicaragua such as the economic embargo that has now been imposed.

Since sending you this letter, I had a telephone conversation with the Minister of Foreign Affairs and he has agreed that at an earlier period he will be prepared to discuss the substantive motion and therefore with your permission I wish to withdraw this application and to table the same motion.

<u>The Speaker</u>: However, Dr. Jagan, leave is granted to have the matter withdrawn but to avoid in future, the nature of this mater – if you really look at the rules that deal with this matter, it says very clearly it must involve the responsibility of the Guyana Government and certainly this would not have qualified.
