Leave

Thirtieth anniversary of the Establishment of the Parliament Office.

Comrades, I am advised that today would mark thirty years since the present Parliament is constituted as it now is. Prior to that it formed part of the colonial office of those years and since that time we have had two officers with us: The Clerk, Frank Narain, who has been with us continuously and Cde. King served under Sir Eustace Woolford, Sir Donald Jackson, R.B. Gajraj, A.P. Alleyne and myself. I am sure you all would wish me to congratulate them and extend to them our best wishes and trust they will be with us for a very long period of time. [Applause] Of course I say a long period because the Clerk will be here until he is sixty-five years and he is a very young man.

Deaths

Comrades, since we last met we have had the deaths of three members. Two who were former members and one member, Cde. Abel Dorrick who was member elected to the Assembly by the Regional Democratic Council for Region 9 – Upper Takutu/Upper Essequibo. I understand a motion of condolence on Cde. Dorrick's death will be moved at the next sitting of the Assembly. We also lost two members who served previously as legislators: Cde. Percival Augustus Cummings and Cde. Wellesley Trevelyan Lord. Cde. Cummings was one of the Governor's nominee to the Upper House, i.e., the State Council of 1953 the legislature. He served from 26th of May, 1953 and up to the time of the suspension of the Constitution in December, 1953. He was also nominated to the Interim Legislative Council which followed and served there from December, 1953 to September, 1957. During this time he was assigned responsibility for Labour, Health and Housing.

Cde. Lord was a nominated Member of the Interim Legislative Council and served there from January, 1954 to June, 1957.

BILL - SECOND AND THIRD READINGS

GUYANA MANAGEMENT INSTITUTE BILL 1983

A Bill intituled:

"An Act to provide for the establishment and administration of the Guyana Management Institute and for matters connected therewith." The Minister in the Office of the Prime Minister.

The Minister in the Office of the Prime Minister (Cde. Harewood-Benn): Cde. Speaker, this Bill, the Guyana Management Institute Bill seeks to establish the institute as a legal entity enabling it to deal with international agencies connected with technical assistance for management development. It is a pretty straightforward Bill in that it seeks to remedy a situation which needs to be remedied urgently. There is general agreement as to the fact that our management training capability is inadequate, and with the urgent need for managers at all levels it is necessary that this institute be organised as a statutory body.

It is going to assume responsibility for management training at all levels. It will also be taking over all the functions that are now carried out by what is known as the Guyana Management Development Training Corporation and it will take over responsibility for all the management training that is now done by the Public Service Training Division. This does not mean that the P.S.M. will no longer

be responsible for training. It will continue to deliver those basic and technical training programmes which it now carries out for personnel in the Ministries and Government Departments in and out of town. Some of these include orientation programmes for new entrants, records management, accountancy and so on.

I must note that the University of Guyana has a Department of Management and the establishment of the Guyana Management Institute will in no way conflict with the running and with the organisation of the Department of Management of the University of Guyana. They are concerned with management education. The Guyana Management Institute will seek to emphasise management training and development. There is no conflict. In fact, there is complete complimentality.

The plan is for the Institute to work with managers themselves in a kind of laboratory situation where they will get very practical knowledge as far as the management training and development programmes are concerned. I may add that this is not any new arrangement. It occurs quite well in many other parts of the world and in seeking to remedy our situation we see the establishment of the Institute as the first step in a necessary series of steps to ensure that our management capability is as it should be. I ask that this Bill be read a Second time.

Question proposed.

Cde. Ram Karran: Sir, the hon. pretty lady Minister has done a little more than what is recorded in the Bill, although I think she failed to tell us what are the reasons for this new addition to this very poor economy of Guyana. This is the time for the P.N.C. to pack up and go. Now they are starting to train. Train who and train for what? The whole country is ready to move them out and now they come and tell us after so many years that they will start training and that this is not going to conflict with the several training facilities that they have got. Why a new one? The lady Minister did not tell us why.

They are telling us that the managers need training. I would think, sir, that other categories of people higher than the managers need training because what we have succeeded to do in this country is chase out all the competent managers so far and now we have got a dearth of managers and we need to train them they say. I am asking why is it that the facilities at the University of

Guyana, for instance, cannot be expanded. We have the Civil Service Training facilities on which we have spent so much money, and not so very long ago we have had a new Ministry set up to look after the Fublic Service and Training and so on. In days gone by — and in fact I understand that the same system exists in the United Kingdom, where you have such a large Civil Service, where the Exchequer is responsible for training and Public Service. We do not seem to recognise nor have we recognised all these years that we are a poor country. At least they say so.

I am astounded by the fact that the Minister said we must look and see what other is happening in places, where countries have benefited from a scheme like this when, in our own country, we are told we must not worry with what the people outside eat, we must make our own colonial basket, we must not worry with flour although the people all over the country in a democratic manner are saying we want wheaten flour. They are telling us we must eat rice flour and at the same time she is telling us do not worry with the training we have here, we must go outside and see. Unfortunately she did not call the name of the country where this sort of training is dome. It is only because she is a nice lady that I do not want to say what I really want to say.

I think it is farcical. I think the Government would have to see. They have taken a long time, they have come to this Chamber. All the people's grievances are aired in the street, they are not brought here. We have come here to do a nonsense piece of thing, expanding another thing, make more bureaucracy.

Interruption by the Speaker.

Cde. Ram Karran continues: Forty years ago you had colonial establishment and I am saying that more honest people prevailed in those days both in the legislature and outside of the legislature than prevail today outside of the Parliament and in this British Parliament. The thing is stinking Cde. Chairman, something must be done about it and this kind of white wash that is going on is not going to solve the problem.
