# SPEAKER CONGRATULATES RECIPIENTS OF HONOURS

Mr. Speaker: Hon. Members of Council, I propose to vacate the chair for a short interval in order to join with others in meeting His Excellency the Governor when he arrives. I take this opportunity on behalf of the Council and myself of congratulating those members of the audience who are here to be recipients of Her Majesty's awards, and of wishing them every continued success in their fields of activity which have brought these honours on them.

# INCREASED OLD AGE PENSIONS

Be it resolved:

That the amount of pension payable under and in accordance with the provisions of the Old Age Pensions Ordinance, 1944, as fixed in subsection (1) of section 8 of the said Ordinance shall, with effect from the 1st day of July, 1954, be varied—

- (a) in the case of a person ordinarily resident in the Georgetown area from four dollars and fifty cents per mensem to seven dollars and fifty cents per mensem; and
- (a) in the case of a person ordinarily resident elsewhere than in the Georgetown area from three dollars per mensem to five dollars and fifty cents per mensem;

And be it further resolved:

That Resolution No. XXVIII passed by the Legislative Council on the 19th day of March 1951, be annulled with effect from the 1st day of July, 1954.

# COMMITTEE TO INVESTIGATE PLYWOOD INDUSTRY

Mr. Carter gave notice of the following motion:

Whereas the locally grown wood known as Dalli is being exported to a foreign country and no export duty is being collected thereon;

And whereas only the highest quality grade of Dalli logs which must be free from knots, splits, wanes, warps, flats and borer are acceptable in the export market, and as a consequence rejected logs involving thousands of cubic feet of this wood are allowed to rot and waste in the forest;

And whereas this Colony imports plywood on which import duty is collected. and such plywood is manufactured from Dalli logs of this Colony;

And whereas the Colony's forests abound with Dalli and in quantities estimated to operate a plywood industry for at least forty (40) years;

And Whereas the Colony's housing programme would absorb fully all of the plywood that could be manufactured locally from Dalli and other suitable Colony woods, and the establishment of such an industry would create employment for many of the present unemployed:

#### Be it Resolved:

That this Council recommends-

- (a) the appointment of a Select Committee comprising five members to investigate and report on the possibility of establishing a plywood industry in the Colony;
- (b) the immediate imposition of an export tax on the wood known as Dalli;
- (c) the imposition of an export tax on all forest products excluding firewood and charcoal;
- (d) that Rules be enacted under section 18 of the Export of Timber Ordinance. 1937 (No. 1) to provide for the collection of export tax and inspection fees, etc., on forest products.

### REPLIES TO QUESTIONS

# DEMERARA ELECTRIC Co.'S FRANCHISE

Mrs. Dey asked and the Member for Communications and Works replied to the following questions:—

- Q. 1: Is it not the case that the franchise granted by Government to the Demerara Electric Company, Limited, to generate and to sell electricity in the City of Georgetown, as well as 5 miles outside of the City of Georgetown is for a period of 50 years?
- A. The answer is in the affirmative. The duration of the Order is, however, subject to the conditions contained in section 4 of the Georgetown Electric Supply and Tramways Ordinance, Chapter 79.
- Q. 2: Is it the case that the franchise is due for revision this year and such revision shall take place by or before August?
- A. The answer is in the negative. Attention is, however, drawn to section 4 of the Georgetown Electric Supply and Tramways Ordinance. Chapter 79, relating to the powers of the Governor in Council should the Company fail to comply with reasonable requirements to improve the undertaking and bring it up to date, etc.
- Q. 3: Is it the case that the Demerara Electric Company, Limited is obligated under the franchise to supply electric current to any local authority within 5 miles of Georgetown on such local authority serving a requisition signed by 6 or more persons on the Demerara Electric Company, Limited?
- A. The answer is in the affirmative. See Clauses 14 to 23 of the Georgetown Electric Supply Order, 1927.

- - Q. 4: Has the Demerara Electric Company Limited the right to make the fuel charge they are now making in every consumer's bill?
  - A. The answer is in the affirmative: Provided however, that the maximum price of electricity supplied does not exceed fifteen cents for each kilowatt unit, as set out in the Third Schedule to the Georgetown Electric Supply Order, 1927.

# HOSPITAL FEES (AMENDMENT) REGULATIONS

Cummings (Member Mr for Labour, Health and Housing): I beg to move the following motion:-

"That this Council approves of the Hospital Fees (Amendment) Regulations, 1954, which have been laid on the table."

The Hospital Fees Regulations of 1932 provide that "every Public Officer on the Fixed Establishment and every Government employee who is on the regular monthly salary staff of any Department who desires to be admitted for treatment to a Public Hospital as a paying patient or to guarantee payment of the Hospital expenses of any member of his family must either conform to the general regulations for paying patients above or alternately sign a special guarantee form authorizing deductions from his salary."

That concession is limited to certain Public Officers. Following upon recommendations from the Whitley Council the Executive Council has decided to ask this Council to approve of these amendments in order that that facility can be applied to all Government Officers and employees-those who are not also on the Fixed Establishment -providing they are on the regular monthly staff, and that Schedule 7 to the Hospital Fees Regulations of 1932 as substituted by Regulation 3 of the Hospital Fees (Amendment) Regulations No. 17 of 1953 which provides for a reduced scale of fees for in-Patient treatment for Government Emplovees on the Permanent Establishment and employees of the Transport and Harbours Department and Non-Commissioned Officers and Constables of the Police Force, should be extended to all employees on the regular staff of all Departments of Government. These Regulations seek to adopt those proposals.

Sir Frank McDavid seconded.

Question put, and agreed to.

Motion adopted.

Mr. Speaker: This concludes the business for today and I adjourn the Council to next Thursday, 25th November, at 2 p.m.
