NATIONAL DEVELOPMENT SAVINGS LEVY

Senator Tasker: I beg to ask the Minister of Trade and Industry Question No. 1 standing in my name on the Order Paper: Will the Government state:

Senator Tasker: Arising out of the Minister's reply, I wish to ask as a supplementary question: Is Government aware of the confused position of both employers and employees over the National Development Savings Levy following a recent judgment in the Supreme Court and in view of the lack of any directions by the Commissioner of Inland Revenue, and will the Minister make an early statement to clarify the position?

Senator Hubbard: The Government will give consideration to the request of Senator Tasker. I can say no more because the matter is still a matter within the competence of the Court, sir.

PUBLIC BUSINESS MOTION

ELECTRIC INSTALLATION (AMENDMENT) REGULATIONS

Senator Aubbard: Your Honour, in 1907 Regulations were made to cover matters relating to Electric Lighting. In those Regulations was provided at Section 52 the procedure to be adopted in relation to the reporting of accidents, when accidents occurred, and it was required in that regulation that "the Undertakers shall also summon immediately to the scene of such accident the Government electric inspector.",

Now, in 1907 the electricity undertaking had been operating only for a very short time and the area electrified was very small. Today the area electrified is quite considerable and it is now impracticable for an inspector to be summoned immediately to the scene. To be more realistic the Government has made a regulation requiring that the electric inspector shall within 72 hours of the receipt of a notice visit the scene of the accident.

We are fully conscious of the need for protection and the safety of workmen engaged in electricity supply, and it is one of the regrets of the Government and the Electricity Corporation that accidents continue to occur while linesmen are at work on the

given a great deal of attention to the tightening up of its safety regulations. It has had consultation with the trade union concerned to try to get employees of the Corporation to adhere strictly to the safety regulations with the aim of avoiding accidents or cutting them to an irreducible minimum. But, as we say in this country, familiarity breeds contempt and we have had cases where men believed that because they have been familiar with electricity they must be contemptuous of it and they have neglected to take the precautions prescribed for their own safety.

I think it necessary to mention this to satisfy the public that our alteration of this regulation is not intended in any way to give licence to the Undertakers to be slack in the application of safety measures or to relax their vigilance. I do hope that these remarks will induce the persons who are exposed to the danger of electricity to recognize that the danger does not disappear because they have become accustomed to it by living with it every day.

I beg to move the following Motion -
