INT DUCTION OF BILLS

Presentation and First Reading

(1) CUSTOMS (AMENDMENT) BILL 1975 - Bill No. 27/1975

The Minister of Finance, on behalf of the Government, presented the following Bill which was read the first time:

A BILL intituled AN ACT TO AMEND THE CUSTOMS ACT.

(2) TIMEHRI INTERNATIONAL AIRPORT (AMENDMENT) BILL 1975 - Bill No. 26/1975

The Minister of Parliamentary Affairs and Leader of the House, on behalf of the Minister of Works and Housing, presented the following Bill which was read the first time:

BILL Second and Third Readings

ITEM 1 PRISON (AMENDMENT) (NO. 2) BILL 1975 - Bill No. 25/1975 published 31.5.75

The Minister of Home Affairs moved the second reading of the following Bill:

The Leader of the Opposition spoke to the motion.

Thereafter, the motion was put and carried.

The Bill was then read a second time.

Assembly resolved itself into Committee to consider the Bill clause by clause.

<u>In Committee</u>

Clauses 1 to 5 were passed as printed.

Insertion of Clause 5A: On a motion by the Minister of Home Affairs the following was inserted as clause 5A;

"Insertion Insert immediately after section 5 of the Principal of section Act the following section -

5A in the Principal Act.

Duties of Deputy Director.

5A. The Deputy Director shall act as principal assistant to the Director in the performance of his duties and shall have power, during the absence or incapacity of the Director, or when so authorised by him to do or suffer any act or thing which may by law be done or suffered by the Director.'."

Clauses 6 to 10 were passed as printed.

Recommittal of clause 10

On a motion by the Minister of Home Affairs clause 10 was recommitted.

Clause 10: On a motion by the Minister of Home Affairs the following amendment was put and carried:

> Substitution of the words "Public Service Commission" for the word "Minister" in subsection(2)(c).

Clause 10 was then passed as amended.

<u>Insertion of clause 11:</u> On a motion by the Minister of Home Home Affairs the following was inserted as clause 11:

"Insertion of **s**ection 39A in the Principal Act.

Insert immediately after section 39 of the Principal 11. Act the following section -Appointment 39A. Notwithstanding anything to the contrary

etc. to enquire into

contained in this Act, where a prisoner commits Superintendent any prison offence the Director may appoint a Senior Superintendent, a Superintendent or an Assistant Superintendent to enquire into the prison offence. offence and if the prisoner is found guilty of the offence the person so appointed may impose any or all of the punishments specified in section 39.'."

"(5) A Member shall be referred to in the Assembly either with the title "Comrade" before his surname or official designation or as the Honourable Member, Mr

That this National Assembly, in terms of section 9 of the Customs Act, Chapter 82:01, confirm the Customs Duties Order 1975 (Nio. 65), which was made on the 26th of June, 1975, and published in the Gazette on the 29th of June, 1975.

ITEM 5 - CONFIRMATION OF THE CONSUMPTION TAX (AMENDMENT) ORDER 1975 (NO. 66)

The Minister of Finance moved the following motion:

BE IT RESOLVED:

That this National Assembly, in terms of section 5 of the Consumption Tax Act, Chapter 80:02, confirm the Consumption Tax (Amendment) Order 1975 (No. 66), which was made on the 27th of June, 1975, and published in the Gazette (extraordinary) on the 28th of June, 1975.

That this National Assembly, in terms of section 9 of the Customs Act, Chapter 82:01, confirm the Customs (Exemption from Duties) Order 1975 (No. 67), which was made on the 27th of June, 1975, and published in the Gazette (Extraordinary) on the 28th of June, 1975.

- AMENDMENT TO RESOLUTION NO.XXXII OF 17TH APRIL. 1974 GUARANTEE OF CREDITS TO GUYANA BAUXITE COMPANY LTD.

The Minister of Finance moved the following motion:

WHEREAS, by Resolution No. XXXII passed on 17th April, 1974, this National Assembly, authorised the Minister of Finance to sign Agreements, as guarantor, between international financial institutions and the Guyana Bauxite Company Ltd., amounting to G\$85 million for the purchase of capital equipment and engineering services in connexion with its expansion scheme for increasing the production of calcined bauxite;

AND WHEREAS the rate of exchange of the Guyana Dollar against the United States Dollar, which is the denomination of most of the loans, may be subject to wide fluctuation;

AND WHEREAS it is desirable that a fixed sum for borrowing in United States Dollars should be authorised:

BE IT RESULVED:

That this National Assembly do amend the terms of Resolution No. XXXII, passed on 17th April, 1974, by the addition at the end of the Resolution of the words "or the equivalent amount of forty two million, five hundred thousand U.S. dollars (U.S. \$42,500,000)".

The Leader of the Opposition spoke to the motion.

Thereafter the motion was put and carried.
