DATH

The Speaker informed the Assembly that he had been advised that Cde. Vincent Rambeer Teekah had been appointed to be a Minister and Had been designated Minister of Education, Social Development and Culture, with effect from 4th April, 1977.

As Cde. Teekah was not an Elected Member of the National Assembly at the time of his appointment, he had, in accordance with article 34(6) of the Constitution, by virtue of holding the Office of Minister, become a Member of the Assembly.

Before Cde. Teekah could take part in the proceedings of the Assembly, he would have, as required by article 76 of the Constitution, to make and subscribe before the Assembly, the Oath of Office.

Cde. Taekah thereupon made and subscribed the Oath of Office.

ANNOUNCEMENTS BY THE SPEAKER

(i) Election of Member

The Speaker informed the Assembly that he had been informed that Cde. William Haynes had ceased to be a Minister with effect from .4th April, 1977.

As Cde. Haynes was not an Elected Member of the National Assembly at the time of his appointment, he had also ceased to be a Member of the Assembly.

Following his call upon the Representative of the People's National Congress List of Candidates, the name William Haynes had been extracted from the list as the person to fill the seat in the National Assembly made vacant by the death of Cde. Branco and Cde. Haynes had been declared to be elected as a Member of the National Assembly.

(ii) Appointments and Changes, etc.

The Speaker announced for the information of Members and for the records of the Assembly, the further appointments and changes which had been made with effect from 4th April, 1977, as follows:-

- (a) Cde. Cecilene Leona Baird and Cde. Oliver Montgomery Roberts Harper had ceased to be Ministers. As they were not Elected Members of the Assembly, they had also ceased to be Members thereof.
- (b) Cde. Winslow George Carrington and Cde. Mohamed Kasim had ceased to be Ministers. As they were Elected Members of the Assembly, they continued to be Members thereof.
- (c) Cde. Robert Corbin and Cde. Jeffrey Thomas, who had been Parliamentary Secretaries, Ministry of Education and Social Development, and Ministry of National Development, had been appointed Ministers of State, Ministry of National Development, and Ministry of Health, Housing and Labour, respectively.
- (d) Cde. Seeram Prashad and Cde. Malcolm Corrica, who had been Parliamentary Secretaries, Ministry of Co-operatives and National Mobilisation, and Ministry of Works and Housing, had been appointed to be Parliamentary Secretaries to assist the Minister of Economic Development and Co-operatives, and the Minister of Education, Social Development and Culture, respectively.
