At the request of the Leader of the Opposition, permission was granted to him to move the adjournment of the Assembly at the appropriate time for the purpose of discussing reports from the Rupununi that the Amerindian population was facing near starvation.

PUBLIC BUSINESS

BILL - Second and Third Readings

REGIONAL DEVELOPMENT AUTHORITIES BILL 1977 - Bill No. 14/1977 published 4.6.77

The Minister of Economic Development and Co-operatives moved second reading of the following Bill:

A BILL intituled AN ACT TO PROVIDE FOR THE ESTABLISHMENT OF REGIONAL DEVELOPMENT AUTHORITIES.

Cde. Dalchand, the Leader of the Opposition and Mr. Singh spoke to the motion.

The Minister of Economic Development and Co-operatives replied.

The motion was then put and carried.

The Bill was read a second time.

Assembly resolved itself into Committee to consider the Bill clause by clause.

In Committee

Clause 1 was passed as printed.

Clause 2 - The Minister of Economic Development and Cooperatives moved the following amendment which was put and <u>carried</u>:

<u>Substitution</u> of the following definition of the expression "Minister":

"Minister" means such Minister as the Prime Minister may by notice in the Gazette designate as charged with the responsibility for an authority and in the absence of such designation the Minister assigned responsibility for regional development:

Clause 2 was then passed as amended.

Clauses 3 to 11 were passed as printed.

Clause 12 - The Minister of Economic Development and Cooperatives moved the following amendment which was put and carried:

Insertion immediately after subsection (3) of the
following as subsection (4):

"(4) It shall be deemed a term of every contract of service entered into between an authority and a person employed by it that such person is liable to be seconded or transferred by the authority to service in any department, agency or institution of the State or to any body corporate in which the controlling interest is vested in the State.".

Clause 12 was then passed as amended.

Clauses 13 to 16 were passed as printed.

Clause 17 was passed with the following amendment:

Substitution in subsection (6) of the words ", if he thinks fit and with the approval of the Minister" for the words "on the request of the Minister".

SUSPENSION OF STANDING ORDER NO. 9(2)

On a motion by the Minister of Information, Standing Order No. 9(2) was suspended to permit the sitting to continue without being suspended at $4.00 \, p.m.$

Clause 18 was passed as printed.

Clause 19 - The Minister of Economic Development and Cooperatives moved the following amendment which was put and carried:

Insertion immediately after subsection (2) of the
following as subsections (3) and (4):

" (3) Where an employee of an authority is seconded or transferred from service in an office in respect of which pension is payable to service in a like office of another authority, in computing the period of pensionable service in the last mentioned office there shall be reckoned the period of service in that office from which the employee was seconded or transferred.

(4) The pension payable in respect of the aggregated service mentioned in subsection (3) shall be discharged by each authority in such an amount as shall bear the same proportion to the amount of pension for which the employee would have been eligible had his service been wholly with the authority as the aggregate amounts of his pensionable emoluments during his service with that authority shall bear to the total amount made up of such aggregate amount toe gether with the aggregate amount of his pensionable emoluments from any other authority.".

Clause 19 was then passed as amended.

Clauses 20 to 22 were passed as printed.

Assembly resumed.

On a motion by the Minister of Economic Development and Cooperatives, the Bill was read the third time and <u>passed</u> as <u>amended</u>.

MOTION FOR THE ADJOURNMENT OF THE ASSEMBLY TO DISCUSS A DEFINITE MATTER OF URGENT PUBLIC IMPORTANCE

Reports of near starvation in the Rupununi

In accordance with permission granted earlier, the Leader of the Opposition moved the adjournment of the Assembly and spoke on roports of near starvation affecting the Amerindian population in the Rupununi.
