STATEMENTS BY MINISTERS

By the Prime Minister

The Prime Minister, in a statement placed on record in the Assembly the information he had already conveyed directly to the people of Guyana in his broadcast on the morning of Saturday, 26th May, 1973, the seventh anniversary of Independence, that it was his intention to advise His Excellency the President that the National Assembly should be dissolved on 6th June, 1973, and that a General Election of Members of the Assembly be held on Monday, 16th July, 1973.

The Prime Minister presented to the Assembly the text of the broadcast which he had made.

REQUESTS FOR LEAVE TO MOVE THE ADJOURNMENT OF THE ASSEMBLY ON DEFINITE MATTERS OF URGENT PUBLIC IMPORTANCE

The Leader of the Opposition sought leave to move the adjournment of the Assembly for the purpose of discussing the availability of the Registration and Voters Lists.

His Honour the Speaker did not allow the claim as he was satisfied that an ordinary parliamentary opportunity would occur shortly during consideration of the Representation of the People (Adaptation and Modification of Laws) Bill 1973, when the matter could be raised.

Presentation and First Reading

REPRESENTATION OF THE PEOPLE (ADAPTATION AND MUDIFICATION OF LAWS) BILL 1973 - Bill No. 9/1973 published 26.5.73

The Minister of Home Affairs, on behalf of the Government, presented the following Bill which was read the first time:

A BILL intituled AN ACT TO AMEND THE CONSTITUTION IN ACCORDANCE WITH ARTICLE 73 THEREOF FOR THE PURPOSE OF REDUCING THE AGE OF MAJURITY FOR ELECTURAL AND OTHER PURPOSES AND FOR DETERMINING THE NUMBER OF MINISTERS WHO MAY BE APPOINTED FROM AMONG PERSONS WHO ARE NOT ELECTED MEMBERS OF THE NATIONAL ASSEMBLY; AND TO MAKE PROVISION FOR THE ADAPTATION AND MODIFICATION OF LAWS RELATING TO THE ELECTION OF MEMBERS OF THE NATIONAL ASSEMBLY, FOR REDUCING THE AGE OF MAJURITY GENERALLY, AND FOR MATTERS CONNECTED THEREWITH.

PUBLIC BUSINESS

BILLS - Second Reading

GUYANA TIMBER EXPORT BUARD BILL 1973 - Bill No. 5/1973 published 17.5.73

The Minister of Mines and Forests moved the second reading of the following Bill:

A BILL intituled AN ACT TO PROVIDE FOR THE ESTABLISHMENT AND FUNCTIONS OF THE GUYANA TIMBER EXPORT BOARD AND FOR MATTERS CONNECTED THEREWITH.

Mr. Reepu Daman Persaud, Mrs. DaSilva and Mr. Sutton spoke to the motion.

The Minister of Mines and Forests was replying when the time for the suspension of the sitting was reached.

SUSPENSI N OF SITTING

At 4.05 p.m. the sitting was suspended for refreshments.

RESUMPTION OF SITTING

At 4.30 p.m. the sitting was resumed.

The Minister of Mines and Forests concluded his raply.

Thereafter, the motion was put and <u>carried</u>.

The Bill was then read a second time.

Assembly resolved itself into Committee to consider the Bill clause by clause.

In Committee

Clause 1 was passed as printed.

<u>Clayse 2</u> - The following amendment by the Minister of Mines and Forests was put and <u>Carried</u>:

Insertion of the following immediately after
 the definition of the expression "forest
 produce" -

"Minister" means the Minister assigned
responsibility for forestry; ! .

Clause 2 was then passed as amended.

Clause 3 was passed as printed.

<u>Clause 4</u> - The following amendment by the Minister of Mines and Forests was put and <u>carried:</u>

<u>Oeletion</u> of the words "As soon as practicable after" and <u>substitution</u> of the word "After" therefor.

Clause 4 was then passed as amended.

Clauses 5 to 15 were passed as printed.

<u>Clause 16</u> - The following amendment by the Minister of Mines and Forests was put and <u>carried</u>:

Insertion of the words "or 7(1)" immediately
after the symbol "(a)".

Clause 16 was then passed as amended.

Clause 17 was passed as printed.

The Schedule was passed as printed.

Assembly resumed.

Un a motion by the Minister of Mines and Forests, the Bill was read the third time and passed as amended in Committee.

ITEM 2 - WALLS PENSION BILL 1973 - Bill No. 6/1973 published 19.5.73

In accordance with article 80(2) of the Constitution, the Minister of State for the Public Service signified Cabinet's recommendation and moved the second reading of the following Bill:

A BILL intituled AN ACT TO MAKE SPECIAL PROVISION WITH RESPECT TO THE PENSION-ABLE SERVICE OF GEORGE WALLS.

The Bill was read a second time and was thereafter taken through its remaining stages and <u>passed</u> as <u>printed</u>.

At 5.20 p.m., on a motion by the Minister without Portfolio and Leader of the House, the Assembly was adjourned to 2.00 p.m. on Tuesday, the 29th of May, 1973.
