UNOFFICIAL NOTICES

Mr. Lee gave notice of he following motion: :-

WHEREAS Plantation Ridge, Wakenaam, was declared a Sea Defence area and the owners were compelled under the Sea Defences Ordinance, Chapter 118, to pay sea defence rates and did pay such rates for several years:

AMD WHMPEAS the said Defence rates were declared a Colonial question and the construction, repairs and maintenance of sea defence areas were made chargeable to general revenue:

AND WHEREAS the said Flantation Ridge, Wakenaam, is being inundated by the tides through the non-repairs of the koker which is part and parcel of the Sea Defences;

AND WHEREAS the said oker is further part and parcel of the public road of the island and as such Government is liable to aintain the said public road;

BE IT RESOLVED that t is Honourable Council recommend to Government the immediate repairs of the said koker and sea defence of the said frontal area of said Plantation Ridge, Wakenaam, in order to protect the owners and tenants of the said lands.

- Mr. Debidin gave notice of the following motions:-
- (a) WHEREAS the Mahaicony District is one of the largest, and most important rural districts in the Colony embracing as it does the Mahaicony Abary Rice Expansion Scheme, the large rice prowing and cattle areas on both banks of the Mahaicony Creek with a population spreading out to a distance of about thirty miles on both banks of the Mahaicony River, also containing the three local authorities of Eastern Mahaicony which tends from Plantation Park to the Abary hiver, the Central Mahaicony Local Authority, and Perth Village, and also embracing populated areas up to as far west as Plantations DeKenderen and Fairfield:

AND WHEFEAS Mahaico y is approximately midway between Georgetown and New Amsterdam, that is, approximately forty miles from the nearest public hospital;

AND WHEREAS there is a Government Medical Officer stationed at Central Mahaicony, but in very urgent cases most often necessitating an operation persons injured seriously in accidents, or taken seriously ill otherwise will have to be sent to Cerogetown for an operation, whereas immediate attention and facilities for hospitalising such cases for a few days might save many a life;

AND WHEREAS also there is no mortuary in this district;

BE IT RESOLVED that this Honourable Council recommend to Government -

- (a) the establishment of a cottage hospital at Central Mahaicony; and
- (b) the erection of a mortuary at Central Mahaicony.
- (b) WHEREAS it is desirable that a contributory pension scheme be established for the whole Colony with universal application wherever there is the relationship of employer and employee;

AND WHEREAS the Colony is in need of money to finance certain development schemes which would result in a greater measure of prosperity to the Colony generally, e.g., making available through Loan Banks or otherwise more money to more peasant farmers for more production of rice, cattle, milk, provision, etc., and for crection of houses;

AND WHEREAS if the aforesaid Colony-wide pension scheme be made a Government controlled undertaking, there would be a considerable revolving sum in the hands of Government which can be used as aforesaid;

BE IT RESOLVED that this Honourable Council, accepting the principle of the establishment of a colony-wide pension scheme, recommend to Government the appointment of a select committee of this Council to consider and report on -

- (a) the establishment and application of a colony-wide pension scheme;
- (b) the expediency and manner of Government controlling the same; and
- (c) the purpose or purposes to which funds in hand of the Government may be devoted in the interest of the development of the Colony.

(c) WHEREAS in this Colony there is no law and procedure laid down for the adoption of children and many instances have arisen and will always arise where a person may wish to ado t a child;

AND .HEREAS such a person adopting a child today would merely be putting himself or herself in loco parentis towards such child with all legal rights, liabilities and duties of parent towards the child still vested in the true parent;

AND WHEREAS such questions as an adopted child inheriting as of right under the Estate of an adopted parent and so forth can only be provided for by logislation such as obtains in England;

AND WHEREAS similar legislation as exists in England for the adoption of children in this Colony is overdue;

BE IT RESOLVED that this Council request Government to enact an Ordinance to contain similar provisions as the Adopti n of Children Act, 1926, (16 and 17 George V Chapter 29) and that a Select Committee be appointed for the purpose of settling the provisions of the said act or otherwise which should be contained in such Ordinance.

) SEPPERS the Village of Moheic

(d) WHEREAS the Village of Mahaica-Helena-Supply has always been and is still one of the Colony's largest villages, and is central to a very large number of other populated areas namely La Bonne Mere, Cane Grove, Mahaica Creek, Chelsea Village, Vygeval, DeHoop, Manilla, Strangroen, Content, Columbia, Glazier's Lust, Rebecca's Rust, Broek-en-Water-Land, Lancaster, Unity, etc., etc.;

AND WHEREAS since the closing down of the Sugar Estates at Plantation Ca e Grove the hospital at Cane Grove has been closed;

AND WHEREAS there is no mortuary in the aforesaid districts, and the nearest mortuary used in respect of any cases from the aforesaid districts is at Plantation Enmore, East Coast, Demerara;

AND WHEREAS this results in the greatest hardship and inconvenience to these in the aforesaid districts;

BE IT RESOLVED that this Honourable Council recommend to Government that steps be taken immediately for the erection of a proper mortuary at some convenient place at Mahaica, East Coast, Demorara.

(e) WHERE S the Village of Mahaica-Helena-Supply has always been and is still one of the Colony's largest villages, and is central to a very large number of other populated areas namely La Bonne Mere, Cane Grove, Mahaica Croek, Chelsea Village, Vygeval, DeHoop, Manilla, Strangroen, Content, Columbia, Glazier's Lust, Rebecca's Rust, Broeken-Water-Land, Lancaster, Unity, etc., etc.;

AND WHEREAS these districts have been served before, when the population had not been as great, by a medical officer residing at Mahaica;

ND WHEREAS since te closing down of the sugar estate at Flantation Cane Grove the hospital at Cane Grove has been closed;

AND WHEREAS the above districts are served by a Government Medical Officer residing at Belfield, East Coast, Demerara, about ten miles distant from Mahaica, and in the cale of some of the abovementioned districts about twenty miles distant;

AND WHEREAS the sick, injured, maternity cases, etc., suffer the greatest inconvenience one can imagine to obtain quick and adequate medical attention, relief and treatment, and having regard to the growing importance of the growing population of the area covered by the above districts -

BE IT RESOLVED that this Honourable Council recommend that Government take steps -

- (a) to establish a cottage hospital in the Mahaica Village aforesaid;
- (b) provide for a Go ernment Medical Officer to be resident at Mahaica; and
- (c) that pending the establishment of the Cottage Hospital aforesaid a Government dispensary with full first-aid facilities, and a whole-time Sick Nurse and Dispenser be established immediately at M haica.
- (f) WHEREAS the rural districts of the Colony, and particularly the river districts and other remote areas are very inadequately served by qualified midwives;

AND WHITEAS in a good many of these areas the residents have to depend upon unqualified persons for midiwfery attention;

A! D WHEREAS in order to keep down the Colony's expenditure, and at the same time provide a more adequate service throughout the Colony, it is very desirable that a scheme be immediately inaugurated whereby young women with permanent residence in the very areas to be served may be given a course of training in midwifery, and be registered as midwives;

AND WHEREAS this could be arranged at no great expenditure by the Medi al Department of the Colony;

BE IT RESOLVED that his Honourable Council recommend to Government the very carly establishment offacilities for the training of a sufficient number of women drawn from the rural areas of the Colony, particularly of the remote districts, a course of midwifery, practical and theoretical with a view to their being registered as midwives;

AND BE IT FURTHER RESOLVED that this Council recommend the appointment of a Select Committee to consider all the details involved by the aforesaid recommendation, and report thereon to this Honourable Council as early as possible.

(g) WHEREAS farmers through ut the Colony have been suffering severe set-backs from time to time from droughts, floods, and to a smaller degree from pests and other causes;

AND WHEREAS with the high cost of living and the very small scope for emloyment of the increasing population, the population in the main will have to depend more and more upon the land for a living;

AND WHEREAS recent floodings have shown how scriously the population can be affected;

BE IT RESOLVED that is Honourable Council recommend to Government the establishment of a Government controlled insurance for farmers in the Colony against loss of cattle and crops from floods, droughts and oth r causes and that a Committee be appointed by His Excellency and the Govern or to go into the matter and report thereon.

(h) WHEREAS the East Demerar. Water Conservancy of an area of 221 square miles releases its water in the wet seasons through four sluices and sometimes through cuts made in the dams exclusively into the Mahaica River, and this volume of thousands of millions of cubic feet of water released per day is far in excess of what the river can discharge per day, and would inevitably cause abnormal floodings of the lands not only on either bank of the Mahaica River, but also of lands in the Mahaicony River districts;

MD WHEREAS there has been a most disastrous flooding in the early part of the year 1950, affecting the above areas which was aggravated by the water from the East Demerara Water Conservancy in so far as these areas are conce ned resulting in serious destruction of crops and other losses;

AND WHEREAS more water is being conserved in the Conservancy with a great r threat to the conservancy

dams during rainy weather, and there is more frequent floodings of the a ove areas experienced as a result of the necessity for letting out the excess water into the Maraica River;

AND WHEREAS it is now beyond the point of exasperation on the part of the pent ants in their recurrent sufferings:

AND WHEREAS the Consulting Engineer of the Colony has expressed the opinion that it is not an engineering impossibility to drain all excess water from the Conservancy in wet seaso a through the Demerara River, and he feels it is work to be done whether now or in the future;

AND WHARGAS this work is an urgent and immediate necessity;

BE IT RESOLVED that this Honourable Legislative Council recommend to Government that steps be taken very soon to build the necessary outlet to the Demerara River in order to drain all excess water from the East Demerara Water Conservancy in wet seasons through the Deme ara River instead of through the Mahdi ca River.

Mr. Fernandes gave notice of the following motion:

BE IT RESOLVED that this Council recommend to Government that a subside be granted to the St. Stanislaus College.

- 5. What amounts each owner of the aforesaid oils received in respect to such shipments?
- 6. What revenue was gained by the Colony from the exportation of the aforesaid oils?

- 7. Who or what authorit was res onsible for, or gave the sanction fo such exportations of crude coconut oil and refiled oil in 1950?
- 8. What was the total a nual production of coconuts in the Colony for the last five years?
- 9. What was the total a nual production of (a) crude coconut oil (b) refi edoil over the said period of five years?
- 10. What was the total number of drums which were available for the st rage of concount oil (crude and refined) for each of the years between 1945 to 1950, and at the present time?
- 11. Has Government made Iny effort to increase the number of drums for such storage during the year 1950, and during this year? If so, what is the nature of the effort?
- 12. What is the personne of the Committee presently appointed to report in the coconut oil industry of which the Directo, of Agriculture is Chairman?
- 13. What is the qualific tion and/or connection with the coconut industry of each member of such Committee?
- 14. What is the quantity of copra meal produced in each of the last five years?
- 15. To whom was copra meal sold and distributed in any of the past five years for which this information may be obtained from a Government Department?
- 16. Those who received in any one year less than one ten may be grouped under Miscellaneous. In particular what quan ities of copra meal were sold to -
 - (a) Booker Bros. M Connell & Co. Ltd.
 - (b) Gladys Hicken & Co. Ltd.
 - (c) Sugar Estates
 - (d) Other concerns
