<u>Clause 20</u> - was passed with the following amendments: (i) sub-clause (2) was deleted; and (ii) sub-clauses (3), (4) and (5) were re-numbered as (2), (3) and (4),

- (A) The Financial Secretary moved the following amendments:
 - (i) <u>Sub-clause (1)</u>:

The insertion of the words "who is qualified to be appointed as an auditor under subsection (8) of

- Cap.328 section 109 of the Companies Ordinance or by a person" between the words "auditor" and "approved" in the penultimate line.
 - (ii) Sub-clause (2):

The substitution for the words "previous year" at the end thereof of the words "preceding period of twelve months ending on the thirtieth day of September of the year during which the books have been audited".

(iii) <u>Sub-clause (3)</u>:

The deletion of sub-clause (3) and the substitution therefor of the following:

"(3) A moneylender's licence shall not be granted except on the production of the auditor's certificate required by subsection (2) of this section in respect of the preceding period of twelve months therein specified."

(iv) Sub-clause (4):

The deletion of this sub-clause.

(B) Mr. Carter moved the insertion of the words "or part thereof" between the words "months" and "ending" in the amendment proposed by the Financial Secretary to sub-clause (2).

After discussion, sub-clause (1) was amended as proposed by the Financial Secretary and passed.

Sub-clause (4) was deleted.

Further consideration of the Clause was deferred.

Clauses 27 to 29 - were passed as printed.

<u>Clause 14</u> was re-committed and passed with the following amendment:

The substitution of the words and figures "the proviso to section 13" for the words and figures "section 12" in the fifth line.

<u>Clause 12</u> - was re-committed and on a motion by Mr. Correia the new paragraph (a) of sub-clause (1) was amended as under and passed:

> <u>Substituted</u> - t e words "twelve per centum" for the words "ten per centum".

Further consideration of the Bill was deferred to the next meeting.
