MOTIONS

Item 2 - MOTION TO APPROVE SCHEMES AND ALLOCATIONS OF THE DEVELOPMENT PROGRAMME, 1960-1964.

Council resumed the debate on the following motion:-

BE IT RESOLVED:

That this Council approves of the schemes and allocations as set out in the Development Programme, 1960-1964 - Sessional Paper No. 5 of 1959.

Mr. Davis concluded his speech.

Mr. Fredericks, Mr. RamKarran and Mr. Hubbard spoke to the motion. The Financial Secretary then replied.

Thereafter, the question was put and carried.

Item 3 - MOTION TO APPROVE OF AN AMENDMENT OF PART IV OF THE FIRST SCHEDULE TO THE CUSTOMS ORDINANCE.

On a motion by the Financial Secretary seconded by the Attorney-General, Council adopted the following Resolution:-

RESOLVED, That this Council in terms of section 7 of the Customs Ordinance, Chapter 309, approves of the amendment of Part IV of the First Schedule to the Customs Ordinance, Chapter 309, by the addition of "Alumina" as Item 9 and "Manganese ore" as Item 10 in the list of exemption from export duties of customs.

BILL - Committee and Third Reading.

Item 4 - LAND BONDS BILL, 1959 - Bill No. 19/1959.

Council resolved itself into Committee to resume consideration of the BILL intituled AN ORDINANCE TO MAKE PROVISION FOR THE SATISFACTION OF THE WHOLE OR ANY PART OF THE PURCHASE MONEY OR OF THE COMPENSATION PAYABLE BY THE GOVERNMENT OF BRITISH GUIANA IN RESPECT OF THE PURCHASE OR COMPULSORY ACQUISITION OF ANY LAND BY THE ISSUE OF BONDS, AND FOR THE ISSUE, NEGOTIABILITY AND REDEMPTION OF SUCH BONDS, AND THE PAYMENT OF INTEREST THEREON AND FOR MATTERS INCIDENTAL TO OR CONNECTED WITH ANY OF THE FOREGOING PURPOSES.

In Committee

- Clause 3 The Attorney-General referred to the question raised by Mr. Burnham at the meeting of the 1st October, and explained that to give effect to Mr. Burnham's suggestion it would be necessary to amend Clauses 4 and 6 instead. Clause 3 was then put and passed as printed.
- Clauses 4 and 6 were re-committed and amended as under and passed:-
 - Clause 4 Inserted: The words "of such type as the Governor in Council determines" after the word "bonds" in the fifth line.
 - Clause 6 Subsection (3) Inserted: The words "of the type determined by the Governor in Council" after the word "bonds" at the end of the tenth line.

Council resumed.

On a motion by the Minister of Natural Resources seconded by the Attorney-General, the Bill was read the third time and passed as amended in Committee.

Item 5 - DEVELOPMENT FUND (1958 APPROPRIATION) BILL, 1959 - Bill No. 25/1959.

On a motion by the Financial Secretary seconded by the Attorney-General the BILL intituled AN ORDINANCE TO MAKE PROVISION FOR THE APPROPRIATION TO THE DEVELOPMENT FUND OF A CERTAIN SUM OF MONEY TRANSFERRED THERETO FROM THE REVENUES AND FUNDS OF BRITISH GUIANA was read a second time and was thereafter taken through its remaining stages and passed as printed.

Item 6 - CUSTOMS (AMENDMENT NO. 3) BILL, 1959 - Bill No. 26/1959.

On a motion by the Financial Secretary seconded by the Attorney-General, the BILL intituled AN ORDINANCE TO AMEND THE CUSTOMS ORDINANCE was read a second time and was thereafter taken through its remaining stages and passed as printed.

Item 7 - CUSTOMS (AMENDMENT NO. 4) BILL, 1959 - Bill No. 27/1959.

On a motion by the Financial Secretary seconded by the Attorney-General, the BILL intituled AN ORDINANCE TO AMEND THE CUSTOMS ORDINANCE was read a second time and was thereafter taken through its remaining stages and passed as printed.

Item 8 - EXPORT OF TIMBER (AMENDMENT) BILL, 1959 - Bill No. 24/1959.

On a motion by the Minister of Natural Resources seconded by the Minister of Labour, Health and Housing the BILL intitule d AN ORDINANCE TO AMEND THE EXPORT OF TIMBER ORDINANCE was read a second time and was thereafter taken through its remaining stages and passed as printed.
