1. FIGHT AGAINST HIV/AIDS

Member Asking:

Mr. Everall Franklin, M.P.

Minister Answering:

The Minister of Health

The Minister of Health has aggressively tackled stigma and discrimination in the fight against HIV/AIDS on the one hand. Would the Minister consider legislation at this time, which would punish individuals who knowingly infect persons with the AIDS Virus?

Answer:

After extensive consultation, HIV Legislation has been drafted. This has been submitted to the Attorney General's Office and we expect to submit a final draft for Cabinet consideration by the end of the year. The proposed legislation intends to make provisions to address the problem of people knowingly infecting others with HIV.

2. MULTI DRUG RESISTANT TB CASES WITHIN GUYANA

- (i) Can the Minister of Health inform this Assembly on any particular measure(s) being undertaken to reduce the number of Multi Drugs Resistant TB cases within Guyana?
- (ii) What legislation is required to control the spread of Multi Drug Resistant TB cases?
- (iii) What measures are in place to prevent the overstocking of TB drugs? (Notice Paper No. 362 (Q270 Opp255) published on 2009-01-30)

Answers:

(i) Measures to Reduce MDR-TB

The health system actively detects and apply prompt treatment according to the WHO recommended DOTS strategy for the control of TB. The key measure to reduce MDR-TB is to use a combination of standard medicines and implement strict supervision of all on treatment.

The DOTS Strategy requires:

- All TB cases be placed on a combination of at least 4 first line anti-TB medications (INH, Rifampicin, PZA and Ethambutol) for no less than 6 months.
- All patients on anti-TB medication be supervised by a TB outreach worker (DOTS worker
 or community Health Worker), who visits the home of such patients and observe them
 taking each dose of the treatment until cured.
- Patients and their relatives be counseled on the vital importance of taking all prescribed treatment for the defined period.
- Sputum smears be done routinely at the initial diagnosis, at 2, 4 and 6 months while on treatment to ensure that the medicines are working as they should and no resistance is developing. With the standard regimen, sputum conversion occurs at about 2 months of treatment and complete cure can be achieved by 6 months.
- Sample of sputum from all patients not responding to the first line treatment are cultured and sensitivity testing conducted to detect resistance to any of the four first line medicines.
- Patients defaulting from treatment are actively traced and placed on appropriate regimen following re-investigation. It is among those that default from treatment that the risk of emergence of resistant TB emerges.
- Some short periods of hospitalization is necessary for some defaulters so as to reduce the chance of MDR-TB developing.
- (ii) The existing quarantine legislation is inadequate. In addition, new quarantine legislation is needed for several emerging and existing infectious disease that threatens globally, e.g. SARS. These are being drafted and will be presented to this Honourable House shortly.

Enforcement of the existing legislation can provide some legal support so that the health system can maintain TB patients on the prescribed treatment until a cure is archived. This requires some restriction of movement around the country or assisted movement if necessary so that the treatment supervision can be transferred to another health worker to follow up and observe treatment.

(iii) TB medicines are procured based on estimates of a modern quantification software (Quantimed). This software package uses the current TB incidence information along with the consumption patters to calculate the stocking levels need. The software adjusts the estimates to provide for a buffer stock of about 4 – 6 months supply. This reduces the burden of possible stock outs that frequently occurred in the TB program during the 1980's and early 1990's and which hinder full treatment of all cases.

Over stocking and stock-outs are not a usual problem for anti-TB medication in Guyana.
