MAINTENANCE OF ROAD FROM STANLEYTOWN TO MARA

Member Asking:

Mr. Robert H. O. Corbin, M.P., Leader of the Opposition

Minister Answering:

The Minister of Public Works and Communications

Since millions of dollars are expended annually for the maintenance of the East Bank Berbice Road, from Stanleytown to Mara, and the said road is constantly in a deplorable state, causing severe difficulties and inconvenience to residents and road-users, forcing them to regularly engage in protest activity over their neglected conditions, could the Honourable Minister provide answers to the following:

- (a) How much money has been spent annually for the past ten years, i.e., 1998 to 2008, for the maintenance of the East Bank Berbice road?
- (b) Could the Minister identify the specifics of the allocated expenditure by the respective year, indicating the amounts that were spent; the sections of the road maintained with the approved expenditure; the name/s of the contractor/s involved; and, whether there were satisfactory completion certificates issued at the end of each job and by whom were they signed?
- (c) Whether it would not make economic sense and reflect more prudent use of our financial resources if, instead of the piecemeal maintenance approach to the East Bank Berbice Road, a comprehensive road building project is implemented even if such a project is phased over a few years?

(d) How soon does the government plan to address the immediate problem of the present deplorable state of the road as emphasized by residents in their recent demonstrations?

Answers:

"The road from Stanleytown to Mara, East Bank Berbice is approximately 40 kilometres, (25 miles) in length. It goes through primarily farming communities.

During the past ten (10) years the Ministry of Public Works and Communications and Regional Administration, Region No. 6, have carried out routine and periodic maintenance works on the 40 kilometres stretch of road as shown in the table below:

- (c) It is true that it would make economic sense to carry out a comprehensive maintenance/construction programme for the 40 kilometres stretch of road on the East Bank Berbice road but since limited funds have been provided over the years, maintenance works have been carried out in accordance with the funds allocated.
- (d) Efforts are being made to address the immediate problem of certain deplorable sections of the road. In this regard the Ministry's Force Account Unit has commenced routine maintenance works in the Stanleytown to Glasgow area. The estimated cost is \$18M."

WHEREAS this Treaty is the constitutive legal instrument of the Union of South American Nations (UNASUR) which was founded by Argentina, Bolivia, Brazil, Chile, Colombia, Ecuador, Guyana, Paraguay, Peru, Suriname, Uruguay and Venezuela, and signed by the said Nations on May 23, 2008 in Brasilia, Brazil;

AND WHEREAS this Treaty is designed to strengthen political and economic cooperation and dialogue between/among member states, and to advance continental integration;

AND WHEREAS Guyana is desirous of ratifying this Treaty.

BE IT RESOLVED:

That this National Assembly approves Guyana's ratification of the Constitutive Treaty of the Union of South American Nations (UNASUR).

WHEREAS the Republic of Trinidad and Tobago will host the Commonwealth Heads of Government meeting from 21st to 30th November, 2009;

AND WHEREAS the Government of Guyana joined with the CARICOM countries to offer security support to the Government of the Republic of Trinidad and Tobago;

AND WHEREAS the Government of Guyana has pledged the deployment of Guyana Defence Force military personnel on a security support mission;

AND WHEREAS the management and operation of troops deployed by the Government of Guyana shall be in accordance with the Visiting Forces Act 2007 of Guyana, the Visiting Forces Act of Trinidad and Tobago and the Treaty of Security Assistance among CARICOM Member States.

BE IT RESOLVED:

That this National Assembly honours the pledge of the Government of Guyana and approves the deployment of such personnel to the Republic of Trinidad and Tobago for the purpose and period stated.

WHEREAS this Convention was adopted by the 33rd General Conference of UNESCO in October, 2005 and entered into force on 18th March, 2007;

AND WHEREAS the Convention addresses the need to recognize that cultural goods and services convey identity, values and meaning and consequently cannot be considered mere goods. And the need for States to take appropriate measures to protect and promote diversity of cultural expression while allowing the free flow of ideas and works;

AND WHEREAS Guyana is desirous of acceding to this Convention.

BE IT RESOLVED:

That this National Assembly approves Guyana's accession to the Convention on the Protection and Promotion of the Diversity of Cultural Expressions.

MOTION

ITEM 4 - SUSPENSION OF SALE OF GOVERNMENT SHARES IN G.T.&T. INC.

Mr. Robert H. O. Corbin, M.P., Leader of the Opposition, moved the following motion:

WHEREAS the wholly owned State Corporation, Guyana Telecommunications Corporation, (G.T.C.), was privatized by the Guyana Government on specific terms, which included, the retention by the Government of Guyana of 20% (twenty percent) shareholding in the new privatized Company, Guyana Telephone and Telegraph Company (G.T.&T. Inc);

AND WHEREAS the said terms of privatization included provisions for the Government of Guyana to appoint at least one member on the Board of Management of the Company to ensure that the interest of the people of Guyana could be represented and safeguarded;

AND WHEREAS Guyana has benefited from the operations of the new Company to the tune of millions of dollars in taxes and dividends from the Company, reported in 2008 to be as high as \$1.5B in taxes and \$265M in dividends and approximately \$US1M to US\$4M annually;

AND WHEREAS it is the workers of GT&T who have made that company into an effective and efficient organization;

AND WHEREAS the 20% ownership in GT&T did not in any way inhibit or prevent the Guyana Government from permitting other telecommunications and internet operators from doing business in Guyana as is evident from the continued operation of DIGICEL, for several years now in Guyana;

AND WHEREAS the retention of Government's 20% shareholding in GT&T has facilitated a significant stream of revenues in the form of dividends to the people of Guyana, not withstanding the existence of other competing telecommunication operators in Guyana;

AND WHEREAS, not withstanding this stream of revenue, the Government has announced plans of its intention to dispose of its 20% shares in the GT&T Company;

AND WHEREAS the retention of a 20% shareholding in GT&T cannot or should not affect the implementation of a government's policy of liberalizing the Telecommunications Sector;

BE IT RESOLVED:

That this National Assembly calls on the Government of Guyana to appoint an objective professional group to assess the Cost/benefit to the people of Guyana, of sale versus retention of the said shares;

BE IT FURTHER RESOLVED:

That this National Assembly calls on the Government of Guyana to suspend the decision to dispose of its 20% shareholding in GT&T until the review is completed by the appointed professional group; and

BE IT FURTHER RESOLVED:

That, should the review group recommend that the shares be disposed of, the first option for disposal of these shares should be to the workers of the Company, thereafter a transparent process, to publicly announced, should be followed for the disposal of the said shares or for such number of the shares not bought by the workers of the Company.
