Clause 21 was passed with the following amendments.

Substitution of the word “each” for the word “such”  
in the first line of paragraph (a) of subsection (1).

Insertion of the words “work or within a radius of ten  
miles” between the words “of” and “therefrom” in the  
Fourth and fifth lines of paragraph (b) of subsection (4).

Clauses 22 to 25 were passed as printed.

AND WHEREAS the said Agreement, which was opened for signature at the United Nations Headquarters from April, 1994, has been signed by Guyana on September 13, 1996;

1st January, 1997;

AND WHEREAS the said Agreement enables Guyana to continue  
its membership of the International Tropical Timber Organisation;

AND WHEREAS the said Agreement will provide a framework  
from which Guyana will be able to benefit financially, technically and  
otherwise;

AND WHEREAS the said Agreement will help to promote and  
support research and sustainable development with a view to improving  
forest management and efficiency of wood utilisation as well as increase  
the capacity to conserve and enhance other forest values in timber  
producing countries:

BE IT RESOLVED:

That the National Assembly hereby endorse the  
decision to ratify the International Tropical Timber Agreement  
of 1994.

ESTABLISHING THE CARIBBEAN COMMUNITY

WHEREAS the Protocol I amending the Treaty Establishing the Caribbean Community signed at Chaguaramas on 4th July, 1972, was signed by the Heads of Government at the Eight Inter-Sessional Meeting of the Conference of Heads of Government of the Caribbean Community which was held in Antigua and Barbuda during the period 20th - 21st February, 1997;

AND WHEREAS the said Protocol I was signed by H.E. Dr. Havelock Brewster, Ambassador to Belgium and to the European Union on behalf of the Government of Guyana;

AND WHEREAS this Protocol deals with the restructuring of the Organs and Institutions of the Caribbean Community redefining their functional relationships in the integration movement;

AND WHEREAS this Protocol is a response to the need to deepen the integration movement through the establishment of the CARICOM Single Market and Economy in order to achieve sustained economic development, international competitiveness, coordinated economic and foreign policies, functional cooperation and enhanced trade and economic relations with other countries;

AND WHEREAS Guyana remains committed to the set goals and objectives of the Caribbean Community in this new era of globalisation

BE IT RESOLVED:

That the National Assembly hereby agree to the ratification of the said Protocol I by Guyana.

AND BE IT FURTHER RESOLVED:

That the National Assembly hereby agree to the Secretary-General of the Caribbean Community being informed of Guyana's ratification of the said Protocol I by the deposit of an appropriate Instrument of Ratification. (Notice Paper No. 117(M79 Govt. 80) published 31.7.97)
