<u>ANNOUNCEME</u>NTS BY THE SPEAKE<u>R</u>

(i) Vacating of Seats in the National Assembly by Members of the People's National Congress

The Deputy Speaker read the following statement which was prepared by the Speaker:

On the 30th January, 1998 The Elections Commission, pursuent to Article 60 (2) of the Constitution and section 99 of The Representation of the People Act, Chapter 1:03, published in the Official Gazette the names of the 53 persons who became members of the National Assembly. Among those named were 22 persons from the People's National Congress' list of candidates as follows:-

Pursuant to Article 60(3) of the Constitution and section 54 of the

Local Democratic Organs Act 1980, Act No. 12 of 1980.

The Elections Commission published in the Official Gazette of the 16th February, 1998 the names of the 10 (ten) persons of the 10 (ten) regions who became members of the National Assembly.

Among the ten persons were Joseph Hamilton for Region 4, Demerara/Mahaica Region, Kelly Andries for Region 7, Cuyuni/Mazaruni Region and Sandra Adams for Region 10, Upper Demerara/Berbice Region.

Members of the National Assembly are entitled to salaries and allowances as enacted by the Ministers, Members of the National Assembly and Special Offices (Emoluments) Act, Chapter 1:07.

Section 6 of the said Act deals with the commencement and suspension of payments and states as follows:-

- 6(1) The payments to which any member of the National Assembly may be entitled by virtue of this Act, shall be made with effect from the date on which the member was declared elected to the National Assembly, and where a person is appointed to be a Minister or Parliamentary Secretary, or the Minority Leader, or is elected to be the Speaker or the Deputy Speaker of the National Assembly, the appropriate payments shall be made to him as a Minister or Parliamentary Secretary or the Minority Leader or a#Speaker or Deputy Speaker of the National Assembly with effect from the date on which he commences to hold such office.
- 6(3) Where a member of the National Assembly fails to make and subscribe the oath of Office required by article 167 of the Constitution on the date of the first sitting of the National Assembly after his election, no payment shall be made under this Act to the member in relation to his Office as such member with respect to the period commencing on the date of the first sitting of the National Assembly and ending on the day imm. ediately preceding the date on which he makes and subscribes the oath unless his failure to make and subscribe the oath is for a reason approved, by resolution, by the National Assembly."

In a layman's language it means that as soon as a person is declared elected as a Member of the National Assembly he is entitled to receive salary and allowances but if a Member after he has been so elected fails to make and subscribe to the oath of office on the date of the first sitting of the Assembly after his election the payment of his salary and allowances will be suspended until he makes and subscribes to the oath, unless the National Assembly approved of a reason for his failure to make and subscribe to the oath.

The making and subscribing to the oath of office is also required by Article 167 of the Constitution, before a Member of the National Assembly can take part in the proceedings of the Assembly.

So the failure to make and subscribe to the oath will result in the suspension of salary and allowances and the prevention of taking part in the proceedings of the National Assembly.

The failure to make and subscribe to the oath, however, does not affect the status of a person named as an Elected Member of the National Assembly and he may attend the sittings of the Assembly until he has vacated his seat.

Article 54 of the Constitution states as follows:"Members of the National Assembly shall vacate their seats in the Assembly in the circumstances set out in Article 156."

Article 156 of the Constitution sets out a number of ways in which "a member of the National Assembly shall vacate his seat."

Article 156 (1) (b) states "if he is absent from the sitting of the Assembly for such period and in such circumstances as may be prescribed in the rules of procedure of the Assembly."

Honourable Members, as you are aware the rules of procedure of the Assembly are the Standing Orders of the National Assembly.

Standing Order 77 deals with absence of Members.

Standing Order 77 (2) states as follows:-

"If without the leave of the Speaker obtained in writing before
the end of the last of the sittings referred to in this paragraph,
any elected Member is absent from the Assembly for more than
six consecutive sittings occurring during the same session
and within a period of not longer than two calendar months,
he shall vacate his seat in the Assembly under articles 54 and
156 (1) (b) of the Constitution."

vacated their seats in the National Assembly in accordance with Articles

54 and 156 (1) (b) of the Constitution and Standing Order 17.

Honourable Members, in the minutes of the 8th Sitting of the National Assembly of the First Session of the Third Parliament of Guyana it is recorded that the then Speaker Mr. Sase Narain, J.P. had informed the Assembly that Dr. Ganraj Kumar who was declared an elected Member of the National Assembly in 1973 had been absent for seven consecutive

sittings of the Assembly and had therefore vacated his seats. Mrs. Elinor

Da Silva was on the same list of candidates as Dr. Kumar and her name

was extracted from the list and she was declared a Member of the Assembly to fill
the vacancy left by Dr. Kumar.

Honourable Members, like Ganraj Kumar, the 25 former Members of the Peoples National Congress did not attend and/or subscribe to the oath of office in accordance with Article 54 and 156 (1) (b) of the Constitution and Standing Order 77 and therefore by operation of law vacated their seats."

Long Title

Substitution of the words "and of members elected by certain Regional Democratic Councils became vacant" for the words "became vacant."

Clause 5

Substitution of the words "members, including those elected by the Regional Democratic Councils," for the word "members."
