# OATES

(i) <u>Cde</u> <u>Dr. Mchamed Shahabuddeen</u> <u>O.R.</u> <u>S.C.</u> <u>M.P.</u> <u>Vice-President</u> <u>and Attorney General</u>

The Deputy Speaker informed the Assembly that he had been advised that consequent on recent Cabinet changes, Cde. Dr. Mohamed Shahabuddeen, who was not an elected Member of the National Assembly, had ceased to be Minister of Justice and he had been appointed a Vice-President. He however, again became a Minister and a Member of the Cabinet by virtue of his holding the Office of Vice-President. He had ceased to be a Member of the National Assembly when he had ceased to be Minister of Justice but again had become a Member of the National Assembly on his appointment as a Vice-President. He, therefore, had to take a fresh oath as a Member of the National Assembly. As Cde. Dr. Shahabuddeen was present, the oath was administered to him.

## (ii) <u>Cde Carl B. Greenidge. M.P. Minister of Finance and Economic</u> <u>Planning</u>

The Deputy Speaker also informed the Assembly that in the recent changes, Cde. Carl B. Greenidge had been appointed a Minister and although Cde. Greenidge was not an elected Member of the National Assembly he had by virtue of holding the Office of Minister, become a Member of the Assembly. It was, therefore, necessary for him to make and subscribe the oath as a Member of the Assembly. That would, however, have to be done on another occasion, as Cde. Greenidge was out of Guyana.

# (111) Cde, Harripersaud Nokta, M.P.

Finally the Deputy Speaker informed the Assembly that following the resignation of Cde. Dalchand as a Member of the National Assembly, and a call upon the representative of the list from which Cde. Dalchand's name had been extracted, the name of Cde. Harripersaud Nokta had been further extracted from the list and Cde. Nokta had on 13th September, 1983, been declared to be elected a Member of the Assembly to fill the vacancy.

As Cde. Nokta was present, the oath was administered to him.

## ANNOUNCEMENTS BY THE SPEAKER

### (1) <u>Resignation of Cde. S.S. Naraine A.A.</u>

The Deputy Speaker announced that a letter dated 14th October, 1983, had been received from Cde. S.S. Naraine, who had been Vice-President, Social Infrastructure, tendering his resignation as a Member of the National Assembly. In his letter Cde. Naraine had expressed his thanks to the Speaker and to the other Members of the Assembly and also to the Clerk and other Staff of the Assembly for the co-operation given to him in the discharge of his functions. With Cde. Maraine's resignation, a seat in the Assembly had become vacant.

The representative of the list of candidates from which Cde. Naraine's name had been extracted, had therefore been called upon, in accordance with section 99Å of the Representation of the People Act, Chapter 1:03, to further extract from the said list the name of another person to fill the vacancy.

It was understood that Cde. Naraine had been appointed Guyana's High Commissioner in India.

### (2) New <u>Appointments and Changes</u>

The Deputy Speaker stated for the record, the changes which had been recently announced, in so far as they affected the membership of the National Assembly:

- (a) Cde. H.D. Hoyte, who had been Vice-President, Administration had been assigned other responsibilities, and had been redesignated Vice-President, Production.
- (b) Cde. H. Green, who had been Vice-President, Production, had been assigned other responsibilities, and had been re-designated Vice-President, Social Infrastructure.
- (c) Cde. Dr. M. Shahabuddeen, who had been Attorney General and Minister of Justice, had been appointed a Vice-President, and had been re-designated Vice-President and Attorney General.
- (d) Cde. C.B. Greenidge, had been appointed a Senior Minister and had been designated Minister of Finance and Economic Planning.
- (e) Cde. S. Prashad, an elected member of the National Assembly, had been appointed a Minister, and had been designated Minister of Transport within the Vice-Presidency of Social Infrastructure.

- (f) Cde. H.L.B. Singh, who had been Minister of State within the Ministry of Finance, had been assigned other responsibilities, and had been re-designated Minister of State within the Ministry of Regional Development.
- (g) Cde. B. Bhaggan, who had been a Parliamentary Secretary within the Ministry of Foreign Affairs, had been given other functions, and had been re-designated Parliamentary Secretary in the Office of the Prime Minister.

## (3) <u>Welcome and Congratulations</u>

The Deputy Speaker on bohalf of Members welcomed back to the Assembly Cdes. Shahabuddeen and Nokta. He congratulated Cde. Shahabuddeon on his further appointment as a Vice-President and Cde. Nokta on his election as a Member of the Assembly.

He also congratulated and extended best wishes to Cdes. Naraine, Hoyte, Green, Prashad, Singh and Ehaggan on their respective new appointments and assignments.

#### MOTION INVASION OF GRENADA

The Prime Minister moved the following motion:

WHEREAS, at dawn on October 25, 1983 the armed forces of the USA, in collaboration with units of the armed forces of six CARICOM countries, invaded Grenada;

AND WHEREAS the invading forces were resisted by the armed forces and people of Grenada and are still being so resisted;

AND WHEREAS this invasion constitutes a flagrant violation of the principles of non-intervention and noninterference in internal affairs, respect for the territorial integrity and sovereignty of states, in particular, and of the Charter of the United Nations and of international law in general:

AND WHEREAS the attack on Grenada can be a prelude to further military interventions in the Caribbean and Central

#### America in Nicaragua in particular;

AND WHEREAS it is the sovereign and inalienable right to each State freely to choose its own political, economic and social system and to develop its international relations without outside interference, subversion, coercion or intervention;

AND WHEREAS in accordance with Article 2(4) of the Charter of the United Nations, all States are enjoined to refrain in their international relations from the threat or use of force against the territorial integrity or political independence of any state, or in any other manner inconsistent with the Purposes of the United Nations:

AND WHEREAS the invasion has been widely condemned throughout the international community:

## BE IT RESOLVED:

That this National Assembly strongly condemns the armed intervention in Grenada by the United States of America, regrettably supported by some Caribbean countries, which has resulted in the death of and injury to many persons, including unarmed civilians from indiscriminate bombardment, shelling and other military activity by the aggressors;

AND BE IT FURTHER RESOLVED:

That this National Assembly calls for an immediate end to external intervention in Grenada, the prompt withdrawal of foreign troops from her territory, and full respect for her sovereignty, independence and territorial integrity.

The Minority Leader, and Cde. Collymore spoke to the motion.

At 16:02 hrs the sitting was suspended for refreshments.

# RESUMPTION OF SITTING

At 16:34 hrs the sitting was resumed.

The Vice-President and Attorney General, Cde. Janet Jagan and the Minister of Foreign Affairs spoke to the motion.

Before the motion was put the Assembly, on a suggestion by the Deputy Speaker, stood in silence in tribute to the death of the Grenadian Prime Minister, Cde. Maurice Bishop, and his colleagues.

Thereafter the motion was put and carried.

### ADJOURNMENT

At 18:00 hrs, on a motion by the Vice-President, Party and State Matters, the Assembly was adjourned to a date to be fixed.
