CONSTITUTIONAL APPOINTMENTS

Notice is hereby given that—

- (a) with effect from 18th September, 1989 Cde. Ranji Chandisingh, M.P., vice-President in the Office of the President and Deputy Prime Minister has resigned from his office;
- (b) with effect from 1st May, 1990 Cde. Dr. Noel Blackman, M.P., Minister in the Ministry of Health has resigned from his office and has ceased to be Minister,
- (c) in exercise of the powers conferred upon the President by article 103(2) of the Constitution, he has appointed Cde. Jean Persico, A.A., formerly Minister of State, as a Minister;
- (d) in exercise of the powers conferred upon the President by article 107 of the Constitution, he has with effect from 1st January, 1989, partially modified the assignments of responsibilities for the business of the Government to Cde. Hamilton Green, M.P., Prime Minister and cde. Jules Richard Kranenburg, M.P., Senior Minister;
- (e) consequent on the changes referred to above, the appointments and styles of Vice-Presidents and other Ministers and assignments of responsibilities among them on the date of this notice are as referred to in the Schedule; and
- (f) the President is always charged with responsibilities not assigned to any Minister which include, on the date of this notice, responsibility for the matters and groups of matters and the Ministries and Departments mentioned in the Table below:—
