THE COMMISSIONER OF REGISTRATION

OF PROCEDURE FOR SETTLING LIST OF ELECTORS

UNDER THE NATIONAL REGISTRATION ACT, CHAPTER 19:08

In accordance with section 15 of the National Registration Act, Chapter 19:08, notice is hereby given that —

- (1) Registrars and Deputy Registrars will be in their respective offices as specified in paragraph 9 hereof between the hours of 4.30 p.m. and 6.30 p.m., Monday to Saturday, and 10.00 a.m. to 12.00 noon on Sunday for the purpose of receiving claims and objections of persons who at 30th November, 1990, qualify to be registered as electors;
- (2) preliminary lists will be available for inspection at the offices of the Registrars and Deputy Registrars of each registration district in which such persons were registered;
- (3) any person who is qualified to be an elector and who is not registered, or whose name does not appear in the said preliminary list, or whose particulars are incorrectly stated therein may submit a claim on the prescribed form to the Registrar or Deputy Registrar;
- (4) any person who, since registration, has changed the location of residence or whose name has changed may make application of the prescribed form for the appropriate correction to be made;
- (5) any person whose name appears on the preliminary list may lodge an objection in writing to the inclusion in the said preliminary list of any person on the ground that, by reason of the facts stated in the objection, such person is not qualified to be registered;
- (6) every claim must be submitted with a deposit of two dollars (\$2.00) and every objection with a deposit of five dollars (\$5.00);
- (7) claims must be made not later than 15th October, and objections not later than 19th October, to the Registrar or Deputy Registrar of the district to which the list relates, provided that where the alteration is claimed in consequence of the person's change of residence from one district to another the claim must be made to the Registrar of the latter district
- (8) copies of the prescribed forms may be obtained free of cost at any office of a Registrar or Deputy Registrar;
- (9) the offices of the Registrars and Deputy Registrars of the districts to which the preliminary list relates are as follows:—
