

NOTICE**CONSTITUTIONAL APPOINTMENTS**

Notice is hereby given that —

(1) under the applicable provisions of articles 103, 107, 112 and 113 of the Constitution and all other powers enabling him in that behalf, the President —

- (i) on 1983—05—01 appointed Cde. Harold L. B. Singh, M. P. as Minister of State and Cde. Joseph B. Caldeira, M. P. as Parliamentary Secretary with effect from the date on which they took the oath of office;
- (ii) has partially modified the assignment of responsibilities for the business of the Government of Guyana among the Ministers and directed that with effect from 1983—05—01 the appointments and styles of Ministers and Parliamentary Secretaries and assignment of responsibilities among Ministers shall be as in the Schedule;
