AND WHEREAS it is provided by section 9 of the Representation of the People Act, Cap. 1:03, that the Elections Commission shall by notice published in the **Official Gazette** appoint a day, being a day not later than 32<sup>nd</sup> day before election day, on which lists of candidates may be submitted to the Chief Election Officer;

NOW, THEREFORE, TAKE NOTICE that the Elections Commission do hereby appoint 26<sup>th</sup> July, 2006 as the day on which lists of candidates may be submitted to the Chief Election Officer.

LISTS OF CANDIDATES shall be submitted between the hours of 2:00 p.m. and 6:00 p.m., in the afternoon of the 26<sup>th</sup> July, 2006 to the Chief Election Officer at the City Hall, Regent Street and the Avenue of the Republic, Georgetown, in the County of Demerara.
