With effect from the 25th March, 1991 the following shall be the rates of exchange for the purposes of the proviso to section 22 (1) (a) of the Customs Act, Cap. 82:01.

Where the price of the imported goods was or is to be paid for with foreign currency permitted to be bought or retained, for that purpose under the Exchange Control Act, Cap. 86:01, the rates of exchange to be used for determining the equivalent in Guyana dollars of any foreign currency for the purpose of the proviso to section 99 (1) (a) of the Customs Act, Cap. 82:01, shall be as specified in the Table below —

Where the price of the imported goods was or is to be paid for in any other manner than the manner specified in paragraph 2, the rate of excharge to be used for determining the equivalent in Guyana dollars of any foreign currency for the purposes of the proviso to section 22 (10) (a) of the Costoms Act, Chapter 82:01, shall be as specified in the Table below:—
