THE INTERPRETATION ORDINANCE (Chapter 5)

UNDER SECTION 39 OF THE INTERPRETATION ORDINANCE, IN AC-CORDANCE WITH ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA, AND BY VIRTUE AND IN EXERCISE OF ALL OTHER POWERS ENABLING HIM IN THAT BEHALF. HIS EXCEL-LENCY THE GOVERNOR ON THE 30TH DAY OF SEPTEMBER. 1964, DEPUTED THE MINISTER FOR THE TIME BEING CHARGED WITH RESPONSIBILITY FOR THE POSTAL SERVICES TO EXER-CISE ON HIS BEHALF THE POWERS SPECIFIED IN THE FIRST COLUMN OF THE SCHEDULE HEREUNDER CONFERRED ON THE GOVERNOR BY THE PROVISIONS OF THE POST AND TELEGRAPH ORDINANCE. CHAPTER 132. MENTIONED IN THE SECOND COLUMN OF THE SAID SCHEDULE. SUBJECT HOWEVER TO THE QUALIFICATION THAT THE DELEGATION OF POWERS MEN-TIONED HEREIN SHALL REMAIN IN FORCE UNTIL VARIED OR REVOKED BY THE GOVERNOR:-
